He advised at the present time DONALD WILKINSON is still the EC and that W. L. ROBERTSON is the secretary-treasurer. He stated that there are actually only about six active members. Those members being the two mentioned above, plus JEWEL LEE BURT, and JEWEL LEE BURT's son-in-law, AMOS EUGENE KINNEY. He stated that he has no information whatsoever indicating that CHARLES MOAK, MELVIN HARDY, CECIL BAILEY, H. E. VINES, BOBBY BOYD, JAMES LIPSCOMB, or GORDON HUGHES are paying their dues or even interested in further contact by UKA people in Adams County, Miss. He stated it has come to his attention that EUGENE L. THOMAS who resides near Stanton or Cannonsburg, Mississippi, is probably trying to obtain the EC's job and that he has no definite indication that this is going to occur. He further advised that a person who attended at one time several meetings and was taken into the UKA Unit #2 was CHARLES BRUCE MOAK but stated that since MOAK won a shotgun approximately one year ago he has not attended any meetings although upon occasion he did pay his dues.

He advised that JAMES JACKSON is not a member of UKA Unit #2 although he might possibly be a member of the Third Unit in Natchez, Mississippi. He stated, however, his contact with other klansmen indicate that UKA Unit #3 has now become defunct as well as UKA Unit #1 which is old Unit 800.

He indicated that he has no information whatsoever concerning the possible membership of CHARLES NATIONS in any klan unit. He stated that NATIONS resides on W. FIELDS' property on the Morgantown Road near Washington, Mississippi, and he believes him to be a roughneck in the oil fields. He stated, however, that he is not sure this is the right man.

He advised that it is his information that ERNEST HENRY AVANTS is allegedly separated from his wife, GLADYS.

He stated that she is running a small cafe located in the Natchez, Mississippi, area and that AVANTS himself is working somewhere off-shore with some oil company. He stated that he has no information indicating that AVANTS is a member of any klan unit at this time.

HUDSON advised that ERNEST AVANTS to his knowledge is presently working off-shore with some drilling operation off the coast of Louisiana. He stated AVANTS' wife, whose name he believes to be SARAH, is operating a cafe in the Trace Down Shopping Center in Natchez, Miss.

HUDSON advised he has recently obtained information that would indicate that RALEIGH JACKSON GLOVER is moving into the residence of DONALD WILKINSON [REDACTED]

[REDACTED] He stated he has no idea at the present time where WILKINSON can be located and stated it was only hearsay that GLOVER had moved into WILKINSON's house. Further, HUDSON advised that he had been talking to CHICKEN FOOT ROBINSON concerning WILKINSON [REDACTED]


HUDSON stated he had overheard recently from JAMES JACKSON that JEWEL LEE BURT and his son-in-law, AMOS EUGENE KINNEY have become rather disenchanted with the UKA Unit #2 after WILKINSON [REDACTED]

[REDACTED] He stated another person at the table at Bob's Eats located on Highway 61 North in Natchez, Miss., was later identified to him as EMMETT L. HARDY, said something to the effect the unit should be disbanded and forgotten about inasmuch as nobody seems to be interested. He stated it is his believe that BURT is residing with one of his daughters, whose husband was killed in some sort of industrial accident and that AMOS KINNEY, his son-in-law is also residing at the same location.

HUDSON advised the name CHARLES NATIONS seems vaguely familiar to him and this particular individual is a roughneck who works in the oil fields in and around Natchez, Miss. He stated he has never obtained any information indicating that NATIONS is a member of the Klan but stated he does believe he lives out towards TULLY SEALE's residence, near the end of Morgantown Road in Washington, Miss.

HUDSON advised the name EUGENE THOMAS is the name that was given to him as being a man who is allegedly pushing for the EC of Unit #2 of which DONALD WILKINSON has been suspended. He stated he obtained this information and that he does not know how accurate it might be.

On 8/1, 24 & 28/72, source advised he has not developed any information indicating the Newton County Klavern is planning any acts of violence or that its leadership is advocating violence.

PUBLIC RALLY, LAKE, MISS.
8/25/72

On 8/24/72, source advised the UKA, Inc., rally is still scheduled for the evening of August 25, 1972, in Newton County, Miss., about three miles north of Lake, Miss., on the Conehatta Road with featured speaker as ROBERT SHELTON.

On 8/28/72, source advised the UKA, Inc., public rally was held as scheduled the evening of 8/25/72 and it was officially opened about 8:00 p.m., and ended about 10:30 p.m., without incident.

Source advised the "SULLIVAN" family, a gospel singing group performed and prayer was led by "Preacher" LANGFORD from Scott County, Miss., who source described as being a self-proclaimed preacher who used to be on the radio broadcasting from the Forest, Miss., area.

Source advised that an individual named "JACKSON" from Natchez, Miss., told about the FBI following him all the time and commented that whites should boycott stores hiring blacks.

Source said that ROBERT SHELTON was the featured speaker and talked about the Government giving \$35 to black women to have children and he urged whites to send their children to private schools. Source remarked that SHELTON was "down" on Senator MC GOVERN and made some remarks about President NIXON not trying hard enough with regard to stopping bussing. Source stated SHELTON generally berated the Government with regard to handouts and other Federal spending that SHELTON felt was wasteful.

Source advised he observed approximately fifteen robed Klansmen, including some from Louisiana and Alabama. He said that NOVA GATEWOOD, ALBERT STAMPER, L. M. GATEWOOD and RALPH VAUGHN from Newton County were robed and he observed ED WARE, OLLIE LEACH, and Q. GREER in attendance at the rally but they were not robed.

Source estimated 300 to 400 persons were in attendance and he noticed license plates from Alabama, Louisiana, Natchez, Miss., and the Gulf Coast area as well as surrounding counties. Source stated that one man was armed with a shotgun at the parking area entrance and he noted that donations were collected; however, membership applications were not handed to his knowledge and there was no over effort to solicit membership.

Source advised that he was not aware of any incidents occurring at the rally and the program was closed with the burning of a cross.


On 8/21/72, J. T. ROBINSON advised that the names of ROLLIE JACKSON GLOVER, JEWEL LEE BURT, WILLIAM LIONUS ROBERTSON, aka Chicken Foot, and JAMES JACKSON are all well-known to him as being former members and possibly even present members of the Klan in Adams County, Mississippi. He stated that he recalls specifically that GLOVER, ROBERTSON and BURT all are employed at Armstrong Tire and Rubber Company and reportedly have been involved in Klan activities at Armstrong Tire and Rubber for quite some time. He stated that it is his recollection that BURT recently had an accident involving a hand injury and that he was partially incapacitated for some time. ROBINSON indicated that he has no information indicating that any of the aforementioned subjects are involved in any agitation or Klan activities at the present time, but stated that it would not surprise him too much if any of them were. He stated that JAMES JACKSON, better known as "Lying" JACKSON, has called the police department several times because of alleged harassment by Negroes inasmuch as he, JACKSON, lives near the River Oak section, a Negro housing community.

WILLIAM T. FERRELL, Sheriff, Adams County, Natchez, Mississippi, advised on 8/21/72, that his office has information indicating that BILLY RAY HINSON, who is a member of the National Guard or the Army Reserve and is employed at Woolco Department Store in Natchez, may possibly be either involved with a UKA Unit or be the EC of that particular unit. Another individual involved along with HINSON is EDDIE ARNOLD. FERRELL advised that recently one of his deputy sheriffs, R. E. STUTZMAN, had questioned ARNOLD about another unrelated incident and at that time ARNOLD indicated to him, STUTZMAN, that he was a member of UKA Unit #2 in Natchez, Mississippi. He stated that ARNOLD to the best of his knowledge is presently residing and working offshore somewhere in Louisiana. FERRELL further advised that MELVIN LAVERN HARDY has been arrested by his department on several occasions for fighting and



It is reported that RED GLOVER has not been in contact with any of the UKA members in and around the Natchez area. It is believed, however, that he recently made a trip to Crystal Springs, Miss., with CHICKENFOOT ROBERTSON and EUGENE THOMAS, allegedly looking for someone. It is not known at this time the identity of the person or persons for whom he may have been looking.

It is reported also among the klan members in Natchez that CHICKENFOOT ROBERTSON is angry with the EC, DONALD WILKINSON, because WILKINSON would not loan him his carbine. Privately, however, WILKINSON is telling individuals that the reason that ROBERTSON is upset with him is because he will not allow ROBERTSON to take care of the finances of the UKA unit #2.

It is believed that ROBERTSON, after obtaining the Kleagle job for Province III, UKA Unit #2, has recommended EUGENE THOMAS to be used by the EC to send to take care of anything that needs to be done and to go with the EC to the Province meetings.

It is reported that the EC of Unit #2 is upset with ROBERTSON and THOMAS because they were suppose to have gone along with GORDON HUGHES to the state meeting but did not attend.

On 7/8/72, DONALD WILKINSON was overheard asking RED GLOVER concerning whether or not he had any information about the recent theft of explosive items in the Natchez area. GLOVER allegedly told WILKINSON that he did not have any information on it and did not believe it was done by any member of the klan.

At that time, GLOVER was also overheard to say that he was headed to Crystal Springs to look up his old girl friend.

On 7/8/72, DONALD WILKINSON, CHICKENFOOT ROBERTSON of UKA unit #2, and JAMES JACKSON of UKA unit #3 from Natchez, were seen to attend the Province III meeting at Brookhaven. At the particular meeting, it was noted that there was no roll call of the units although it was noticed that two Natchez units, Wesson, Miss., McComb, Brookhaven units were present. It was further noted that only approximately 15 individuals attended, among which were the Grand Titan of the province. During the course of the meeting, many of the individuals wanted to know the details about the Grand Titan being involved with a female other than his wife. It was reported that a man named HODGES or HUGHES, a man named PETE, and one other man from the McComb unit which has split up are trying to form another unit because of the information that they have concerning FLEMING running around with this woman.

During the course of the argument, the EC of the Wesson, Miss., unit stood up and said he did not think it was right to accuse these three men of trying to split up the McComb unit when they were not there to defend themselves. It is privately believed by many of the people attending the meeting that the man named EARLS from the Wesson unit wants the Grand Titan's job and wants FLEMING out.

Also discussed at this time was the fact that during April, 1972, the McComb unit was not able to put a UKA member in the march which was held at the McComb Centennial. FLEMING told the group that he was not there during the incident because he was at the courthouse trying to get an injunction letting the UKA march, but the members of the group did not accept his explanation.

It was further discussed during the meeting about a man named WILLIAMS who is apparently a close friend of FLEMING and who was handing out Nazi literature at the previous state meeting. Many of the members were upset about this Nazi literature. However, DURELL FONDREN indicated to the group that he had read it and that he would check with ROBERT SHELTON to determine if they could use this literature because it "had a lot of good things to say".

At the end of the meeting, FONDREN indicated that he was going to get a man by the name of J. C. BROWN to speak to the next meeting if this was okay with the membership which was subsequently okayed by all persons involved.

The following letters are being circulated among the UKA units in the Natchez area:

June 13, 1972

Esteemed Klansmen:

I made a mistake on the date of our next state meeting. The correct date is June 24th. This is our regular fourth Saturday night meeting.

To all units that have the George Wallace petitions, please bring them with you to the next state meeting, along with the money you have collected.

We now have duly appointed Kleagles working in various parts of the state setting up new units. Before one can become a Kleagle he must be recommended, by his unit and approved by the state office. Each Kleagle will receive \$4.00 out of each Klectoken he collects. This is to help defray his expenses.

In view of what happened to Governor Wallace, the Liberals and Communist in our Government are going to try to get a Gun control bill passed. It is time for us to let our Senators and Congressmen know that we will not accept this. You can do a lot of good by talking this up to your friends and nabors. We must not set back and allow our arms to be taken-

The Constitution of the United States reads as follows-
Article-II- "A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed."

Websters Dictionary, defines Militia, as Citizens enrolled and trained, but not called to active service unless an emergency arises; Citizen Soldiery.

We must keep our guard up and be ready for what ever may happen. We must be organized and ready at all times. We can do this and still keep our activities within the law.

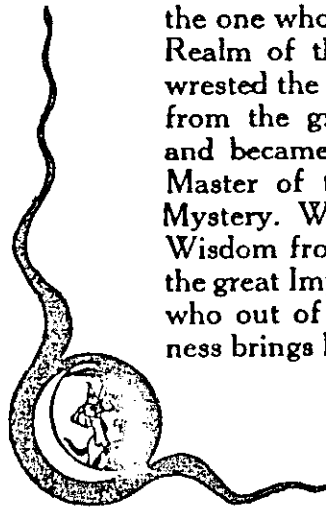
The Practice of Klanishness

Imperial Instructions

Being Official Instructions in K-uno in the border Realm of Karacter from the one who traversed the Realm of the Unknown, wrested the solemn Secret from the grasp of Night and became the Imperial Master of the great lost Mystery. Words of timely Wisdom from the soul of the great Imperial Wizard, who out of Mystic Darkness brings Light.



To Each and Every Citizen of the Invisible Empire, Knights of the Ku Klux Klan, My Cordial Imperial Greetings: To You I Speak, Oh, Noble Klansman!

The One great underlying principle of "our" noble Order, one which demands "constant" practice, is---**KLANISH FIDELITY**---constancy in the performance of Klanish Practices.

To be "kianish" (Note: We spell it with a K instead of a C) toward your fellow klansmen in ALL things honorable implies that this principle must be applied and exemplified in the four-fold realm of man's mundane life---Physical, Social, Moral and Vocational. This is the four-fold application of this, "our" sacred and self-preserving principle and it is therefore a **FUNDAMENTAL** element in the progress and stability of our great institution as well as in the betterment of our individual lives.

Our klanishness is defined as follows: "A number of real men, each of whom is the embodiment of true American manhood, of kindred purpose, actuated by unselfish motives, dedicated to a manly mission and pledged to a noble ideal, and who are voluntarily and strongly bound together by an unyielding tie, wholly determined to so live and act as to safeguard and enhance each other's interest and welfare in all the several relationships of life and being."

(1). **PHYSICAL KLANISHNESS**: Has to do with the application of this great principle in the realm of one's physical being. Having due regard for the health and bodily wellbeing of a klansman and protecting same in every way possible; if health be impaired to seek its restoration. It enforces self-control when one is aroused to anger and the bodily wellbeing of a klansman is threatened or likely to be abused; true to this principle no klansman will strike, stab, lacerate or in any other manner inflict bodily pain or commit an injury to the physical being of another klansman, unless in case of self-defense, and to do so would be a crime against the Invisible Empire.

(2). **SOCIAL KLANISHNESS**: This implies that all klansmen are on a common social plane and are therefore without individual social distinction between each other. The set rules of social valuation operative in the society of the alien world at large are ignored by klansmen in their regard for each other. We form our estimate of each other not by the texture of the garment worn nor by the position held in the social, educational, political, financial or ecclesiastical spheres of the world's society, but we look well into the inner qualities of the heart, the mind and the soul; on these we base our estimate and the eye of scrutiny beholds him bathed in the penetrating light of the fiery Cross and he stands before us our equal in that he possesses a klansman's heart and a klansman's soul, and of him we shall not be ashamed before men but will gladly acknowledge his fellowship before the world, for we know who he is-- a **MAN** who values **HONOR** more than life.

The practice of social klanishness enforces an affectionate and manly regard for the personal and professional reputation and good name of a klansman and that of a klansman's family and will not permit such to be slanderously assailed without resentment. How sacred a thing is

a man's or a woman's good name! And thrice so is that of a klansman and his loved ones!

This principle enforces an appreciative valuation of each other, prompting sincere, courteous conduct and free social intercourse among klansmen. When you meet a klansman be glad to greet him and act the part, for he, like yourself, is no common man.

(3). **MORAL KLANISHNESS**: This has to do with the attainment and the preservation of decency; by it we assist each other to conform our lives to the standard given in the Scriptural Charter of the Klan--the 12th chapter of Romans, especially the 1st and 2nd verses, and thus we make secure, by the practice of klanishness, our highest and best interest not only in this life but in the great life to come. No klansman will permit himself to be the means of, or the instrument in, the moral degeneration of another klansman; or in the wrecking of the soul of his fellow in the world to come. No klansman will throw aside his qualities of a gentleman and give himself over to debauchery. We seek to know our own and each other's moral weakness and constantly endeavor to strengthen these to the end that in the practice of klanishness we develop and maintain that quality of character that will stand the ultimate test of God's just and unerring judgement. This practice enforces Temperance (in thought, in word and in indulgences) and all of its allied virtues, and thereby aims at the ideal of decency and cleanliness in life and character. To pollute the morals of a klansman is to commit a grave offense against our Order.

(4). **VOCATIONAL KLANISHNESS**: This calls for the constant and earnest exercise of this great principle in the realm of one's business life or professional. Trading, dealing with and patronizing klansmen in preference to others. Employing klansmen in preference to others whenever possible. Boosting each other's business interest or professional ability; honorably doing any and all things that will assist a klansman to earn an honest dollar, thereby adding to his material wellbeing; lightening the burden of life for him and constantly succoring him with new strength and refreshing encouragement. Make it a special point in life to know the nature of a klansman's business or profession and then hold him and his interest well in mind and never let an opportunity pass to turn trade or patronage to him and thus you will help him to succeed and be happy and thereby you will add to the force of joy towards dissipating the sorrow, grouch and gloom of this life and making the world brighter and better by your having lived in it.

For an example: If you should come across a person interested in the purchase or sale of real estate, scan your list of known klansmen and if there be one who is in that line of business (though you may not be so intimately acquainted with him) urge this person to see your particular real estate man. It is presumed there is a profit to be made in the transaction if consummated, then do your part in endeavoring to turn the profit to a klansman. You must not tell this person why you insist on him seeing this particular real estate man, other than he is worthy and deals honorably. He is a klansman and you can safely recommend him. Apply this method in regard to klansmen who are doctors, lawyers, dentists, merchants, barbers, opticians, caprenters, insurance men, taxi cab owners, automobile dealers and ANY and ALL other vocations of men. Again, a clerk, for instance, or other employee of a shop, to hold

his position must make good, his advancement hinges on his ability to produce business; therefore deal with those firms or persons who employ klansmen in their business and have your dealings with your fellow klansmen in person therein employed that he, or they, might get credit for the business done. If possible, let the employer know that you deal with his firm on account of this particular man being employed by him.

The exemplification of this great principle enforces honesty in all transactions. Deal fairly and justly with klansmen at any and all times and in all things. To cheat wrong or deceive a klansman, in plighted word or in trade or business transactions, would be a bad breach of klanishness for which you would suffer. If you borrow from a klansman be not slow to repay; remember it is an obligation of honor. Do not allow yourself to impose on a klansman's generosity. A klansman has implicit confidence and imposes a sacred trust in you, therefore do nothing that would impair that confidence or betray that trust. Be a big man, a fair man, an honest man in all your dealings with all men and most especially with klansmen. Remember this sublime duty was voluntarily assumed by you and to this great work you have been solemnly dedicated and your life has been sacredly consecrated; see to it that you prove not yourself one who will flinch at DUTY or show himself a cowardly weakling or a treacherous scallawag.

Think seriously and soberly along this line of the application of this great principle and the greatness of it in its ultimate range will overwhelm you, and you will readily see what you have lost in the past by the common method of fraternal practice you have followed. Oh, how miserably meaningless is the so-called fraternity of the multitude of so-called fraternal Orders! How disgusting to a soul unselfish and sincere!

The practice of klanishness is FUNDAMENTAL with us, it is our mark of distinction as an institution and as individual members thereof; therefore, to be true you MUST train yourself accordingly. In this you will doubtless often be required to make some sacrifice of time or of conveniences and possibly some impulse of personal friendship or of old acquaintanceship, but to attain the lofty ideal to which we aspire it must be done. How easy it is with one so determined to form the holy habit of the practice of klanishness, and how good one feels when he has done it! What delectable experiences come to him in the consciousness of having maintained his honor in the bitter battle of life against Self and selfish inclinations and having this day contributed something, though ever so small, toward blessing some one's life by making that some one more successful and happy and also to be able to repose in the sweet consciousness of having done something more toward shaping your own life to conform to a laudable and lofty ideal.

By this practice you lift yourself above the noxious atmosphere of selfish, sordid gain and place yourself on the lofty heights where the genial breezes of reciprocal fraternal fellowship forever wafts their inestimable blessings and the sun of Divine approbation is always bright. Get out of the boggy swamps, my fellow klansmen, and get you to the mountain top where you can catch the vision of the larger life that will impart to your soul super-human strength enabling you to enter the stressful struggle of the alien world, with which you are surrounded, and

come out conqueror from every contest. Devotion to our standard MUST be made worth while; worth while to others by YOU and worth while to YOU by others.

Our Order is one with a great specific purpose, therefore, a klansman is a man with a definite purpose in life, not a mere piece of animal drift-wood, and he is unyielding in his devotion to that purpose and the bed-rock principle of that purpose if the practice of klanishness. You have invested of your time and money to become one of us and one with us, now be sensible enough to make good that investment; for it holds treasures for you. In other words, you have bought the field, now sow the seed and properly cultivate it and a pleasing harvest is yours; otherwise brambles, and weeds and pernicious plants will infest it and thrive and you shall have miserably wasted your investment, you shall have failed to preserve your honor in the faithful practice of a self-protective principle. Put forth your hands and sow the goodly seed of klanish fidelity and you shall reap abundantly; withhold your hand and you shall perish. "Bear ye one another's burdens and so fulfill the law of Christ."

Again the four-fold application of this great principle is as follows:

(1) PATRIOTIC KLANISHNESS: An unswerving allegiance to the principles of a pure Americanism as represented by the flag of our great nation, namely: Liberty, Justice and Truth. Real, true Americanism unadulterated, a dogged devotedness to our country, its government, its ideals and its institutions. To keep our government forever free from the alien touch of foreign alliances and influences, that Liberty's effulgent torch be not dimmed. By your vote as a citizen select only men of pure patriotic impulses to serve in positions of public trust. Vote not politics, but patriotism. Exercise your rights and prerogatives as a civil citizen for the best interest of your state and community and for the general public weal; the making of just and equitable laws and the righteous enforcement of same; bitterly oppose tyranny in any and every form and degree, and displace the corrupt politicians with dependable patriotic statesmen. "He who saves his country saves all things and all things saved bless him; but he who lets his country die lets all things die and all things dying curse him."

(2). DOMESTIC KLANISHNESS: Standing by and protecting the sanctity of the home, and its manifold interests, of a klansman, his family and its every interest and well-being, and faithfully warn him of any approaching danger thereto.

(3). RACIAL KLANISHNESS: Being in all things true and loyal to the caucasian race, its traditions and civilization pure by preserving it from the contaminating intermixture of alien races and their influences, maintain WHITE SUPREMACY first, last and all the time. Faithfully protect our politics and society from the haughty ambitions and arrogant aggressiveness of colored races who seek to mix their breed with the blood of our government and civilization. Racial integrity—abstaining from and preventing casual physical contact with or by colored races; thereby, keeping secure from pollution from inferior blood the precious blood of the caucasian race. Recognize the distinction between the races of mankind as they have been decreed by nature, and preserve unto death the peculiar distinctiveness of the white race from the foul touch of a

lower stock. Keep caucasian blood, society, politics and civilization PURE!

(4). IMPERIAL KLANISHNESS: This is the principle applied toward our great fraternity. It means a constant, unflinching loyalty to the Institution; to harmonize your soul with its sacred purposes and principles, put yourself in accord with its mission and ideals. Guard WELL its EVERY interest; make good your allegiance to it by practicing its precepts, exemplifying its principles, meeting promptly without reserve your EVERY obligation to it (both personal and financial), faithfully obeying its constitution and constitutional authority, enforcing its laws and conforming willingly to its requirements, regulations and usages.

Give due respect at all times, and maintain a klanish regard for the person and authority of its chief officer—the Imperial Wizard, and thereby facilitate his efforts in perfecting the work he has to do for the glory of the Invisible Empire in its development and government. He is laboring constantly and unselfishly for YOU, YOUR country and YOUR race. Your respect for him, his official decrees, edicts, mandates, rulings and instructions means much for you in approximating the common ideal of klansmen. He in his official capacity represents the entire Order, every phase and feature of the whole Institution centers in him. Be therefore constructive and not destructive of obstructive in your criticisms. If you have honest criticisms to make take them to the proper officer to hear, discuss and consider them—the Exalted Cyclops of a klan, the Grand Dragon of your Realm, or the Imperial Wizard of the Order.

Do not in ANY MANNER WRONG our Institution by slandering it (though ever so mildly) or by discussing its seeming imperfections or the mistakes of its officers at any time or place where any person of the alien world may chance to hear; a conspicuous characteristic of a klansman handed down by our fathers is, A klansman keeps the inner affairs of the klan strictly to himself and thereby maintains its peculiar prestige as a potent factor. Always speak of the klan and its work enthusiastically or not at all, oftentimes silence begets respect; never discuss the klan or its affairs freely with anyone except a klansman. Do not familiarize our fraternity to anyone of the alien world. Under no circumstances suffer any cisms, factions or ill feelings to spring up in your klan and never any remarks or conversations that favor sedition. Remember IN UNISON we labor wherever we may roam.

The Institution believes in YOU and has reposed a very sacred trust in YOU; be true to the trust committed to your keeping and thereby give to it that sincere, unselfish devotedness as typified by the Fiery Cross; the light of that cross reveals YOUR DUTY, then perform that duty as a klansman and not as one of the common herd of mankind. Be YOU the incarnation of the principle of constant loyalty to the Order, and thus with real men like you a great institution can and will be established in the land, that will be peerless in the perfection of its powers to preserve and perpetuate that which we all hold as sacred to our race, our country, each other and to the world, and will endure through the ages to bless mankind. Be prudent in your conduct and conversations that nothing might be said or done by you at any time or place that will engender prejudice against our Order. Allow no alien to enter the klavern in quest of citizenship in the Invisible Empire unless you are confident that he is worthy of the honor we confer, the

sacred trust we impose and will appreciate our peculiar fellowship, and if a scallawag should develop in your midst eject him speedily from the portal of the Invisible Empire without fear or favor. Maintain forever the social cast and dignity of YOUR Institution, for its foundation is laid in character and it is built up with MANHOOD.

Remember always that YOU as a klansman represent more than you do in any other fraternal relationship, for you are a living commemoration and the perpetuation of the most dauntless organization known to the world and of men who were the greatest heroes of all history. Let the spirit of that immortal institution and of those great men possess YOU and let not its exalted ideals be one whit lowered by any indifference or careless conduct on YOUR part. Our Order is most worthy of you and you honor yourself by your devotion to it; therefore, live up to the peerless dignity of the peculiar relationship you sustain as a klansman, for this is your opportunity to achieve something worth while in rightly and gratefully commemorating the heroic achievements of the past, for the betterment of the present, and in begetting imperishable honor for yourself and your progeny in the future.

KLANISHNESS with us is the concentrated extract of "fraternity" intensified and applied in every conceivable way. In the application of the meaning of the word as used by us it is more specific, more potent and goes more into minute detail by taking cognizance of the small things ordinarily overlooked by the word—fraternity. It considers no act small and insignificant that contributes directly or indirectly to a fellow's welfare or happiness. While it has due respect for the acts of large favors and conspicuous benefits, it especially gives attention to the countless small acts of beneficial practices and kind words opportune in every moment of time which go to make up this great life that we live together; indeed, it is fidelity in these small things which makes life pleasant after all. It is the constant application that counts—CONSTANTLY klanish towards klansmen in ALL things honorable.

OUR KLANISHNESS prompts us to STUDY the interest of a klansman and never lose an opportunity to enhance same; to SEEK the opportunity and NOT sit down in fraternal lethargy and wait until it runs against us; and to seek not with a base, selfish motive as with an inner thought that you might possibly reap a gain by so doing, but in the true spirit of the great motto: Not For Self But For Others; for selfishness is the arch-canker that corrupts the hearts and the minds and prostitutes the motives of men, and is the conquering curse of creation. YOU are dedicated to the sublime mission of conquering it, you must make the fight within YOUR OWN breast. Be its master there and you can conquer it anywhere.

THE PARAMOUNT distinction of a klansman, that which marks him as being different from other men is—HE is KLANISH towards his fellow klansmen. Klansmen, that is YOUR mark of distinction as you move among the great countless multitude of men and by it you will tower above men of alien creed as Saul of Gibbeah among the men of Israel. That is the mark of YOUR high calling—YOUR thrice honorable election, and may that mark be seen, known and devoutly respected by all men, that they may take knowledge of you that you are a citizen of the Invisible Empire. To this exalted honor our great institution has elected you and it seeks to elevate you to the higher life

Esteemed Klansmen;

We have had a full month of rallies, and it has been indeed a pleasure to have had the opportunity to speak and gather with Klansmen and friends in the locations of Morgan City, Ala. The foregoing are just the minimum requirements for the important post of Grand Officer. These men must be leaders of the highest order if we are to continue to progress as we have in the past.


CROSSBURNING

The Grand Officers by unanimous vote approved the following resolution Saturday, June 24th:

It shall hereafter be against the policy of the UKA within the Realm of Louisiana to light a cross at any place or at any time except upon private property with the signed permission of the property owner in question. No Officer of the UKA shall be empowered to authorize a cross lighting under any other circumstances than those above.

Any member who violates this regulation and is identified in any way as a member of this order shall be dismissed from the UKA by the Grand Dragon. Furthermore, any member who shall light, or cause a cross to be lighted upon private property without the permission of the property owner in questions permission, that member shall be immediately banished forever from the UKA.

They've been telling us for years that niggers are "equal." What a bunch of crap! An administration that believes that is really out of it. As long as they stick together and we don't, we're screwed. But when we learn to stick together, there's nothing we can't accomplish. Let's start learning!

The only way we'll ever have control of our schools again is to ORGANIZE-- and then throw the Black scum out into the streets.

Further, it is reported that the EC or some high ranking member of the McComb, Miss., Unit was attempting to have the Titan of Province #3

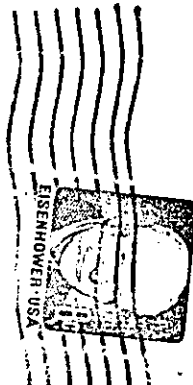

It is reported that KENNETH ROBERTSON, W. L. ROBERTSON, and others went to see DURELL FONDREN, the Grand Dragon of the UKA in Mississippi. They allegedly are unhappy with the way the units are being run, and further, he was allegedly told he'd better do better or something would be done about replacing him.

It is reported that a Judge BRADY from around McComb, Miss., has agreed to take the Grand Dragon's job when he retires from public life, which will be in approximately one year.

A Province #3 meeting was held at Brookhaven, Miss., on 5/13/72 and the following license plates were observed to be present:

57-176--on a Volkswagen;

3-2445--and 1C-4074--1971 Dodge.

UKA Unit #1, Adams County, Miss., was represented by O. K. GERMANY and R. L. MYRICK.

UKA Unit #2 was represented by DONALD HOUSTON WILKINSON and TOMMY LOVE.

UKA Unit #3, Adams County, was represented by JAMES JACKSON and an unknown white male driving a 1971 Dodge with Adams County plates 1C-4074.

It is noted that there was no roll call at the meeting, but FLEMING, the Grand Titan, indicated that the McComb and Columbia, Miss., units were not represented.

During the course of the meeting it was discussed that a charter bus going to Washington, D. C., for a

Patriotism Day Parade, sponsored by Reverend CARL MC INTYRE, needs \$160 more and eighteen more people to go. Further, FLEMING mentioned a LEWIS DISALAULIO from New Orleans, Louisiana, who is "a fiery gentleman" and wanted this individual to speak at either Brookhaven, Mississippi, at a klan meeting or hire a park to have people hear him because he was a very good speaker. It was reported that this DISALAULIO is not a klansman.

Further, during the course of the conversations, it was noted that a man named CHRISTMAS from an Original Knights of the Ku Klux Klan of Louisiana unit has brought all of his members, allegedly 200, into the UKA of Louisiana, among these being a MURRAY MARTIN from Winnsboro, Louisiana. This group has joined the group headed by a Mr. KIDD from somewhere in Louisiana.

It is believed that W. L. ROBERTSON is to be the new klead of Unit #2 in Adams County, Mississippi.

JEWEL LEE BURT and TOMMY LOVE are allegedly going to attend the state meeting on 5/20/72. It is reported, however, that the same day, on 5/20/72, there is a meeting to be held at Amite, Louisiana, sponsored by the UKA in Louisiana. The Province #3, UKA of Mississippi, is supporting this meeting and it is believed that the Grand Titan told the members of Province #3 to go there instead of going to the state meeting.

The Citizens Council meeting held on 5/15/72 at Thomas Jefferson School was largely ineffectual, having only seven people in attendance. There was actually no meeting held, the chief topic of discussion being the shooting of GEORGE WALLACE.

It is believed that JACK HUBER wanted more people to attend and has set the new meeting date for the third week in June, exact date unknown at this time.

JERRY FRANK CASE is not known to be a member of the UKA in Adams County, Mississippi, and CHARLES O. WHITE is believed to be out of the Natchez, Mississippi, area

at this time. It is reported that JOHN WILLIAM BARBER, formerly of Adams County, Miss., is working and residing in the Jackson, Mississippi, area for Presto Aluminum Cookware Company, either selling and/or driving a delivery truck, and is allegedly living in Jackson.

Any Klansman that does not own a robe should order one. If you need order blanks, you can pick them up at the state meeting. A check or money order must be sent in with your order. Order robes direct from the National office. Any thing other than robes should be ordered from your state office.

Kleagles

So far we have three Kleagles (Organizers), one from Mize, Liberty and McComb. If there is a member in your unit that will accept this position and knows the constitution of this order, please forward his name to the state office. As soon as we get these names these men will be called to a special meeting for instructions.

Book

The book that was given to me to deliver to the Governor has been delivered. I think we will get some action on this very soon. Bill Walker and his aides were very upset, after reading a few pages.

I gave you a report on his attendance record at a state meeting recently. The record shows that he was absent forty per cent of the roll calls last year, which in my opinion is very poor. Yet I have checked his voting record and he has voted against every Civil Rights bill that has been brought up. He has voted against all the major issues, that you and I are against.

There is supposed to be a meeting set up between Jim Eastland and myself in a few days. Maybe I will be able to get some answers from him, pertaining to the issues that we are most interested in.

It is reported that a Citizens Council representative by the name of BRADSHAW, who allegedly is a white male, approximately 57 years of age with graying hair and is an ex-schoolteacher from Rankin County, is attempting to reorganize the Citizens Council in Natchez, Mississippi. A tentative meeting date of April 25, 1972, has been set for this organizational meeting.

It is reported that W. L. ROBERTSON has made statements to the effect that an EC by the name of EARL is definitely after the Grand Titan's position in the Province of Mississippi. It is unknown at this time exactly why EARL wants the job or what he has against FLEMING, but it has definitely been established that ROBERTSON does believe that EARL does want this position.

It is reported that "CHICKENFOOT" ROBERTSON had been overheard discussing the fact that two Federal agents were out to see him, but he was not home. He is also reportedly to have said that he heard that two of them had gone out to see EDDIE ARNOLD and also other Klansmen. It is not known exactly what these persons wanted, but it is reported that ARNOLD has told "CHICKENFOOT" ROBERTSON that he did not talk to the Agents but "ran them off."

It is believed, according to information overheard from BILLY RAY HENSON, that a young man by the name of [REDACTED] and EDDIE ARNOLD were involved with "CHICKENFOOT" ROBERTSON in some activity in the Vidalia area prior to [REDACTED] being arrested for a narcotics violation in Concordia Parish. It is not known at this time exactly what this incident may have been.

It is noted that the United Klans of America, Incorporated, has been selling tickets for a Colt .38 Super Automatic plus 200 rounds of ammunition. This is to be given away at Lake, Mississippi, on May 27, 1972. It is reported that at the last state meeting on April 22, 1972, Number One and Number Three Units of the UKA of Adams County, Mississippi, were not represented. "CHICKENFOOT" ROBERTSON and JULE LEE BURT attended from Adams County, Mississippi. During the course of the meeting, it is believed that JULE LEE BURT mentioned something about the lie

detector test and suggested that all the EC's of the UKA in Mississippi be given this test. It is believed that at the present time this lie detector test is being given to new Klansmen only, but they are meeting some reluctance on the part of several Klansmen to take this examination because they do not trust the people that are giving the exam.

JAMES JACKSON was overheard talking to several individuals at the barbeque pit and at that time indicated that he wanted to know something about the meeting and what had happened at the state meeting. JACKSON has indicated that he has taken over the Number Three Unit and is helping the EC BILLY RAY HENSON get the thing off the ground. He has jumped from Unit Number One, which is the old Unit 800, to the Number Three Unit, but stated that he has not been too successful in getting people to join the unit as yet.

DONALD WILKINSON was overheard saying that he had attended a Citizens Council meeting at JACK HUBER's house, 301 Park Place in Natchez, Mississippi, and among the people attending were individuals by the names of JACK MOORE, JACK HUBER, (First Name Unknown) HEDGELAND, CECIL M. PEOPLES, (First Name Unknown) BRADSHAW, (First Name Unknown) DUNIGAN, a man by the last name of MC MANUS who is believed to be a member of the old Slygo Unit of the White Knights. The next meeting has been scheduled for May 15, 1972, but no further plans or activities have been made at this time.

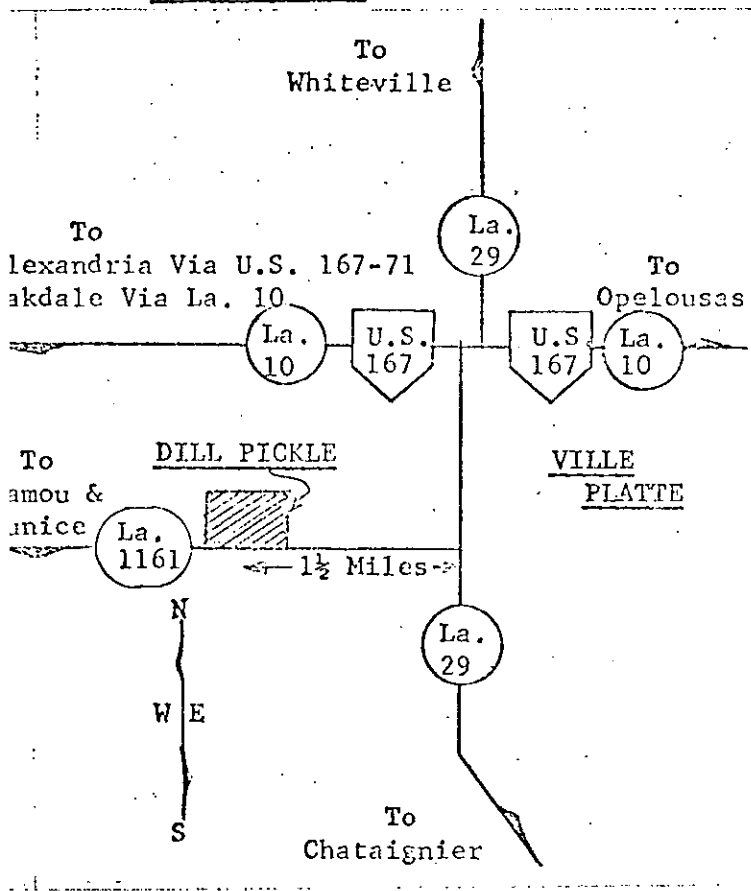
SOUTHWESTERN PROVINCE MEETING

PUBLIC RELATIONS

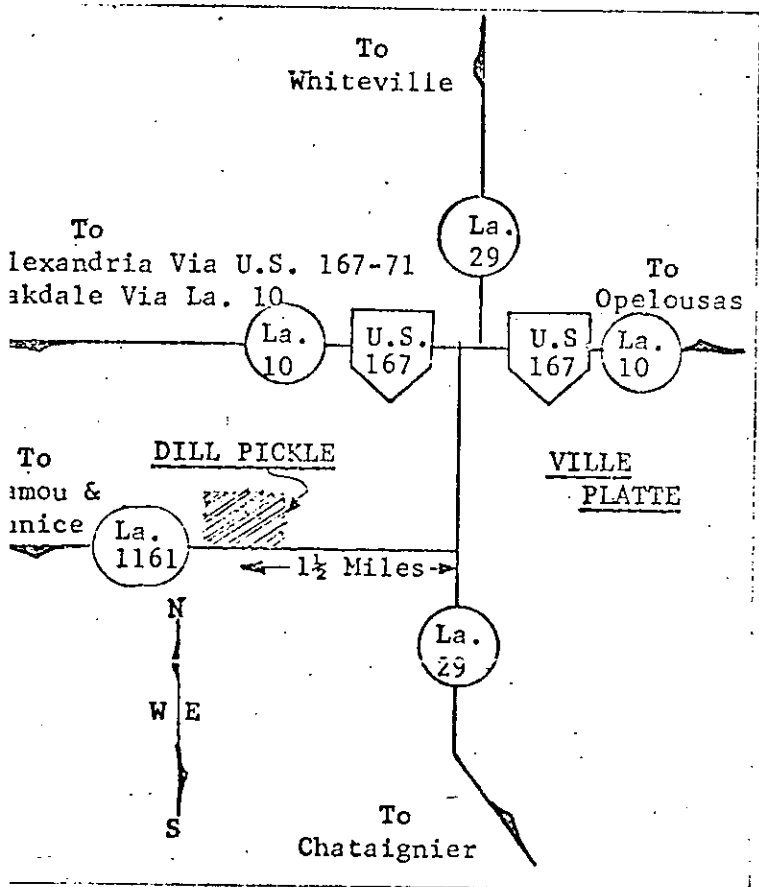

According to a letter dated March 25, 1972, from HARVEY FLEMING, Grand Titan of the Province, the Mayor of McComb, Mississippi, has assigned the United Klans of America (UKA) a position in the Centennial Parade for McComb, Mississippi, set for April 3, 1972. FLEMING has recommended that every Klansman who cares to can attend and should be robed out. It is noted, however, that many Klansmen in the Natchez, Mississippi, area are reluctant to do this because of the potential for identification by the FBI and also because of possible violence with the Negro people who will be watching in the parade. It is further noted that HARVEY FLEMING has an address of Post Office Box 711, McComb, Mississippi, telephone number 684-1289.

On or about March 24, 1972, it is reported that BILLY RAY HINSON was seen talking to STEPHEN JOSEPH AUCOIN. AUCOIN allegedly told HINSON that he was not going to say anything to anyone concerning the activities of the Klan in the Natchez-Vidalia area. AUCOIN allegedly told HINSON that he was moving to Morgan City, Louisiana, because his home and car had been locked up and he had no way of getting around. It is also reported that during the course of the conversation, AUCOIN mentioned that [redacted] [redacted] also of Morgan City, Louisiana, was involved in smoking marijuana also.

On or about March 21, 1972, RED GLOVER told several Klansmen in the Natchez, Mississippi, area that he had received a sentence of one year's probation for his part in the burglary in Wilkinson County, Mississippi. He allegedly was also inquiring as to whether or not "CHICKENFOOT" ROBERTSON had taken care of several items that he, ROBERTSON, had gone to McComb, Mississippi, to pick up. It is noted that later GLOVER was overheard saying that he had contacted ROBERTSON and ROBERTSON had gone to McComb and taken care of the recovery of some specific items.

It is believed that the UKA of the Realm of Mississippi has an unscheduled meeting on or about March 25, 1972, at which time new state officers were elected. It is noted, however, that

the old officers were actually reelected and it is believed that this was due to the fact that the E. C. of the Wesson, Mississippi, Unit wants the job of Grand Titan of the Province. It is noted, however, that it is believed among Klan units in the Natchez area that the E. C. of the western unit controls only his unit and is not backed by any other units in the province.

The following letter, postmarked March 20, 1972, at Columbus, Mississippi, is being distributed among Klansmen in the Natchez, Mississippi, area:

Esteemed Klansmen:

Just a line to remind you of our State meeting next Saturday at 7:30 P.M. This meeting will be held at the same place in Lawrence, Miss. All units are requested to have three voting delegates at this meeting.

I deeply regret to inform you of the death of two of our members. Brother Dennis Lee Porter of Unit no. 910 was killed in a accident while at work. Brother Raiford Norris of Unit no. 620 died of a heart attack.

I have been informed that Kenneth Roberts of Unit no. 910 has been Banished forever from the United Klans of America,.

This same team will come into Miss. and put on the Yellow Dog degree, which is strickly a fun degree.

Esteemed Klansmen:
The State office of the Realm of Miss. has purchased a Lie detector machine. We have a Klansman in training to operate this machine. The purpose of this mazine is to weed out the informers and to settle any disputes that may arise among our people.

I am very sorry to be so late in getting this letter out, but I have been on the sick list. I was released from the Hospital this past Friday, the Doctor said that I will be O.K.

It is noted that WILLIE BARLOW is a secret member of
the UKA and that there is no knowledge of ARTHUR B. MC DANIEL or
JERRY FRANK CASE being members of any Klan unit.

It is reported that "CHICKENFOOT" ROBERTSON and some
other Klansmen had gotten into an argument over some money that
ROBERTSON allegedly owes to the UKA Unit Number Two. It is
further reported that at least two Klansmen, whose names are
unknown, called on ROBERTSON, and he was drinking at the time and
was very upset because they had come to see him. It is further
reported that the check that ROBERTSON had given to an individual
in Concordia Parish, Louisiana, to pay the fine for CHARLES O.
WHITE was returned and that there were quite a few people very
upset about this situation with "CHICKENFOOT" ROBERTSON.

RED GLOVER has been seen in the company of J. C. INGRAM
on several occasions, and it is reported among Klan members in
the Natchez, Mississippi, area that he might possibly be the

other man that was with GLOVER at the burglary that GLOVER was involved in in Wilkinson County, Mississippi. GLOVER was overheard to be talking to several individuals and mentioned that one of his "boys shot another one" somewhere around Hazlehurst, Mississippi, sometime around the last of February or first of March of 1972. The victim was shot allegedly three times and was taken to the University Hospital in Jackson, Mississippi, and is supposedly in fair condition. GLOVER was overheard talking to "CHICKENFOOT" ROBERTSON and telling him that they would have to "get those guns back from Old Man LEWIS," and it is believed that these guns that he is speaking of were the Smith and Wesson revolvers that "CHICKENFOOT" ROBERTSON previously had. Attending the state meeting were several individuals, among which was a DANNY WALKER and a (First Name Unknown) SCOTT representing the Brockhaven Klan Unit.

It is reported that the UKA of Mississippi has been advised that a lie detector is available through national headquarters in Tuscaloosa, Alabama, and that the Grand Dragon is attempting to get the lie detector available in Mississippi sometime in the future.

Also discussed during the state meeting was a parade in McComb, Mississippi, to be held on April 8. At this time no set plans have been made concerning the Klan involving themselves in the parade, but further details are being worked out.

It is also reported that on the agenda for the state meeting scheduled April 1, 1972, is the possible reelection of new state officers due to there being dissension among the Klan units and also members of some Klan units have allegedly been jumping from one unit and voting in another unit in order to throw the elections to the people that they wanted to win.

A CHARLIE CHRISTMAS, 414 North Durant, Amite, Louisiana, telephone number 748-7161, who allegedly is a former Grand Dragon of the Original Knights of the Ku Klux Klan of Louisiana, spoke to the organization, but it was the same diatribe against the Negroes and Jews in the United States of America. He told the Klan gathering that they were the last line of defense when the

country was taken over but did not specify who was to take over the country. It is noted that the Wesson, Mississippi, Unit was late arriving, and Units Number One and Three of Natchez, Mississippi, did not come at all.

It is reported that RED GLOVER is allegedly very worried concerning his trial in Wilkinson County, Mississippi. GLOVER has been telling the Klansmen in the barbeque pit that he has been told by his attorney, WILLIAM RILEY, to plead guilty and that the Circuit Judge LENOX FOREMAN will give him three years suspended and put him on probation for from one to two years. He further will have to pay a \$500 fine and make a \$200 restitution to the man whose goods he stole. He has been discussing this with several of the Klansmen, among which is JOE LEE HARDY, but has not decided according to his story what he is going to do about this situation.

It is reported that "CHICKENFOOT" ROBERTSON and JEWEL LEE BURT were to go with RED GLOVER to McComb, Mississippi, on March 19, 1972, to recover the Smith and Wesson firearms that had been previously mentioned. However, it is not know whether or not these firearms were recovered and whether or not they are in fact the Smith and Wesson firearms previously mentioned.

The UKA is planning on having two rallies in and around the McComb-Wesson, Mississippi, areas, the one for McComb scheduled for April 29, 1972, and the one for Wesson, Mississippi, soon thereafter. No further details are available at this time.

It is reported that RED GLOVER has obtained a 1965 white Buick but has not made contact with any klansman in and around the Natchez area for quite some time. On one occasion he was overheard talking to a group of individuals at the Bar-B-Que Pit at Natchez, Miss., wherein he stated he has been interviewed by the FBI and that he had not told them anything.

At the end of this particular conversation, GLOVER was met by J. C. INGRAM of Franklin County, Miss., and a white female who drove off in GLOVER's 1965 white Buick.

It is reported that JEWEL LEE BURT is still upset with CHICKENFOOT ROBERTSON because of various personal problems. Further, it is believed that CHICKENFOOT ROBERTSON is badly in debt and that he has not turned over the klan dues to the EC of the unit as he is supposed to have done. He was also involved [REDACTED] CHARLES O. WHITE, who

It is also reported that ROBERTSON has written TINY LEWIS at the Bar-B-Que Pit, and it is believed that he is deeply involved with the white female who is employed at the Windmill.

It is reported that Province #3 UKA members who passed out the klan pamphlets in Franklin County, Miss., were disappointed with the response but that they had planned to send some fake letters to the box number in order to check to see if the FBI was keeping tabs on the box number.

For information of the Bureau, it is pointed out that the subject in this matter has shown marked patterns of residential movement by taking up temporary residency usually by rental in and around the Natchez, Miss., area. However, he has on occasion resided in Vidalia, La., also.

Subject has usually left the temporary residence quarters in a relatively short period of time, usually not exceeding 90 days and has returned to a farm which he owns located in Kentwood, La.

Further, subject allegedly purchased a residence at 2035 Eleanor Street, Vidalia, La., approximately two months ago and was residing there until he began residency with his step-son, JAMES WATTS, at Leesdale, Miss.

In view of the fact that the subject owns residence property in the State of Louisiana and his tendency to leave a rental property and return to his farm, it is suggested that New Orleans retain origin in this matter.

On 1/8/72 a meeting was held in Brookhaven, Miss., at the headquarters of Unit 713 which on Old Highway 51 in a tin building near Brookhaven. There were five UKA units represented at the meeting as follows:

Mc Comb Unit
Brookhaven Unit
Wesson Unit
Liberty Unit
Natchez Unit #2

It is noted that represented in the Natchez Unit #2 were W. L. CHICKENFOOT ROBERTSON and JEWEL LEE BURT. Also present was KENNETH ROBERTSON, Knight Hawk of the state, who is a former EC of a unit in Pike or Amite Counties.

There were approximately twelve men in attendance at this meeting and during the course of the meeting, an ex-state representative by the name of TULLIS (phonetic) BRADLEY, who allegedly was a Klansman for years from Brookhaven, Miss., spoke on the deterioration of the United States. He stated that the President of the United States is only a figurehead and that the Klan could never be successful in anything that it undertook because it is too infiltrated by FBI informants. It is noted that he is believed to be scheduled to speak at the next state meeting in Lawrence, Miss.


Then the Grand Titan, the province leader, with the last name of FLEMING, mentioned that the leader of the UKA in Miss. has requested that this particular province drop literature in the Franklin County area and try to get men interested in joining or forming a unit, inasmuch as there is no unit in Franklin County at this time. He stated that a box has been obtained in Meadville, Miss.,

that box number being 391, and the pamphlets and literature that they will throw out will instruct any interested person to write that box number.

The meeting closed with a meeting of the province EC's only scheduled for 1/24/72 again at Brookhaven, Miss.

It is noted that during the conversations in and around the building prior to the beginning of the meeting, a man by the name of CHARLES GOODWIN who reported himself to be a member of the McComb, Miss., Unit, but how resides in Jackson, Miss., at telephone #354-3184, made the remark that he was trying to form a unit in Hinds County, Miss. It is noted that he also mentioned that he has guns for sale and mentioned specifically that he had a .38 Smith and Wesson Snub-nose there at the meeting for sale. It is believed that CHICKENFOOT ROBERTSON contacted the man and indicated that he will buy a Franchi shotgun from the man in the near future.

It was reported in the Natchez, Miss., area that CHICKENFOOT ROBERTSON



It is reported that CHICKENFOOT ROBERTSON also was recontacted by several individuals wanting to buy handguns and he told them that the man who had the handguns had already sold them.

RED GLOVER has moved to Leesdale, Miss., and is residing with his stepson, JAMES WATTS, at Leesdale, Miss.

However, he has indicated to several Klansmen that this is a temporary residence and that he will be moving back to Louisiana in the near future.

It is further noted that a member of UKA Unit #2, Adams County, Miss., by the name of ROBERT ROSE, who was employed as a welder in Vidalia, La., is allegedly working as a welder at the Armstrong Tire and Rubber Company in Natchez, Miss.

JOE LEE HARDY, who is no longer known to be affiliated with any Klan organization, is presently on suspension from the International Paper Company because he made a serious mistake during the operations at the paper mill and cost the company somewhere in the neighborhood of \$200,000 because of his error.

On 1/24/72 a meeting was held at Brookhaven, Miss., of all the ECs of the province. The meeting started at approximately 7:30 p.m. and it is noted that the following units were represented at that meeting with their ECs:

It is noted that the Vicksburg Unit did not send anyone to the meeting, although they are the only unit which was not represented.

During the course of the meeting, it was decided that the group would meet on Saturday, 1/29/72, at the roadside park near Meadville, Miss., on Highway 84, at 10:00 p.m. to throw literature over the Franklin County area. It is noted that several of the ECs were against meeting prior to the putting out of the literature but were overruled.

Each Klan Unit was charged \$5 for the distribution of the paper and was supposed to furnish any additional money that they could to the province. It is noted that Unit #3 in Adams County, Miss., was represented by BILLY HINSON, the EC of the unit, and present with him was ED HINSON, believed to be a brother of BILLY HINSON, a white male by the name of WHITEHEAD and JAMES JACKSON formerly of UKA Unit #1 of Natchez, Miss.

It is noted that prior to the arrival of UKA Unit #3 of Natchez, Miss., several members of the organization indicated that they were unhappy with the fact that some members of the UKA #3 Unit at Adams County, Miss., were under age and further that they were believed to be carrying guns and riding around Natchez, Miss. It is reported that the state organization is disturbed at this and if the riding around does not cease, action will be taken by the state level.

It was reported that a former EC of a unit around McComb, Miss., by the name of ROY MORGAN had become a turncoat and had given a party wherein Negro people had been invited. During the meeting, one of the ECs inquired as to why he was a turncoat and it was indicated that the private school in McComb or Liberty, Miss., had no longer continued to carry his (MORGAN's) retarded child and had turned him against the Klan.

Further, it is noted that during the course of the meeting, it was mentioned that a JAMES A. COOK, Route 2, Box 200, Columbia, Miss., is a Klansman, is very ill and the organization was requested to furnish letters and any financial help possible. The following is the pamphlet to be distributed in Franklin County, Miss.:

"SICK SOCIETY" ?

There are those who claim our is a "sick society"; that we are sick, well, maybe they are right. I submit I am sick...and maybe you are too. I am sick of having policemen ridiculed and called "Pigs" while cop killers are hailed as some kind of hero. I am sick of being told that religion is the opiate of the people, but Marijuana should be legalized.

I am sick of commentators and revolutionaries and criminals, rapist, condemning law enforcement when such criminals are brought to courts.

I am sick of being told that pornography is the right of the Free Press, But Freedom of the press does not include being able to read the Bible in School Rooms.

I am sick of paying more and more taxes to build schools while some faculty members are encouraging students to tear them down or burn them. I am sick of those who are suppose to run our schools, but don't have the courage or "guts" to maintain law and order in the public schools.

I am sick of the supreme court discision, which turns criminals loose on society, while other dicisions are to try to take away my means of protecting my home and family.

I am sick of pot smoking entertainers with their condemnation of moral standards. I am sick of being told that policemen are mad dogs, who should not be allowed to carry guns. But that criminals who use guns to rob, maim and murder, should be understood and helped back to society.

I am sick of being told that it is wrong to use napalalm to end a war overseas, but if it is a Molotov Cocktail or a Bomb at a home or place of business I must try to understand the provocation.

I am sick of not being able to take my family to a movie unless I want them exposed to nudity, homosexuality and the glorification of narcotics.

I am sick of riots, marches, protest, demonstrations, confrontations and other mob tantrums of people who are intellectually incapable of working within the system.

I am sick of hearing the same slick slogans, the cries of the people who must chant the same thing like zombies because they haven't the capacity for verbalizing thought.

I am sick of those who say I owe them this or that because of the sins of my forefathers, when most of these people are receiving federal and state handouts that I pay for through my heavy taxation.

I am sick of cynical attitudes toward "patriots" who are trying to help straighten out the mess that we find ourselves in. I am sick of the judges who release the dope peddlers with a small fine or a suspended sentence. I am sick of our law makers who will not pass strict laws to combat the dope situation that they know exist in our schools.

Most of all I am sick of being told that our country is sick when we have the greatest nation that has ever been on the earth.

TAKE NOTE: You will not find me throwing a rock or a bomb. You will not find me behind a placard or see me take to the streets. You will find me at work, paying my taxes and serving the community in which I live. You will find me speaking out and expressing my anger to the elected officials if they deserve it. PERSONAL FORM THE GRAND DRAGON



Freedom of Choice for Laboring Men

The American Party believes in Freedom of Choice, and this applies to schools, churches, private clubs or labor unions. We believe that Freedom of Choice is the American way.

The American Party will restore freedom to the laboring man so that he can control how his union dues are spent. We intend to give the union member a veto power which will prohibit his union dues being spent on causes and candidates which he does not support.

As Governor, Hall Lyons will work with the State Legislature in order to insure more freedom for the laboring men. We believe that the laboring men should have the right to join a union or not join, but we do not believe that a man should have to join a union in order to get a job or hold a job. The laboring man will no longer be a pawn and a tool and a source of money and power for the labor boss.

This will be known as a Freedom of Choice Labor Law.

Industry will be more willing to locate in Louisiana when we adopt a Freedom of Choice Labor Law in our State.

Labor Racketeering

Labor peace is needed to attract new industry. Labor racketeers will be dealt with as criminals by the Attorney General.

The rights of the labor organizations who obey the law will be respected.

The Freedom of Choice Labor Law will provide for limited terms of labor leaders as presidents of unions in order to restore local control of unions by their members. We intend to restore democracy to union elections with a secret ballot under neutral supervision.

We will treat labor and management with complete fairness so as to attract new industrial investment and thus provide more jobs.

When Hall Lyons is elected Governor of Louisiana everyone will get a fair shake - not a shake-down.

Welfare

The scandal associated with various aspects of the welfare program should be thoroughly investigated so as to remove the racketeers from the welfare rolls.

To reduce the burden of the growing cost of the "Aid to Dependent Children", the State should

adopt a Parental Responsibility Law forcing the fathers of all children born in or out of wedlock to be responsible for the cost of raising their children.

Fundamental Principles

The American Party of Louisiana obtained 48.5% of the vote of Louisiana for its presidential candidate in 1968.

Most of the Democrats who voted for Richard Nixon believed his campaign promises made in speeches both in the South and in other parts of the Nation, but now find that the Republican Administration of President Nixon has not only repudiated Richard Nixon's speeches but also the promises made in the platform.

Therefore, it would seem that a majority of the people in Louisiana have already departed from any lasting allegiance to the Democrat and Republican Parties, and are looking for a new political party based on principles not on promises and politicians.

The Principles of the American Party

The American Party on the national level has adopted a general statement of principles, upon which to build a party truly reflecting the will and the desires of the majority of all Americans. The American party of the USA believes in:

1. Restoring a sense of and a devotion to decency among all men.

2. Encouraging the individual to become more responsible to his God, his family, himself, and his country and state.

3. Restoring the sovereignty and independence of the States as defined in the Constitution of the United States.

4. Restoring the sovereignty of the individual people within the states.

5. Instilling a new sense of loyalty to the ideas and the ideals of liberty and freedom expressed in the Constitution and the Bill of Rights.

With these basic principles in mind, we offer the following program and statement of principles as applied to the problems and the hopes of the people of Louisiana.

The Moral Issue

There is nothing wrong in Louisiana which cannot be corrected by a return to principles, to morality, to honesty and integrity.

This is not an impossible dream if we take the power away from the Governor and the bureaucrats and return it to the people, to the cities, to the parishes and to the elected senators and representatives.

Corruption in high places in Louisiana has become a cancer that must be cut out in an emergency operation. This means breaking all ties with the National Democratic and Republican Parties and declaring our independence from the criminal and political conspiracies which have brought Louisiana to our present corrupt condition.

Personal Income Taxes

The American Party believes that what a man earns he should be allowed to keep and spend according to his own concept of freedom of choice in the market place. By abolishing the personal income tax in Louisiana we will be attracting industry, investors and retired people. This will create new job opportunities by attracting personal and private investment to our State. Business volume will increase to such an extent that income from other taxes at the wholesale and retail level will replace the loss of income from personal taxes.

Property Tax Assessments

We completely support the right of the people in their individual parishes to raise sufficient taxes to carry on their local improvements and therefore we are completely opposed to the fraudulent "Equalization of Property Tax Assessments" which is being promoted by the bond salesman and the eastern banking interests which are continuously seeking to drive the people of Louisiana into more and more debt.

The American Party believes in local control and we believe that the local assessors know what the people in their districts need and want and therefore we are against the so-called "Property Tax Equalization" racket because we believe in local home rule.

Industrial Development

The way to attract new industry is to provide a welcome atmosphere, based on fair taxes; equal treatment of labor and industry; honest elected officials; and superior technical education.

To get rid of tax favoritism we should end tax inducements which do not attract industry with a high employment potential.

We will give labor union members a Freedom of Choice Labor Law, which will end corruption and racketeering in labor union management, by giving the union man a secret ballot in electing his officials and limiting union presidents to one year terms with a limit of four years consecutively.

Abolition of the state tax on personal incomes will attract new people to Louisiana and will also attract new investors, and industries to our state thus giving our people more jobs.

And finally we must improve the quality of our trade and technical schools. These schools should be made independent of the corrupt State Department of Education and placed under the control of the local school board thus better serving local industry.

Restore the Freedom of the Press

To give the people greater freedom of choice in the news media, chain ownership of newspapers, radio and television stations needs to be abolished.

We do not allow chain banking in Louisiana and we should not allow the same corporation or family to own radio and newspapers and television stations in the State. We believe the people will be better informed when there is more competition among the organizations providing the news.

Freedom of Choice in Education

The American Party believes in freedom of choice. And in the case of education, this means the restoration of the concept of neighborhood schools and guaranteeing to all citizens, regardless of race, religion or color, an equal opportunity to go to the school of his choice. We are opposed to bussing as a method of achieving racial balance.

Financing Education

We propose to use a voucher system for education, which means that the total amount of money available for the education of our children shall be divided equally among all children of school age. Everyone will have the opportunity to go to the school of his choice, whether the school is operated by the public school system, a church-connected school, or a private, non-sectarian school.

We will not be financing any particular religion. We will also end a double financial burden for those parents who wish their children to receive quality education with religious instruction included.

Federal Aid to Education

A study of the educational budget of Louisiana indicates that about 15% of the total amount of money spent on education comes from Federal sources.

We believe that we should tell the Federal Government that we will refuse their money so that we can be free from Federal controls. Most of the money coming from Federal sources is spent for materials and supplies (much of which is wasted) and bureaucratic supervision within the State Department of Education. We believe that by cutting out unnecessary frills in the gigantic educational bureaucracy of our State, we can improve the quality of education of all of our students by concentrating on essentials.

This approach to the solution of the problem of education chaos in our school system will result in a concentration on quality education and a return to the normal neighborhood school, freedom-of-choice concept which provided educational continuity and harmony prior to the days of Federal interference.

Technical Education

We believe that all technical and trade schools should be taken away from the Louisiana State Department of Education and put under the control of the local parish school board. The purpose is to produce qualified employees for the commerce and industry in the local area. This is the private enterprise way of attracting and expanding industrial opportunity by improving the quality of education.

RALEIGH JACKSON GLOVER, General Delivery, Washington, Mississippi, was contacted at his stepson's residence in Leesdale, Mississippi, and was advised of the official identities of the interviewing Agents and that he was being contacted regarding his views on the Ku Klux Klan and other extremist organizations. He then furnished the following voluntary information:

GLOVER advised that he is not now, nor has he ever been, a member of any type of klan organization nor has he ever been approached to join any such organization. He stated that he has been contacted at least 18 times previously concerning the klan and extremist organizations and that he has, on every occasion, furnished the same information to the FBI.

GLOVER advised that he believes that the klan or any other organization or person should not set himself up as being "contrary to the law" and that if any organization or person did set himself up or violate any law, he should be prosecuted and punished for the violation.

GLOVER stated that he did not care to make any type of comment upon his personal views concerning the Ku Klux Klan because he felt that it was his own personal business, and it did not fall under the label of being anyone else's business.

Raleigh Jackson Glover, General Delivery,
Washington, Mississippi, furnished the following voluntary
information to two Special Agents of the Federal Bureau of
Investigation on January 21, 1972:

Glover stated that he has never been a member of
any Klan organization and that he has never been approached
to join any Klan organization. He stated he has furnished
this information on all prior occasions when contacted by
the FBI and would immediately notify the FBI if he were
contacted regarding Klan or other extremist organization
membership.

Glover stated that he believes the Klan or any
other extremist organization should not set itself up
"contrary to the law" and that if any person or organization
violated any law they should be punished for that violation.

Glover stated that he would make no comments con-
cerning his own views because they were personal and he did
not feel that they were anyone else's business.

RED GLOVER is believed to have moved to a large house on the south side of Highway 84 near Leesdale, Mississippi. His wife, POLLY, is again working at Wilson's Drugstore in Natchez, Mississippi.

JEWEL LEE BURT has not been too friendly with the Klansmen in Natchez, Mississippi, lately. He allegedly still is mad because he cannot get "CHICKENFOOT" ROBERTSON, the EC of Unit #2, to spend any money.

It is reported that "CHICKENFOOT" ROBERTSON is still advertising and trying to sell a group of Smith and Wesson firearms around the Armstrong Tire and Rubber Company. It is noted, however, that when he was contacted by an individual wanting to buy some of these guns, he told the individual that he would have to get the guns from the man that had them as someone else other than he, ROBERTSON, was keeping them.

It is believed that "CHICKENFOOT" ROBERTSON is

At the recent UKA State Meeting located in Lawrence, Mississippi, on 1/8/72, the individual that attended from the #2 Unit was "CHICKENFOOT" ROBERTSON. Also present at the meeting was JAMES JACKSON, who answered for the #3 Unit in Natchez, Mississippi. It is believed that JAMES and A. C. JACKSON have transferred from Unit #1, UKA, to the #3 Unit, UKA, in Natchez, Mississippi. During the course of the meeting, KENNETH ROBERTSON from McComb, Mississippi, has been affirmed as Knighthawk for the UKA of Mississippi. A man by the name of FINDLEY, believed to be from McComb, Mississippi, has been appointed the Titan for Province #3.

During the course of the meeting it was mentioned that in either Columbus or Hattiesburg, Mississippi, a pamphlet was located in the public library wherein instructions for bombing schools and the making of gasoline bombs and Molotov cocktails were set forth. The UKA decided that they would complaint about this to the different libraries and try to get the pamphlet, with the name "Black Nation," removed from the library shelves.

It is noted that JAMES and A. C. JACKSON are believed to have transferred to the Third Unit, UKA, Adams County, Mississippi, from the #1 Unit. It is rumored that I. J. RUDISEL has taken over as EC of the #1 Unit, and the AEC of the #3 Unit is either STEVEN JOSEPH AUCOIN or a white male by the last name of HINSON who is employed at Woolco at Natchez, Mississippi.

The next state meeting for the UKA in Mississippi is set for 2/26/72, believed to be at Lawrence, Mississippi, and there is to be an officers meeting of the UKA for the state, this Saturday, 1/15/72, at Lawrence, Mississippi.

The following pamphlet entitled "Sick Society" and petition to the House of Representatives of the State of Mississippi and the letter from DURELL FONDREN were believed to have been received by the EC of Unit #2 sometime in December, 1971:

"Sick Society"?

There is those who claim ours is a "sick society";that we are sick,well maybe they are right. I submit I'm sick ... and maybe you are too. I am sick of having Policemen ridiculed and called "Pigs"while cop killers are hailed as some kind of hero.

I am sick of being told that religion is the opiate of the people,but Marijuana should be legalized.

I am sick of commentators and revolutionaries and criminals rapist,condemning Law Enforcement when such criminals are brought to justic.

I am sick of being told that pornography is the right of the Free Press,but Freedom of the Press does not include being able to read the Bible in School Rooms.

I am sick of paying more and more Taxes to build schools while I see some faculty members encourging students to either to tear them down or burn them. I am sick of those who are supposed to run our schools,but dont have the courage or"guts" to maintain law and order in our public schools.

I am sick of the supreme court dicisions,which turn criminals loose on society-while other decisions try to take away my means of protecting my home and family.

I am sick of pot smoking entertainers with their condemnation of moral standards.



On 12/16/71, the current occupant of 2036 Eleanor Street, Vidalia, La., advised that subject has moved from that location, stating that he was "moving into the country on the other side of Natchez, Mississippi." According to occupant, subject's wife works at Wilson's in Natchez, Miss., and subject works at Armstrong Tire and Rubber Company, Natchez, Miss.

On 12/16/71, inquiry at the Vidalia, Louisiana Post Office determined that subject has moved from 2036 Eleanor, leaving a forwarding address of General Delivery, Washington, Mississippi.
