



James Lee Scaroborough, a klansman of Ferriday, Louisiana, is forming a Klan-backed rifle club and is soliciting membership in the National Rifle Association. The Bureau suggested to Jackson the possibility of an anonymous mailing to the National Rifle Association in an attempt to thwart the acceptance of the above group in the National Rifle Association. The Jackson Office submitted a copy of a letter with the Salutation "Dear Governor," and signed "Troubled Wife." The letter sets out that the individual writing is quite upset because her husband has become involved with Scaroborough and the fact that Scaroborough has a reputation for being a violent individual. It points out that Scaroborough has been holding meetings at the state office of Virgil Wright who is a Louisiana state employee in the Drivers License Bureau. The letter further states that a copy is being sent to the National Rifle Association. Jackson advised that the letter will be sent anonymously to the Governor of the State of Louisiana as well as the National Rifle Association. 

Special Agent in Charge

Dear Governor:

I am writing to you for help. I am quite upset. My husband has become involved in something that is going to turn out bad for both himself and the family. He has always been interested in guns as he is an avid sportsman. Recently, James Lee Scaroborough of Ferriday, Louisiana, contacted him to join a new Concordia Pistol and Rifle Club. Scaroborough has the reputation for being a violent member of the Ku Klux Klan and many people in the community have a great amount of fear for him.

To date, my husband has attended several meetings at the state office of Virgil Wright who is a Louisiana state employee in the Drivers License Bureau. State officials and employees should not be deceiving citizens dragging them into hate outfits organized by Klansmen under the pretense of being a sportsman's club.

I think that this is a secret organization that is much more dangerous than the Klan. My husband is

being led by the nose by Scaroborough. Please do something about this group for both my sake and for the sake of the community. They are all armed with God knows how many weapons.

I am sending a copy of this letter to the NRA, too, but I have no hope for them. They will accept anybody to make a dollar. Scaroborough would kill me and hurt my husband if he knew who wrote this so it must be unsigned.

In regard to your request that your office be advised as to what action the National Rifle Association (NRA) took after receiving an anonymous letter in the past concerning the chartering of a Klan-backed rifle and pistol club similar to that being formed by James Lee Scaroborough in the Ferriday, Louisiana, area, the following is furnished.

After the submission of an anonymous letter to the headquarters of the NRA in Washington, D. C., relative to the attempt to form a Klan-backed group to be known as the Belmont Rifle and Pistol Club of Belmont, North Carolina, the NRA submitted a letter to the Belmont Rifle and Pistol Club which stated that their organization had not accepted the group and turned down their request for a charter. The letter from the NRA was read to the members at a meeting of the Belmont Klavern of the United Klans of America, Inc., on 6/5/67. REC 51 157 - 4717

Promptly submit information contained in referenced letter in a form suitable for dissemination to the Bureau. Also disseminate this information to local military intelligence agencies and the Secret Service in your area.

Referenced letter enclosed to the Bureau as a counterintelligence measure a suggested letter to be made available to officials of the National Rifle Association (NRA) in Washington, D. C., by the Washington Field Office if approved by the Bureau.

Authority to contact or to make the letter available to NRA officials in Washington, D. C., is denied, for to do so would cause an outside organization to become aware of an investigative technique utilized by the FBI.

For your information, the Charlotte Office recently experienced a similar situation wherein the Klan was attempting to form a rifle club which was to be associated with the NRA. Charlotte was authorized to prepare the following anonymous letter which was mailed to the President of the NRA, 1600 Rhode Island Avenue, N. W., Washington, D. C., on 5/2/67. It is suggested that you prepare a similar letter and mail same to the NRA at the above address. The letter should be prepared on unwatermarked paper with no Bureau markings. Be certain that the letter is carefully handled and given full security. For your guidance, the letter mailed by the Charlotte Office is set forth verbatim.

"Dear Sir:

"I am writing this letter as an outraged citizen of Belmont, North Carolina, who has recently learned of the backing your organization has given to the local Ku Klux Klan organization in my home town.

"I refer to the Belmont Rifle and Pistol Club of Belmont, North Carolina, which I am sure you must realize is made up of Ku Klux Klan members. It is a National Rifle Association affiliated group, too - does this mean that the NRA believes in the Ku Klux Klan and that these are the "Americans" you want to have guns?

In the event you do not know - believe me, I do. The members of the Belmont Rifle and Pistol Club are all active members of the Belmont Klavern of the United Klans of America. The charter of this pistol club should be cancelled and any affiliation with your NRA should cease.

"I regret I must remain anonymous, but I know what would happen to me if I signed my name and members of the Klan learned who I was."

For your additional information, under certain circumstances the Director of Civilian Marksmanship of the U. S. Army furnishes rifles and ammunition to NRA-affiliated clubs, and this proposed new rifle club may be planning to take advantage of this assistance.

It is of utmost importance that you ascertain the name of the proposed new club so the Bureau will be in a position to advise the Director of Civilian Marksmanship. The name, or sufficient identifying information should be obtained prior to your submitting the suggested anonymous letter mentioned above. Be certain your anonymous letter is not identical to the letter mailed by the Charlotte Office.

NOTE: The Jackson Office has advised of an attempt to form a new chapter of the NRA by Klan and former Klan members in the Jackson territory and submitted a suggested letter to be given to officials of the NRA in Washington, D. C., as a counterintelligence measure. We do not desire to contact NRA officials



Enclosed for Bureau and WFO is one copy each of a suggested letter to JAMES LEE SCAROBOROUGH.

On 5/29/67, FOIA(b)7 - (D) advised that he met with JAMES LEE SCAROBOROUGH, 332 Iowa Street, Ferriday, Louisiana, to discuss the formation of a new chapter of the National Rifle Association (NRA). SCAROBOROUGH is the subject of Jackson file 157-7479 and Bureau file 157-3975. He was the Exalted Cyclops of the Ferriday-Clayton, Louisian Klan in 1965 and is presently under investigation in the WHARBOM investigation, Jackson file 44-2044, as a member of the Silver Dollar Group, Jackson file 157-5206.


SCAROBOROUGH told source that this new organization was going to be comprised of a good or legitimate side and dark or secret side. He continued that they planned to admir an unidentified FBI informant who would be restricted to only the legitimate side of the chapter. Source advised that SCAROBOROUGH believed by doing this the FBI would have no reason to investigate it.

SCAROBOROUGH told source that he is going to write, or has written, a letter to the NRA Headquarters in Washington, D. C. to apply for authorization to form the new chapter, as well as to obtain the names of NRA members in the Mississippi -Louisiana area. Source believed that SCAROBOROUGH was going to pick members for the chapter from this list.

Source continued that the chapter will have an official charter, will charge \$10.00 membership dues, will have legitimate meetings, and will organize a young persons club within it.

SCAROBOROUGH said that he wanted to be particularly sure of the members who will function on the secret side of the chapter so that they can be depended upon when needed.

It is suggested that this proposed chapter of the NRA in Concordia Parish, Louisiana, may be a basis for the revival of the Klan in that area. In view of this, it is suggested that the NRA Headquarters in Washington, D. C. be contacted to establish whether such an application has in fact been received and of the danger of being used as a legal cover for a sub rejue-type group.


Dear Mr. Scaroborough:



A review of information regarding Klan matters indicates above group is described as being composed of persons residing in Mississippi and Louisiana who would probably commit acts of violence. It is noted that this group was recently described in the above manner by a New Orleans informant, which information was set forth in the report of SA Donald J. McGorty dated 11/3/65 captioned "James Frederick Lee, RM - Klan."

By return airtel New Orleans is instructed to furnish a letterhead memorandum suitable for dissemination setting forth the names of known or suspected members of this group and its objectives. The memorandum should also include a brief summary of the activities.

In the event it is determined that this group and its members have a propensity for violence, New Orleans should make certain that individual cases are opened on the members pursuant to the instructions set forth in Section 122A, Volume IV, Manual of Instructions. Insofar as the group itself is concerned, if it DEC 9 1965 is actually a part of a particular Klan then the investigation concerning the group should be handled as part of the Klan inves-COMM-FBI tigation. However, if the Silver Dollar Group is a separate and distinct organization, then it should be handled accordingly and pursuant to above-mentioned Manual section. After the hearing was concluded, RALEIGH JACKSON GLOVER was observed to walk over to MORACE and converse with him.

HOMER T. HORTON, contacted at 413 Lynn Street, Vidalia, Louisiana, was advised of the identity of the interviewing Agent who also advised him that he did not have to furnish any information and that any information he did furnish could be used in a court of law.

HORTON advised that approximately two years ago, he purchased an M-1 Carbine rifle from Sears, Roebuck and Company in Natchez, Mississippi. He advised he fired the semi-automatic weapon two or three times to see if it worked. He advised that he has no other guns.

HORTON advised that he sees RALEIGH JACKSON GLOVER almost every day at the Armstrong Tire and Rubber Company plant. HORTON became very hostile toward the interviewing Agent and the FBI at the mention of GLOVER's name, stating, "The FBI has lied about me and GLOVER to people all over two states."

HORTON stated that he did not want to see another FBI Agent unless it was in court where they will have to prove what they are saying about him. He accused the FBI of trying to prevent him from getting his flight instructor's license, of talking to all his neighbors and friends, and telling them that he was involved in the death of WHARLEST JACKSON.

TORGERSEN advised that he has been unable to learn any information indicating those responsible for the bombings of GEORGE METCALFE or WHARLEST JACKSON. He continued to deny any prior knowledge or participation in either of these matters.

TORGERSEN stated that he told GLOVER he would be there but he had no intention of making an appearance at this hearing.

TORGERSEN advised that on the afternoon of July 24, 1967, he visited JAMES LEE SCAROBOROUGH in Ferriday, Louisiana, and learned that SCAROBOROUGH has no activity at the present time with the exception of the construction of a private school in the City of Ferriday, Louisiana.

TORGERSEN continued that on the night of July 24, 1967, he was visited by TOMMIE LEE JONES of Natchez, Mississippi, and that JONES appeared very upset over his recent association with GLOVER on the night of July 14, 1967. JONES told TORGERSEN that he had been requested by GLOVER to attend GLOVER's hearing concerning the bush hog matter as GLOVER had told him, "The enemy will be there, and we

RALPH HALL DAY, interviewed at his used car lot, Highway 550, Brookhaven, Mississippi, on July 18, 1967, at his own request, furnished the following information.

DAY advised that during the past few weeks, he has been in touch with ELDEN GLEN HESTER of rural Meadville, Mississippi, on two occasions, the last being the afternoon of July 4, 1967.

DAY advised that he introduced himself at the HESTER residence by telling him that he has heard of him through his wife, who was born and reared some three miles from his residence and has known HESTER all her life.

DAY advised that he offered to sell HESTER an automobile, should he need one in the near future, at a very good price. DAY advised that he was unable to get HESTER to converse with him at all on either occasion.

HESTER to converse with him at all on either occasion. He advised that on the afternoon of July 4, 1967, HESTER dragged an old pickup truck from the front of his house across the highway to the rear of his father's house with his tractor. He stated that "Try as I may, I could not get HESTER to converse with me."

DAY advised that his father-in-law, who resides in the rural Meadville, Mississippi, area, is currently working for ROSS BARNETT in the forthcoming Gubernatorial race in Mississippi. He advised that his father-in-law told him that JAMES FORD SEALE is going to be elected Sheriff in Franklin County. He stated that according to his father-in-law, SEALE has attached himself to the BARNETT forces in Franklin County and is going to be elected Sheriff in that county.



TOMMIE LEE JONES, a resident of 75 Cloverdale Road, Natchez, Mississippi, telephonically contacted the interviewing Agent and thereafter proceeded to the Bienville Apartments, Commerce Street in Natchez, for a meeting with interviewing Agent.

After acknowledging the identity of the interviewing Agent, JONES was warned of his rights and stated he understood completely his rights and desired to discuss the matter of his recent association of RALEIGH JACKSON GLOVER.

He advised that GLOVER had recently told him that he was scheduled to appear at a hearing in Fayette, Mississippi, on Saturday, July 22, 1967, in regards to the theft of the bush hog. JONES advised that GLOVER has told him that he had nothing whatsoever to do with this theft. JONES advised that he planned to accompany GLOVER to this hearing merely to see what it was all about. He denied that GLOVER requested his presence.

JONES was questioned concerning his activity with GLOVER on Friday, July 14, 1967. He did not deny that he

JONES volunteered that upon returning to the parking lot at the hospital, they saw several individuals they suspected to be FBI Agents watching GLOVER's truck. He stated they then drove to the back of the hospital where he let GLOVER out of his automobile. He stated that GLOVER had to be at work at midnight at Armstrong Tire and Rubber Company.

When questioned further of the trip to Vidalia, Louisiana, JONES then stated that GLOVER came to his residence at approximately 6:00 PM, evening of July 14, 1967, and requested that JONES drive him to his residence in Kentwood, Louisiana. He advised that GLOVER parked his truck at the Jefferson Davis Hospital parking lot, that H he picked GLOVER up at the hospital, and they drove to F Kentwood, Louisiana, in JONES' white Chevrolet. He stated they drove through Meadville, Summit, and McComb, Mississippi, to Kentwood, Louisiana. JONES advised that P End they stopped only once during this trip and that was at a residence in rural Kentwood. Louisiana where CLOWER a residence in rural Kentwood, Louisiana, where GLOVER talked briefly with an unknown individual. He advised that they 5 arrived at GLOVER's rural Kentwood, Louisiana, residence at approximately 8:00 PM. They then had a cup of coffee with GLOVER's wife and GLOVER then bathed and shaved and S at approximately 8:00 PM. They then had a cup of coffee they returned to Natchez by the same route.

When approaching Jefferson Davis Hospital, they observed what they thought to be FBI Agents and he then let GLOVER out at the back of the hospital. JONES stated that GLOVER then went on to work at Armstrong and that he, JONES, went home. On this trip, JONES advised GLOVER took nothing with him, brought nothing back, and that they contacted only one individual en route to Kentwood, Louisiana, and this was in rural Kentwood. JONES advised that he did not know the real purpose of this trip. He did state, however, that it did not strike him unusual that GLOVER requested him to drive him to Kentwood, Louisiana, a distance of almost 100 miles, for merely a bath and a shave.

When questioned further in regard to any items taken on this trip by GLOVER or himself, brought back from Louisiana, or activity during the course of this trip, JONES then admitted that they brought a box back from Kentwood, Louisiana, to Natchez, Mississippi. He advised that while at GLOVER's residence in Kentwood, GLOVER showed him a box approximately 38 inches in length, six inches in width, and six inches deep, rectangular in shape, under a tree at his residence. According to JONES, GLOVER requested that he put this box in the trunk of his car and dispose of it. JONES stated that GLOVER gave his car and the wanted that he put the box in the trunk of. JONES stated that he put the box in the trunk his car and brought in back to Natchez. After leaving or OVER at the rear of the Jefferson Davis Hospital, JON to the Moose Hall, Highway 61 in of his car, a no reason as to why he wanted this particular box disposed GLOVER at the rear of the Jefferson Davis Hospital, JONES Stand he then drove to the Moose Hall, Highway 61 in Natchez, removed this box from the trunk of his car, and .L. tossed it out at the back of the Mcose Hall building. B He stated he then returned home.

He stated he then returned home. JONES advised that he was absolutely sure there were no guns, explosives, or any other items in this box when they picked it up at GLOVER's Kentwood residence. He stated further that it was completely empty when he disposed of it at the Moose Hall. JONES stated again that he did not think this was unusual in view of the fact that he has heard GLOVER refer to the fact that the FBI had previously questioned people concerning this box. JONES volunteered that he thought GLOVER might have "sometime in the past" kept guns or explosives in this box and for this reason wanted to dispose of it.

JONES stated that he conducted no activity whatsoever with GLOVER in regard to guns or explosives on this particular night or "any other time".

JONES, who was visibly nervous during the questioning of his activity with GLOVER on the night of July 14, 1967, volunteered that he was upset because

of the fact he feels GLOVER may have gotten him involved in some illegal activity. JONES would not elaborate on this "belief" but merely stated he was worried about it.

JONES was requested to point out the location where this box was disposed of. He then pointed out the location which was the west side of the Moose Hall and actually retrieved this box and furnished it to the interviewing Agent. He then requested that this box be returned to him at such time as it was no longer useful.

JONES was questioned further at this time concerning the GEORGE METCALFE and WHARLEST JACKSON bombings and he continued to deny any participation or prior knowledge of either of these matters. He again stated that he would not deny the fact that he was a member of a group known as the "Silver Dollar Group" but stated that he had no information whatsoever that anyone in this group had anything to do with the bombings of METCALFE or JACKSON. At this interview JONES further denied any participation or knowledge of the beating in March of 1966, of ROBERT CUPSTID, now a Natchez Policeman, by robed Klansmen.

JONES concluded by stating that he would give further thought to his and GLOVER's activities on the night of July 14, 1967, and would again recontact the interviewing Agent at a later date.




TOMMIE LEE JONES, a resident of 75 Cloverdale, Natchez, Mississippi, made available an unpainted wooden box lined with tar paper, which box was retrieved by JONES from the west side of the Moose Hall, Highway 61, Natchez, Mississippi. This box, according to JONES, was transferred from the residence of RALEIGH JACKSON GLOVER in Kentwood, Louisiana, in JONES' automobile, a 1963 white Chevrolet, to the Moose Hall, Natchez, on July 14, 1967.

It was evident that this box had been exposed to several days of heavy rain and was quite dirty and muddy when retrieved by JONES.

This box was immediately examined at the time it was turned over by JONES and it was empty.

The box is constructed of rough unpainted lumber, completely lined on the inside with tar paper, and measures approximately 54½ by 9 3/4 by 5½ inches.

JONES requested this box be returned to him upon completion of examination by this Bureau.



JAMES LEE SCAROBOROUGH, 332 Iowa Street, after acknowledging the identity of the interviewing Agent, stated that he was completely aware of his rights and that he had no objections to talking with the interviewing Agent at any time.

SCAROBOROUGH advised that he has no current association with any Klan group. He stated that his only activity at the present time is that of his regular job at International Paper Company in Natchez and the building of a private school in Ferriday, Louisiana. He did state, however, that he continues his interest in forming a Junior Club of the National Rifle Association (NRA) for the purpose of keeping teenagers off the streets and out of bars.

SCAROBOROUGH advised that his only association with any Klansmen at the present time was confined to social visits. He advised that he had no time for any Klan work and further that he would have no association whatsoever with any individual for the purpose of conducting any type of violence. SCAROBOROUGH gave his reason as that he does not believe any act of violence is a solution to integration or any other "problems" facing a citizen.

SCAROBOROUGH advised further that he did not desire at the present time to have even a social association with anyone who would be prone to conduct an act of violence such as the bombings of GEORGE METCALFE and WHARLEST JACKSON. SCAROBOROUGH advised that, as stated before, he has no knowledge of who was responsible for these bombings but advised he would describe the person responsible for these acts as "an animal or primitive person." He advised that the person responsible for these bombings would have to be

"an athiest, non-family man, mentally unbalanced, and in reality, a criminal rather than a segregationist."

In response to questions regarding what action SCAROBOROUGH would take if called upon to participate in any such act of violence, SCAROBOROUGH advised that because of his personal feelings, he would immediately notify this Bureau.

JONES, during this interview, volunteered that he could not recall ever seeing any illegal guns in GLOVER's possession, but he did have personal knowledge that GLOVER has had certain types of explosives. He further volunteered that GLOVER might have at one time maintained explosives in this box. JONES declined to elaborate on his personal knowledge of the possession of explosives by GLOVER, but merely stated he knew GLOVER had some "in the past". He, however, denied ever conducting any activity with GLOVER in regard to explosives.

JONES advised that during the time that he was a member of the Klan and Silver Dollar Group, he never heard the name WHARLEST JACKSON discussed. He admitted, however, that sometime during July or August, 1965, he did hear the members of the Silver Dollar Group discussing GEORGE METCALFE. JONES stated he did not desire to discuss this matter further, but again stated that he had nothing whatsoever to do with the GEORGE METCALFE or WHARLEST JACKSON bombings.

JONES advised that during conversations recently with other Klansmen, he had learned that Klansmen are at present generally upset and worried about a possible civil suit brought by victims' families in regard to acts of violence conducted by the Klan. JONES would not reveal any particular incident or individuals.



ROBERT JACK CUPSTID, Patrolman, Natchez, Mississippi Police Department, was interviewed at the Natchez Resident Agency Office of the FBI and he furnished the following information:

In March, 1966, he was employed as a bookkeeper by the Natchez Boat Store which is located on the Mississippi F River in Natchez. The Cargill Road leads from Natchez to this firm's location. This firm supplies boats which travel on the Mississippi River. The firm is notified by teletype about 12 hours before a boat will appear at this firm's location for supplies. Regardless of the hour in which a boat was to appear at the firm's location, CUPSTID would be present at his place of employment in order to help supply the boats.

One night in March, 1966, at about 11:30 PM he was driving down Cargill Road toward his place of employment; and approximately two miles before he arrived at his place of employment, he observed a 1955 or 1956 blue Ford parked on the side of the road and a man was standing beside it with a five gallon gas can in his hand. This man motioned with his hand and CUPSTID thought he needed some assistance, so he pulled his automobile (which was a 1963 yellow Ford convertible) behind the parked automobile and stopped. This man walked up to his automobile and asked him if he could have enough gasoline to get his vehicle to a service station. CUPSTID said he told the individual he did not have a hose in order to siphon some gasoline from his automobile into the can. This man stated he had a rubber hose in the trunk of his automobile and he and CUPSTID walked to the rear of this individual's vehicle. CUPSTID stated as this individual unlocked the trunk of his vehicle, he heard both of the rear doors of this individual's vehicle open and saw one individual door maarie white tobe. the individual who had not been wearing a robe grabbed him by the left arm and one of the robed individuals grabbed him by the right arm. He was pulled over to his vehicle and his arms were stretched out over the hood of his car and one of the hooded individuals held his arms from the opposite side of his car. After he was pulled upon the hood of his car, the other hooded individual hit him with what CUPSTID believed to be a wire, similar to the receiving wire of a telephone, about 25 times across his back, shoulders, and arms.

After he was beaten he managed to jerk one of his arms free, but immediately he was pushed to the ground and one of the individuals kicked him in the ribs and knocked the breath out of him. After this, one of the individuals stated, "that's enough, lets get out of here before someone spots us". These individuals then picked up the gas can, got into their vehicle, made a "U" turn, and drove in the direction of Natchez.

ARA TWO CUPSTID stated he remained on the ground for a few minutes in order to get his breath, then he returned to his residence. When he returned to his residence, he told his

After observing the scene of the incident, he and his father drove to his father's residence, where he was living at the time, and he (CUPSTID) spoke to Sheriff ODELL ANDERS, who telephoned him to inquire about the incident. He stated he told ANDERS best he could what had happened and ANDERS said he would do what he could to identify the individuals who had beaten him. He stated he never heard

from the sheriff again about the incident. CUPSTID stated that while he and his father had gone to the doctor's home, his mother had called the sheriff's office and reported the incident.

CUPSTID described the individual with the gas can in his hand who was not covered by hood and robe, as follows:



CUPSTID stated he does not know the reason he was beaten. However, he pointed out he had been outspoken in his criticism of the Klan. He stated he had frequented the Shamrock Restaurant in Vidalia, Louisiana, prior to March, 1966, and on occasion while there he criticized the Klan.

He stated that on the afternoon prior to his beating, he visited his girl friend who was employed at the Sterling Store in Vidalia, Louisiana. While there he talked with TRUMON DUNHAM, a white male about 40 - 45 years of age, who was at that time manager of the store. He stated DUNHAM was aware of the fact he was going to work that night. He and DUNHAM had discussed the Ku Klux Klan in the past and he and DUNHAM had had a few arguments over CUPSTID's criticism of the Klan. He stated he was of the opinion DUNHAM was a member of some Klan type group but he had no proof to back up this statement.



CUPSTID stated that BOBBY HARMAN or Captain INMAN, both mentioned above, would have worked with him the night in which he was beaten.




He stated these individuals alternated the nights in which they worked, so he never knew which one of them would be working until he arrived at work.



ODIS HESTER, father of ELDEN GLEN HESTER, was interviewed at his residence, Route 3, Meadville, Mississippi. He identified a photograph of RALEIGH JACKSON GLOVER and thereafter furnished the following information:

His son, ELDEN GLEN, and GLOVER are in his opinion associates but not close friends. When his son resided in Louisiana about a year or so ago he and GLOVER rode to work together when they worked the same shift at the Armstrong Tire and Rubber Company in Natchez, Mississippi. The stated he had seen GLOVER at his son's residence on about three occasions and the last time he saw GLOVER at his son's residence in Meadville was about eight months ago when GLOVER visited his son and his family.

HESTER stated that he and his son had talked about the bombing of WHARLEST JACKSON and his son professed to have no knowledge regarding this crime.

HESTER stated he would encourage his son to tell the FBI everything he knows about GLOVER but he added he doubts that his son will talk to the Agents because he knows very little about GLOVER.





RALEIGH JACKSON GLOVER was recontacted at the residence of his stepson, JAMES E. WATTS, who resides at 134 Lee Avenue, Vidalia, Louisiana. GLOVER was advised as to the identity of the Agents by SA BENJAMIN F. GRAVES. He was advised he did not have to furnish any information and any information he did furnish could be used against him in a court of law. He was advised he could contact an attorney prior to furnishing any information.

When GLOVER was first contacted and asked if the Agents could talk with him a few minutes, he said "Hell, its about time; you have talked to everybody else."

GLOVER denied having any knowledge regarding the Silver Dollar Group or the fishfry which was held at which the residence of JAMES FREDERICK LEE in Wildsville, Louisiana, in the Summer of 1965. GLOVER was advised o that the Agents had heard that he had given a number of silver dollars to various individuals and he denied giving any silver dollars away, stating that he was not that

his only comment was "You cannot tell me one person I have sold an automatic carbine to." He would not even discuss the matter regarding his ever possessing a .30 caliber carbine.

He denied having any connection with, or knowledge of, the bombing of WHARLEST JACKSON and he stated he thought Negroes were responsible for JACKSON's death, pointing out that the Negroes had made certain gains at the Armstrong Tire and Rubber Company since this crime m occurred.

At one point during the interview GLOVER commented En that he did not want his wife, who resides in the Kentwood, Louisiana, area, interviewed again by Agents of the FBI. "He stated his wife is ill, which is the reason she now - resides in that area. He pointed out that his wife's S relatives live in the Kentwood area.

During the interview it was discussed by GLOVER that possibly a "nut" had been the perpetrator of this crime and he concluded the interview by telling the Agents to keep looking for that maniac.

It is to be noted that Mr. and Mrs. JAMES WATTS ---- were present during the above interview.





Mrs. BARBARA WATTS, wife of JAMES E. WATTS, the stepson of RALEIGH JACKSON GLOVER, was interviewed at her residence at 134 Lee Avenue, Vidalia, Louisiana. It is to be noted that Mrs. WATTS joined the interview when the Agents were interviewing her father-in-law, RALEIGH JACKSON GLOVER. Mrs. WATTS inquired of the Agents as to why she had never been contacted regarding the allegation that the stolen portrait of JEFFERSON DAVIS and explosives supposedly had been stored at her residence in the past. Mrs. WATTS was advised she had not been contacted at the request of her husband. She was advised, since she had brought the question up, did she have any information regarding these items being stored in her residence, and she replied in the negative.

Mrs. WATTS was asked about the .38 caliber pistol which Agents had located in the attic of her home when her husband gave the Agents permission to search it for the portrait of JEFFERSON DAVIS and the explosives. Mrs. WATTS commented that she had no knowledge that the pistol had been stolen. Mrs. WATTS commented that SAMMY WOOD had

told them that he had taken the pistol off of a drunk.










LEONARD stated that in his visits to the residence of ELDEN HESTER and his father, ODIS HESTER, he has not observed a Ford tractor on either of these individuals' property. He stated that an old worn out tractor is in the barn of ODIS HESTER. He is of the opinion this tractor has not been used for a number of years.

LEONARD stated that ELDEN HESTER has an Allis Chalmers tractor which he purchased new in the Spring of 1967. He stated that the type of bush hog which would fit on the power takeoff on a Ford tractor would not fit on this Allis Chalmers tractor.

He stated that he had never seen a bush hog on the property of either ELDEN HESTER or his father's property and he had never known either of these individuals to use a bush hog.

LEONARD stated he will recontact HESTER at the earliest opportunity in order to elicit additional information regarding GLOVER and this case.



Dear Sir:

I am writing this letter as an outraged citizen of Belmont, North Carolina, who has recently learned of the backing your organization has given to the local Ku Klux Klan organization in my home town.

'I refer to the Belmont Rifle and Pistol Club of Belmont, North Carolina, which I am sure you must realize is made up of Ku Klux Klan members. It is a National Rifle Association affiliated group, too - does this mean that the NRA believes in the Ku Klux Klan and that these are the "Americans" you want to have guns?

In the event you do not know - believe me, I do. The members of the Belmont Rifle and Pistol Club are all active members of the Belmont Klavern of the United Klans of America. The charter of this pistol club should be cancelled and any affiliation with your NRA should cease.

"I regret I must remain anonymous, but I know what would happen to me if I signed my name and members of the Klan learned who I was."

For your additional information, under certain circumstances the Director of Civilian Marksmanship of the U. S. Army furnishes rifles and ammunition to NRA-affiliated clubs, and this proposed new rifle club may be planning to take advantage of this assistance.

LEONARD stated that he treated one of HESTER's calves one night during the past week for diphtheria and the next morning, he went to HESTER's father's barn, which is located behind his father's house, and treated five other calves. He stated while he was in this barn, he noticed nothing unusual therein. He stated this barn has a hay loft and he did not have an opportunity to determine what was in the hay loft.

LEONARD stated that there is a small shack behind HESTER's father's house and he believed that this shack covered the water pump.

LEONARD stated that HESTER's father owns the house and property where HESTER now resides at Route Three, Meadville. He did not know of any buildings other than a small shack to the left of HESTER's house that is on this property.

LEONARD stated that during one of the conversations with HESTER while he was treating one of his calves, he commented he was going to lead a better life but did not offer an explanation regarding this comment.

LEONARD advised that he still desires that HESTER do some farm work for him and he will attempt to have HESTER perform this work at the earliest possible datazeand atenthate time, he will attempt to elicit any information which HESTER has regarding the bombing of WHARLEST JACKSON and his knowledge of RALEIGH JACKSON GLOVER. 

J. T. ROBINSON, Chief of Police, Natchez, Mississippi, stated he has known Officer JOHN HENRY of the Vidalia, Louisiana, Police Department casually for years. They are not close friends, but have been closely associated during the past five or six years since HENRY has been an officer. ROBINSON stated it had come to his attention that HENRY is acquainted with "RED" "JACK" GLOVER of Vidalia, and that he would attempt to learn the degree of association and particularily their extent of dealing in guns.

ROBINSON reminded the Agents that HENRY had C contacted him in Natchez earlier in the week, in the presence of SA CLARENCE G. PROSPERE, wanting information from ROBINSON as to whether or not he could legally possess an M-2 carbine which he had. ROBINSON told HENRY he would do some checking, but was confident an individual S could not possess such an automatic weapon. ROBINSON told the Agents he would stay in contact with HENRY and endeavor S in his own way to develop helpful information.

On May 27, 1967, ROBINSON advised he had on > the previous date called HENRY in Vidalia, told him he had talked with Alcohol Tax Unit Agents, which was not true, and learned the FBI was about to make a number of arrests in connection with illegal guns in the Vidalia area. HENRY told ROBINSON he had bought both of the above-mentioned guns from WEEKS, who had said he purchased them from a gun dealer at a gun show in Jackson, Mississippi. ROBINSON stated HENRY indicated he would like for ROBINSON to help him get his \$75 out of this carbine and suggested that maybe the City of Natchez would purchase it for the Natchez Police Department. ROBINSON indicated he would check on this matter. HENRY asked ROBINSON for a receipt for the carbine stating if the FBI questioned him about the whereabouts of the carbine he could show the Agents where it is located.

ROBINSON exhibited the carbon copy of the receipt given HENRY which reflects the following information:

ROBINSON discussed with HENRY about donation of the gun to the city whereupon HENRY stated he would not donate it to Vidalia as Chief SPINKS would take it to his home, where he has taken some four or five machine guns, and that the officers would not again see them. HENRY hesitated to donate the gun to the City of Natchez as he indicated he needed to get the \$75 he had invested in the gun.

In their discussion, ROBINSON asked HENRY if he E could convert a carbine. HENRY told ROBINSON he had not, but he had seen some converted, could study one that had been converted, and believed he could now convert one. From the over-all discussion with HENRY, ROBINSON stated he is inclined to believe HENRY had handled only the two carbines.

With reference to his association with GLOVER, HENRY has maintained to ROBINSON that he only drinks coffee with RED GLOVER on occasions, that he, HENRY, is in no way connected with any klan organization and wants to be a police officer this being the only reason he puts up with the pressures of Chief of Police BUD SPINKS.

On May 27, 1967, Chief ROBINSON made the above carbine temporarily available to the FBI for examination. It was subsequently returned to Chief ROBINSON by Agents. JN 4-4

On May 29, 1967, ROBINSON said HENRY had attempted to call ROBINSON several times that day, but ROBINSON was out of town until about 3:00 p.m. when HENRY came to his office in the police station. HENRY wanted to retrieve the carbine he had left with ROBINSON, stating that he had been talking to FBI Agents and wanted to turn the carbine over to them. ROBINSON stated he told HENRY he had removed the carbine from the police station, but he would get it and return it to HENRY.



Four copies of this report are being furnished to the Jackson Division in view of the request of Inspector JOSEPH SULLIVAN, in charge of the Wharbom Special, Natchez, Mississippi, in order to provide current background data relative to subject TAYLOR.

SHE WER The following information is being set forth in this administrative section due to the fact that it was the result of converstions between the informant and suspects in the Wharbom investigation. This information is being presented in this matter so as to avoid any possibility of the informant being compromised.

NO T-1 advised on 3/6/67, that in the summer of 1965, JAMES HORACE TAYLOR, JR. was invited to a fish fry at the home of JAMES FREDERICK LEE in Wildsville, Louisiana. At that time, JAMES HORACE TAYLOR, JR., who is also called "SONNY" TAYLOR, was a member of the Original Knights of the Ku Klux Klan, and the others attending the fish fry were the more "close-mouthed" tough members of this and other klan units. Among those attending was RALEIGH J. GLOVER, also known as "RED" GLOVER, from Vidalia, Louisiana.

At a time after the fish fry, GLOVER told TAYLOR that the fish fry was a cover for screening candidates for a new organization called the "Silver Dollar Group," and gave TAYLOR a silver dollar from a bag of silver dollars that GLOVER was carrying with him. This silver dollar had

a small hole drilled into the top, but no other markings. The date of the coin was 1886. GLOVER told TAYLOR the significance of the silver dollar was that the last two numbers in the date, in this case 86, were TAYLOR's numbers in the Silver Dollar Group.

GLOVER identified himself definitely as a member of the Silver Dollar Group, and so has JAMES HORACE TAYLOR, JR. and E. D. MORACE.

As explained by GLOVER, the Silver Dollar Group Z Z was composed of the toughest, most fanatical members of Fixed and Mississippi, who 'could keep their mouths shut." There were 52 of them originally, but GLOVER has advised they were reduced to a hard core of 20, seven of which "went underground."

PER About 16 days before the bombing of Wharlest Jackson in Natchez, on 2/27/67, "SONNY" TAYLOR, who lived in Harrisonburg, Louisiana, and was unemployed, E visited the home of RED GLOVER in Vidalia, Louisiana. He found E. D. MORACE there, and all three discussed information that GLOVER knew a man in Mississippi who He found E. D. MORACE there, and all three discussed the was associated with a Seismographic outfit in Mississippi, and "had his eye on" some type of seismographic explosives that GLOVER believed they should obtain. GLOVER indicated The might send TAYLOR over to Mississippi to see the NJ explosives man soon.

Two days after the meeting at GLOVER's house, GLOVER came to TAYLOR's home in Harrisonburg, and attempted to talk TAYLOR into taking a trip to Mississippi with him that night, hinting that he wanted to contact the seismographic explosives man. TAYLOR did not go.

NO T-1 advised on 3/20/67 that BILL BLANEY, a member of the Original Knights of the Ku Klux Klan (OKKKK) from Ferriday, Louisiana, has been associating with JAMES HORACE TAYLOR, JR. during the week of March 13 - 17, 1967. BILL BLANEY stated that he had burned the Two Mile Inn, north of Sicily Island, Louisiana, about one year ago. At the time BLANEY made the statement, he had been drinking heavily. BLANEY mentioned that in burning down the Inn, he had been shot at by unknown persons. BLANEY further made the remark concerning RED GLOVER, that if he caught anyone turning RED into the law, he would kill them.

NO T-1 also advised that RED GLOVER is known to possess an automatic Carbine, with a "banana" clip. This Carbine has been modified to fire on fully automatic, and the fire selector switch has been cut off by GLOVER, but he uses a knife blade to turn the switch to the automatic position. GLOVER has had this weapon for approximately four or five months, and he keeps the weapon at times in his home, but frequently keeps it behind the front seat of his pick-up truck.

NO T-1 advised on 3/29/67, that in approximately August, 1965, RED GLOVER contacted SONNY TAYLOR and told him that he had been accepted as a member of the Silver Dollar Group. E. D. MORACE is considered as the #2 man under GLOVER in this group and it is further believed that MORACE recruited BILL and GERALD BLANEY into the Silver Dollar Group.

NO T-1 further advised that, on one occasion in early 1966, GLOVER talked TAYLOR into accompanying him to the Woodville, Mississippi, area and said they were going to steal some guns from a Negro's home there. When they arrived, it was observed that the Negro was at home, and they did not attempt to steal the guns at that time. GLOVER told TAYLOR that they would return when the Negro was not at home; however, TAYLOR never went back to this

NO T-1 also advised that in connection with the arrests and alleged bailing out of TOMMIE JONES, who was NO T-1 also advised that in connection with the arrested by the Ferriday, Louisiana, Police Department on 6/26/65, SONNY TATLOR did not go to the Ferriday Jail after

NO T-1 advised on 4/22/67, that SONNY TAYLOR contacted RED GLOVER at GLOVER's residence on 4/18/67. TAYLOR told GLOVER that he had heard GLOVER had made 2 be careful of TAYLOR, in view of the fact TAYLOR had not been around for a few months.

At this time, GLOVER said that he trusted TAYLOR, but that if TAYLOR was coming back into the Silver Dollar Group, he could expect to be tested and would have to prove himself to members, as he had been out of their activities for a while. GLOVER, at this time, asked TAYLOR if he still had his silver dollar, and TAYLOR replied that he did.

During this contact on 4/18/67, GLOVER asked TAYLOR to go with him and help him move something. GLOVER said that he wanted to drive up to ELDEN "SCRAPMAN" HESTER's old home in Franklin Parish, Louisiana, to get some "stuff" that had to be moved. TAYLOR and GLOVER drove to Harrisonburg where TAYLOR left his car and rode with GLOVER in his pick-up truck to HESTER's home. During this trip, GLOVER took several evasive routes, stating he was trying to throw the FBI off in case they were following him.

Parish, GLOVER first searched the premises to make sure that the FBI was not watching, then asked TAYLOR to stand guard with GLOVER's sawed-off, double barrel shotgun in the yard. On arrival at HESTER's home in rural Franklin

In a short time GLOVER called TAYLOR into the house and into a back storeroom, where GLOVER had entered the attic of the house by removing a piece of wallboard, which appeared to be part of the ceiling.

WO DATE 3 GLOVER, from the attic, handed down four or five boxes to TAYLOR, one of which was an army ammunition box, and when TAYLOR opened the box and noted that it was filled with rice, GLOVER commented "don't look in the box and you won't know anything." After they loaded the boxes into the truck, TAYLOR asked GLOVER if the "stuff" they were carrying was mafe, and GLOVER said not to worry as it was safe as long as he put one of the boxes in the front seat and the other boxes in the back of the truck.

GLOVER had also secured from the attic eight or ten old shotguns, which GLOVER said were just of nigger guns," and placed these guns along with the boxes under a tarpaulin in the back of the pick-up truck. GLOVER also picked up several shovels, axes and tools, which he said belonged to the "SCRAPMAN" and indicated that he was going to take it all to him!

GLOVER further commented that the "stuff" had to be put away and saved for the future, as the man they had obtained it from, the Seismographic Company employee, had stated that he would not be able to get any more, as the company was checking on the seismographic explosives very closely.

NO T-1 advised that GLOVER stated on 4/20/67, that H had sold his house and was moving to Kentwood, Louisiana, where GLOVER has a small house about 12 miles east of Kentwood.

NO T-1 advised on 5/3/67, that JAMES TAYLOR contacted RED GLOVER in Vidalia, Louisiana, on 4/20/67.

At that time, GLOVER stated that he wanted to get all of the "boys" together in a couple of weeks, just to talk and plan strategy. GLOVER indicated that this meeting would be another "test" of the members of the Silver Dollar Group to find out who is furnishing information to the FBI.

During a discussion of the bombing of the Negro JACKSON in Natchez, Mississippi, TAYLOR asked GLOVER how the bomb in the truck was timed to go off some time after the truck was started. GLOVER stated that this was no problem, as you could hook up the bomb to a turn signal wire on the vehicle, and the bomb would not go off until the turn signals were used. GLOVER commented that if the wire was put on the right turn signal, then the bomb would go off when that signal was used and if the wire was put on the left turn signal, it would go off when the left signal was used. GLOVER also told TAYLOR that any time TAYLOR wanted a fully automatic rifle, GLOVER could aget him one.

NO T-1 advised on 5/10/67, that R. J. GLOVER contacted E. D. MORACE on 5/8/67 at MORACE's place of employment, in Ferriday, Louisiana. The two went to a cafe located next door to MORACE's shop and there met JAMES TAYLOR. TAYLOR was identified as a Silver Dollar Group member from Harrisonburg, Louisiana.

GLOVER had some mimeographed sheets of paper, which contained instructions as to what the klansmen should do when contacted by the FBI, and he gave several of these to MORACE and TAYLOR. GLOVER commented that they had nothing to worry about as long as they did not talk to the FBI.

NO T-1 advised on May 17, 1967, that TAYLOR drives a 1955 Ford, four-door sedan, dark blue in color, bearing 1966-67 Louisiana license 86 F 767.

II. AFFILIATION WITH KLAN OR OTHER HATE-TYPE ORGANIZATIONS.

NO T-1 advised on March 6, 1967, that in the summer of 1965, TAYLOR was a member of the Original Knights of the Ku Klux Klan (OKKKK).

NO T-1 further advised that TAYLOR was originally sworn into the OKKKK by MURRAY MARTIN of Winnsboro, Louisiana.

NO T-2 advised on March 17, 1967, that SONNY TAYLOR was a member of the Silver Dollar Group and TAYLOR was believed to live in the vicinity between Jonesville and Sicily Island, Louisiana.

NO T-1 advised on March 20, 1967, that JAMES TAYLOR is a member of the OKKKK. TAYLOR attended the fish fry that was held at the home of JAMES LEE in Wildsville, Louisiana, about one and one-half years ago, which was attended by approximately 20 known OKKKK klansmen.

NO T-1 further advised that the OKKKK unit at Harrisburg, Louisiana, has not been agtive for over a year and one-half. TAYLOR was identified as a former nighthawk of that unit.

NO T-3 advised on April 5, 1967, that SONNY TAYLOR has been named as a member of the Silver Dollar Group.

NO T-3 further advised that he had seen SONNY TAYLOR display a silver dollar, identifying him as a member of the Silver Dollar Group.

NO T-3 advised on April 13, 1967, that JAMES TAYLOR was observed at the fish fry of JAMES LEE in Wildsville, Louisiana, during June, 1965.

NO T-3 advised that, during the course of the fish fry, TAYLOR and JAMES LEE left LEE's residence in TAYLOR's truck and returned shortly after with a large stick of dynamite. The dynamite appeared to be about two feet long and approximately six inches in diameter, with an end that was very soft to touch.

TAYLOR cut up this dynamite into small pieces and, with a regular fuse, tried to ignite these pieces. Someone in the group, however, mentioned that the explosion might be heard, and TAYLOR did not detonate any of the pieces.

NO T-4 advised on April 11, 1967, that JAMES HORACE TAYLOR was a close associate of JAMES FREDERICK LEE, and is definitely a member of the Silver Dollar Group.

NO T-2 advised on April 25, 1967, that he did not know that JAMES HORACE TAYLOR was a member of the Silver Dollar Group.

NO T-1 advised on April 22, 1967, that SONNY TAYLOR assisted RED GLOVER in moving his household possessions to Kentwood, Louisiana, where GLOVER has a small house about 12 miles east of Kentwood.

NO T-1 advised on May 3, 1967, that SONNY TAYLOR was never a member of the Ferriday-Clayton, Louisiana, unit of the OKKKK and never visited a meeting of that unit. At one time, TAYLOR was visited by R. J. GLOVER and E. D. MORACE, and TAYLOR gave MORACE some tin to be used on the building that the Ferriday-Clayton klansmen were building to use as a hunting camp.

NO T-4 advised on April 25, 1967, that some time prior to June, 1965, SONNY TAYLOR was overheard to state that he had an ideal place to store explosives in a cave near his residence, south of Harrisonburg, Louisians

NO T-4 further advised that SONNY TAYLOR has not been known to possess any kind of an automatic rifle.

A characterization of the Original Knights of the Ku Klux Klan (OKKKK) is attached as the appexdix of this report.



A source advised on October 25, 1963, that an organization known as the Original Knights of the Ku Klux Klan (OKKKK) had been organized in the State of Louisiana at Shreveport, Louisiana, in December, 1960.

A second source advised that on August 12, 1966, that the OKKKK continues to be active within the State of Louisiana, and that the aims and purposes of this organization continue to be to promote Americanism, the supremacy of the white race, and the furtherance of segregation between the races.



ROBINSON stated he asked GLOVER if the FBI was still after him and GLOVER indicated the affirmative, commenting that he had not done anything. ROBINSON told GLOVER that the FBI had inquired about GLOVER's background and that ROBINSON had told the FBI that GLOVER was bad about drinking and fighting. GLOVER stated that he had heard as much and drove on. ROBINSON stated he has had no further contacts with GLOVER.





JACK MEYERS, Constable of Franklin County, Mississippi, and who resides in Eddiceton, Mississippi, advised he has known ELDEN GLEN HESTER for a number of years. He advised that he has no knowledge that HESTER is or was connected with any klan group.


MEYERS stated that HESTER and DONALD HOLLAND, who runs the feedmill in Meadville, Mississippi, would know each other quite well in view of the fact that they were reared in the same meighborhood in Franklin County and they at the present time reside in the same rural neighborhood. He stated he has no knowledge of any klan affiliation on the part of HOLLAND.

MEYERS stated that he did not know of any close association between these two individuals and BUFORD ASHLEY who also resides in Meadville, but he assumes that ASHLEY would know both of these individuals since all three reside in and around Meadville.

MEYERS stated he never knew HESTER, HOLLAND or ASHLEY to be in any type trouble and he had no additional information to furnish regarding these individuals.

He does not know RALEIGH JACKSON "RED" GLOVER an employee of the Armstrong Tire and Rubber Company. He stated he had no idea as to why M. D. CUPSTID would be in contact with GLOVER in Vidalia, Louisiana.


He advised that M. D. CUPSTID is his uncle who resides in the Cloverdale Subdivision of Natchez, Mississippi. He stated his uncle is about 55 years of age and is retired on physical disability from the International Paper Company. He stated that he knows M.D. CUPSTID to be a klansman because he has seen his robe and hood in the back seat of his car approximately nine months ago and, further, M. D. CUPSTID and Patrolman CUPSTID's father had a serious argument over M. D. CUPSTID's father to get his father to join the Ku Klux Klan. Patrolman CUPSTID stated that both he and his father are against the tactics of the Ku Klux Klanas well as its policies. He stated MD. and ROBERT, SR., have not spoken since the above argument. He did not know which klan

organization M. D. CUPSTID is a member of.

He advised that he would attempt to determine from his uncle his uncle's association with and knowledge of RED GLOVER.

Mrs. M. A. FORMAN, owner of Forman Market and Grocery Store, located on Louisiana State Route 565, Wildsville, Louisiana, was recontacted at her place of business. Mrs. FORMAN advised that JAMES FREDERICK LEE and his family moved into her two story house which is located next door to her grocery store in about May, 1965, and shortly after they moved in they had a number of individuals come to their house for a fish fry. She states she was not invited to the fish fry and she would not have attended had she been invited. She stated to her knowledge none of her neighbors were invited to this fish fry. She stated she did not know anyone who attended the fish fry and she did not know any of her neighbors who had any information regarding the fish fry. Mrs. FORMAN was shown photographs of MYRON WAYNE "JACK" SEALE, JAMES FORD SEALE and L. C. MURRAY and she

Mrs. FORMAN was shown photographs of MYRON WAYNE "JACK" SEALE, JAMES FORD SEALE and L. C. MURRAY and she stated she did not know these individuals, she did not know if they attended the fish fry at LEE's residence in the Summer of 1965 and she could not recall these three individuals coming into her grocery store on the date of the fish fry to make any purchases. Mrs. FORMAN was asked specifically if she could recall the above three individuals coming into her store on the day of the fish fry to purchase grease or lard and she reiterated she could not recall these individuals being in her store on the day of the fish fry or any other day.

She was asked specifically if she recalled finding a klan card in her store on the day of the fish fry and she stated that in the past she had found a klan card in her store, but she could not recall any specific time when she had xed found this card.

Mrs. FORMAN advised she does recall that on the JACKSON afternoon of this fish fry at LEE's residence two women who she assumed were in attendance at the fish fry came into her store and purchased some sun hats. She stated she

He continued that they planned to admit an unidentified FBI informant who would be restricted to only N the legitimate side of the chapter. Source advised that SCAROBOROUGH believed by doing this the FBI would have no reason to investigate it.

SCAROBOROUGH told source that he is going to write, or has written, a letter to the NRA Headquarters in Washington, D. C. to apply for authorization to form the new chapter, as well as to obtain the names of NRA members in the Mississippi -Louisiana area. Source believed that SCAROBOROUGH was going to pick members for the chapter from this list.
