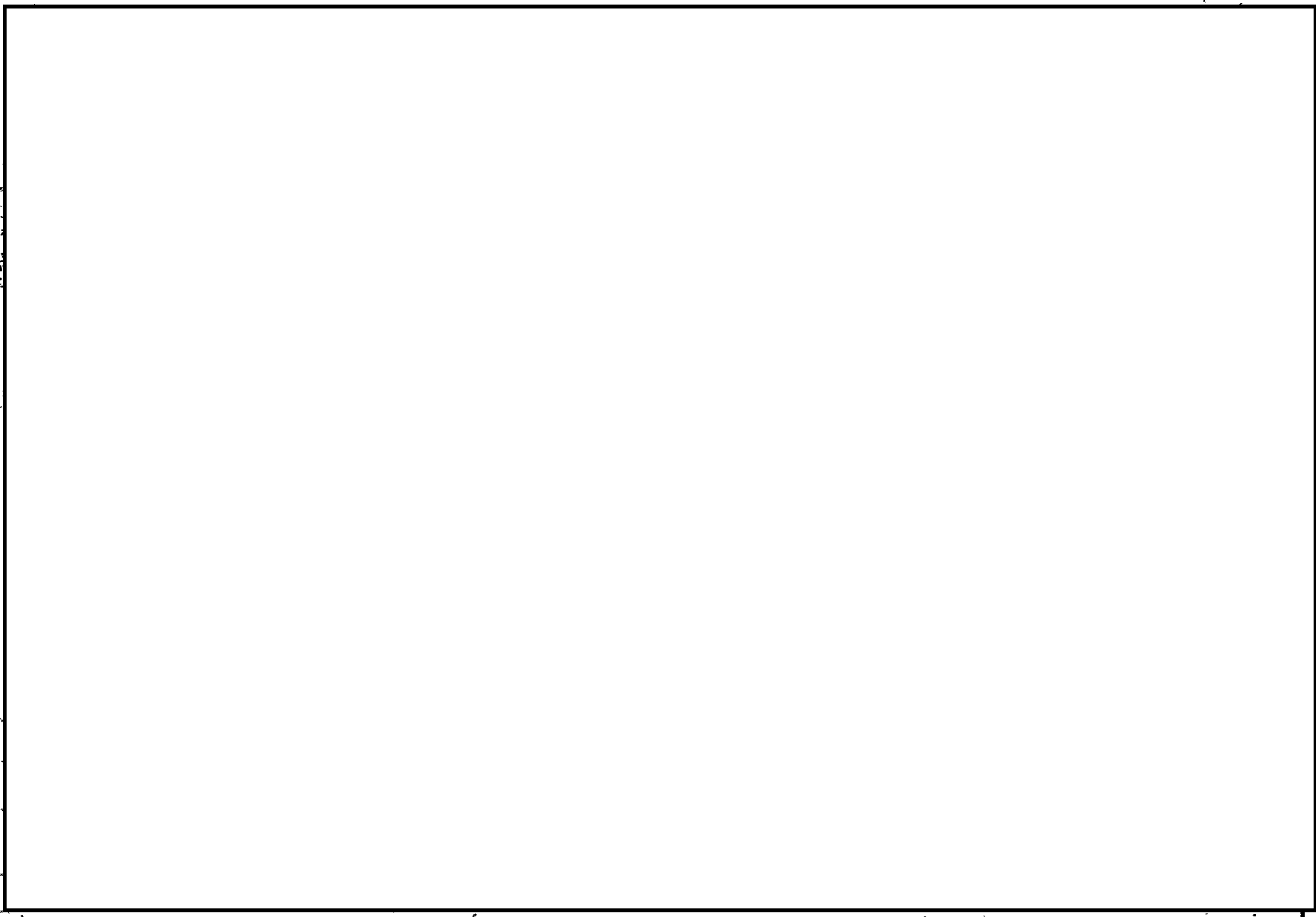

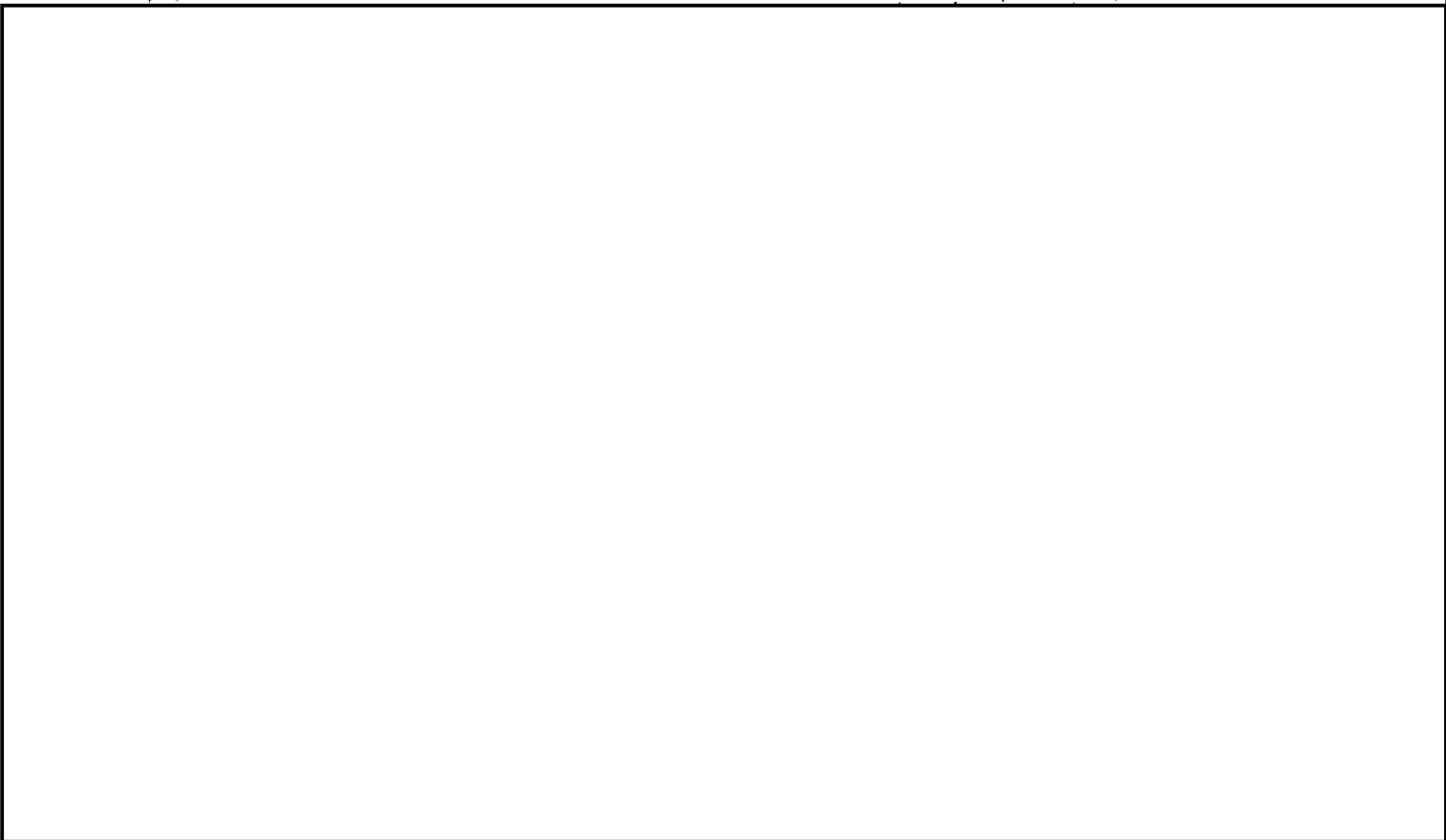

AT FERRIDAY, LOUISIANA

The following investigation was conducted by SA [REDACTED]

[REDACTED] Credit Bureau of Ferriday, advised that the only person listed in her files who could possibly be identical with THOMAS BARKER is THOMAS D. BARKER. He and his wife, [REDACTED] have been on file since December 11, 1963, when last checks. He was listed as age 50, residing at Route 1, Jonesville, Louisiana, retired and formerly in the restaurant business in California. He had three satisfactory accounts; one in Bank of America, Indio, California; one at Sears and Roebuck, Indio, California; and one at Catahoula Bank in Jonesville, Louisiana, where he had a six figure loan being paid as agreed. He also had an \$18,000 annual note at First Federal of Winnfield, Louisiana. She said he personally is unknown to her and that she recalls no BARKER living in the Ferriday, Louisiana area now or in the past several years.
