JAMES BUFORD GOSS was contacted at his residence. Before conducting any inquiry, he was furnished a statement of his constitutional rights and he executed a waiver of his rights. He advised that he did not desire to contact his attorney, JACK KAPLAN, in connection with this interhis attorney, GOSS furnished the following signed statement:

JAMES LEASS JAMES RECEISS "Bossier, City, La. JAMES RECEISS "November 28, 1967

"I, James Buford Goss, make the following free and voluntary statement to Henry B. Britton 3rd and Merriman D. Diven who have identified themselves to me as Special Agents of the Federal Bureau of Investigation. I was presented with a form setting forth my constitutional rights. I know what my rights are and voluntarily waived these rights by signing a waiver. I do not wish to consult my attorney, Jack Kaplan, at this time.

"I reside at 3236 Sarah Street, Bossier City, 14. and was born on June 24, 1920.

"During the middle of 1964, I was told by Iona Perry, the registration clerk at the Shamrock Motel in Vidalia, Louisiana, that her co-worker, a Negro porter by the name of Joseph Edwards, had insulted her by grabbing her arm and kissing her.

"After hearing of this, I returned to the motel to locate Edwards and beat him up with my hands, but I was not able to locate him that night.



'The next day at the Concordia Parish Court House, I saw Chief Bud Spinks and told him of the incident, although Miss Perry had requested me not to report the matter to the police.

"Bill Ogden, a <u>Concordia Parish Deputy Sheriff</u>, was near when I told Chief Spinks about the incident. Later that day, he came to me and asked what the incident was all about. I told him about Edwards' kiss of the crippled girl. Ogden stated that "they" would take care of it. He did not indicate who "they" were nor what "they" would do. I assumed he meant the Sheriff's Office would take some legal action.

"I was told by Iona the next time I contacted her that the police had contacted her, but she declined to press charges against Edwards.

"I did not see Edwards at any time after Iona told me of the insult. However, an unrecalled number of days later, I saw a <u>lt.</u> blue and white Buick, about a 1957 model, which someone unrecalled pointed out to me as Joseph Edwards' vehicle. "Sometime later, while I was in the King Hotel in the company of Richard Van Matre at a table when some unknown person at the bar stated that Edwards had gone to New Orleans via the river.

"A long time after speaking to Ogden about the matter of Edwards, I bumped into Ogden entering the Concordia Court House. Ogden said to me that I should sink my 'niggers' far enough out where fishermen could not hook onto them. I asked him what he meant. He said something like, 'You ought to know; you put him there.' Later, I heard from some unrecalled source that a fisherman had hooked into some flesh in the river.

'When I heard that Edwards' car had been found, I believed that maybe he had left town. After hearing that Edwards had gone to New Orleans via the river and the fisherman hooking onto some flesh I knew that someone had killed Edwards. I asked no questions as I did not want to get involved.

A long time after the disappearance of JOSEPH EDWARDS, at a time when there was much racial trouble in Natchez, Mississippi, he accompanied Chief BUD SPINKS, Deputy Sheriff JUNIOR HARP, and Deputy Sheriff FRANK DE LAUGHTER in the Vidalia police car on patrol in Natchez, Mississippi.

GOSS stated that JUNIOR HARP had been a former jailer in the Ferriday, Louisians, Jail. On one occasion, he observed a length of fire hose attached to a stick which was reportedly used to beat primoners. He was unable to furnish any specific incidents of such beatings. He further advised that JUNIOR HARP had a 1964 or 1965 white Oldsmobile which he used as a patrol car, after he became <u>Concordia</u> <u>Parish Deputy Sheriff</u>. Although he has no tangible reason for his suspicions, he is of the opinion that JUNIOR HARP may have been involved in the disappearance of JOSEPH EDWARDS.

Mr. GEORGE FENTON, Rel Air Lodge, Deer Park, Louisiana, was contacted at his residence and apprised of the identity of the interviewing Agents and the nature of the investigation being conducted, at which time he furnished the following information:

FENTON stated that he is in the air conditioning and heating business and his office is located at 449 Dory Street, residence address 325 Huron Street, in Jackson, Mississippi. FENTON stated that in 1964 and 1965, he had occasion to submerge a total of forty to fifty iceboxes in the vicinity of his railroad track and float them for the purpose of harboring fish. FENTON advised that prior to sinking the refrigerators, he would transport them from Jackson and leave them on the embankment in front of the bouse.

Specifically, upon review of a guest log maintained at the lodge, FENTON advised that the track is 200 feet long and that 25 feet from the end of the track center line and 25 feet south, 28 refrigerators were placed four abreast and seven deep parallel with the shore. A total of 28 were placed in this manner with an additional ten to twelve on the north side of the track.

FENTON advised that the water level in May of 1964 was 45 feet on the Natchez water gauge and during July 10 to 12, the water was sixteen to seventeen feet in the flats. FENTON advised that during the weekend of July 10-11-12, 1964, he and a Mr. and Mrs. G. H. HARRIS were at the lodge. He advised that the HARRISES stayed at night over at Jughead's in Deer Park and not at the lodge and added that he does not recall any unusual activity



FENTON stated that he was not knowledgeable of the disappearance of JOSEPH EDWARDS. He stated, however, that sometime during the Fall of 1964, he recalled hearing about the Sheriff's Department's boat being used at the lake and sinking during a storm while moored at Jughead's Landing.

JACKSON stated that she was acquainted with Mr. (First Name Unknown) RUSHING, a white man who had once been a former neighbor. She visited Mrs. RUSHING when they resided in the River Oaks Apartments. Mrs. RUSHING told her that she had stayed at the Shamrock Motel a short time before. Mrs. RUSHING stated that her child drowned at the Shamrock Motel swimming pool and JOSEPH EDWARDS attempted to save him, but slipped and EDWARDS would have drowned if Mrs. RUSHING had not helped him. Mrs. RUSHING further advised JACKSON that she went to school with Negroes and did not believe Negroes were inferior or discriminated against. Mrs. RUSHING is believed to have held EDWARDS in high regard for his life saving attempt.

Mrs. RUSHING further advised JACKSON that the incident occurred while they were on the patio of the motel and either she or her husband went to get some soft drinks. Each one thought the other was watching the baby. The unattended child was not noticed in the pool in time to save him. JACKSON stated that Mr. RUSHING worked in the oil fields. His wife is not known to have had any dates with other men, nor was EDWARDS known to have been intimate with her or arranged dates for her.

The RUSHINGS returned to their original home, which according to JACKSON's recollection was Arizona or possibly Oklahoma.

She stated that they are paid a very minimum salary and the bulk of their income is obtained through tips from the guest of the motel. She further stated that EDWARDS, as was the practice at that time, had a pass key to all of the rooms and as the porters frequently did at that time, would place the guest in a room different to which they were originally registered because the original room may have been uncleaned or for other reasons. telephone call from an unrecalled person advising her that EDWARDS had entered a room apparently thinking the room to be unoccupied. The complainant was not particularly angry over the incident, but had called her to make sure that he was properly registered to that room.

She stated that the motel has a total of 58 rooms for rental and it was her understanding that the registration records are retained by JOANN CROSS, the Shamrock's Bookkeeper for a period of three years. Miss DUNLAP stated that she would have Miss CROSS search the records for all the registered guests of the motel for July 11 and 12, 1964.

Miss DUNLAP stated that she knows of no Vidalia Police Officers who were dating any of the waitresses or other female employees at the Shamrock Motel and Restaurant.

With regard to CAROL POWELL, a former waitress, Miss DUNIAP stated that CAROL was obtaining a divorce during 1964 and may have dated some unknown person. She advised that FRANCES CUPIT was CAROL POWELL's best friend and was also in the process of obtaining a divorce. The only person CUPIT was known to be dating was NORMAN LONG, a service repairman at the motel.

She further advised that she had no knowledge that EDWARDS owned a vehicle, nor did she know of his possible indebtedness to the owner of the Shamrock Motel for the purchase of a vehicle.

POWELL had rented from Mrs. MC JUNKIN on the levee outside of Vidalia. As POWELL entered the house, an unidentified male told POWELL to stay away from the house. POWELL ignored him. When POWELL later left the house, there were two unidentified males sitting in a Chevrolet Ranchero parked a block from the house. One of then fired a shot at POWELL. POWELL then began firing at the two persons with a .410 shotgun. The two persons in the Ranchero then drove away and later brought assault charges against POWELL. POWELL obtained Attorney WALDEN to represent him, but the two persons who had been in the Ranchero later dropped their charges.

NEWMAN had gone to see one of his trucks that was hauling mud on Highway 15 below the Harris Plantation. He noticed CAROL POWELL on the side of the road. He stopped and discovered that she was having car trouble. He offered to give POWELL a ride to the Lewis Grocery Store in Vidalia where she was going to buy groceries. He drove CAROL POWELL back to where CAROL POWELL was living on Highway 15.

When they arrived at the CAROL FOWELL residence, CAROL POWELL's husband saw them in the car together and CHARLES POWELL came after NEWMAN with a chain and broke the windshield of NEWMAN's car.

NEWMAN stated that he drove away. In order to get back to his truck, NEWMAN had to drive by where the chain incident had taken place. NEWMAN took an employee named BILL WARD with him. On the way back to NEWMAN's truck, CHARLES POWELL passed by in his red truck and began shooting. WARD returned the shot with his revolver.

As a result of these circumstances, NEWMAN stated that he filed a complaint against the husband. The husband was never extradited from Mississippi. The husband later asked NEWMAN to drop the charges. NEWMAN refused to do so, However, the husband never bothered NEWMAN again, and NEWMAN

SCHUCKS stated that he is 86 years old. He advised that he spends much of his time hanging around the Shamrock. SCHUCKS advised that he had no knowledge of any prostitution activities around the Shamrock. He stated that he did not know if any waitress at the Shamrock had been insulted by a Negro employee in 1964. He stated that he did not know if any of the waitresses at the Shamrock had been

SCHUCKS advised that a cripple did work as a waitress at the Shamrock at one time, but he could not recall her name. He also stated that at one time a waitress named CAROL POWELL had a bad toe nail and was limping around for a short time.

SCHUCKS advised that he knew CAROL POWELL very well. SCHUCKS advised that several years ago (he could not recall the date) he was walking into the Shamrock Coffee Shop and saw CAROL POWELL. POWELL was crying. SCHUCKS was informed that POWELL's husband had just beaten her up and had taken her car away. SCHUCKS felt compassion for the girl and bought a car for her for \$200. A platonic relationship blossomed and eventually cost SCHUCKS \$7,000. Some of the money went for the purchase of another car (a Corvair), a down-payment on a trailer, payment of \$300 medical bill, \$100 Easter outfit, \$1,000 bank deposit in an account for POWELL to have money on hand should SCHUCKS pass away, a \$600 loan, and numerous other expenditures which SCHUCKS' could not recall.

IONA SEWARD, 417 Walnut Street, was advised of the personal and official identities of the Special Agents and of the nature of the contact.

Mrs. SEWARD advised that she is the former IONA PERRY. She is now married to MARION SEWARD.

She stated that prior to her present employment, she was employed as the PBX operator at the Shamrock Motel, Vidalia, Louisiana. She served in that capacity for approximately two months or more, ending her employment around the second week of July, 1964. She stated that her employment at the Shamrock was terminated at the request of MIKE MC DONOUGH, Gwner and Manager of the motel, because it was his opinion that the job was too strenuous for her impaired physical condition. Mrs. SEWARD advised that she has been wearing leg braces and using crutches since she was eleven years old. She stated that she had intentions of quiting her job at the Shamrock Motel prior to being terminated. This desire of hers to leave the Shamrock was in part due to an incident that occurred about two weeks before being terminated. On that occasion she had left the switchboard and was proceeding towards the restroom, when she encountered JOSEPH EDWARDS, a Negro porter at the motel. SEWARD stated that, "EDWARDS kinda got fresh. He grabbed me and tried to kiss me and I let him know I didn't go for this." EDWARDS pleaded with SEWARD not to mention this incident to anyone and he attempted to assure her that it would not happen again.

She advised that no one witnessed the incident and she had no recollection of mentioning the incident to anyone except to JUDY FORD, whom she described as her roommate at the time of the incident. SEWARD advised that Miss FORD is

now married to (First Name Unknown) PIGGOTT (phonetic) and is currently residing in Yazoo City, Mississippi.

Although she did not report the incident to the motel management or any law enforcement agency, she was contacted about the incident several days later by two or three police officers. SEWARD stated that one of the officers was wearing the uniform of the Natchez Police Department and may have resided in Woodville or Wilkinson County at one time. She stated that the other officer or officers were from the Vidalia Police Department.

SEWARD was shown a photograph of the Vidalia Police Department in 1964 which included left to right: JOHN HENRY, ALFRED HOLLAND, GEORGE TUNDLE, J. L. SPINKS, JOHNNY CROSS, ALLEN CROSS, and Mr. WILSON. After looking at the photograph, she pointed to the person in the center of the photograph and said, "I sorta say it was SPINKS".

The officers inquired as to EDWARDS' improper advances and advised her that EDWARDS would be taken care of. She does not know if any charges were lodged against EDWARDS and she has never been called to testify against EDWARDS concerning the incident. She further stated that she had heard of no information indicating that EDWARDS had disappeared.

SEWARD further advised that she knew of no illegal activities that EDWARDS may have been involved in, and except for the incident that she related above, EDWARDS performed his duties in a satisfactory manner. She stated that she had treated him courteously and had never given him any reason to approach her in an improper manner.

SEWARD stated that she was unmarried at the time, and that she does not recall whom she was dating at the time. She advised that at no time did she ever date any police officers.

"One afternoon I left my switchboard and was proceeding to the restroom. I encountered Joseph Edwards. As I passed by him, he put his arm around

> me with his hand on my shoulder. He attempted to kiss me on the lips, but I turned my head and his lips touched my cheek. I pulled away and let him know that I did not go for that. He said he was sorry. He asked me not to tell anyone about it. He said he would not do it again.

"I told my roommate, Judy Ford Pigott. I may have told my landlady also. Also I told James Goss who was a La. Probation Officer who stayed at the Shamrock almost every Thursday. James is 6'6", 250 lbs., blond-grey hair, and often wore glasses. James denied ever being a member of any klan type organization. James usually carried a gun with him.

"A day or two after I told James about the incident, two or three men came one morning to my apartment at 300 Jefferson St., Natchez, Miss. One of the men was a Natchez Police Officer in his uniform." He was young and I later learned he was from Wilkinson County. A second man was a La. police officer. I don't remember if he was in his police uniform. I think his name is Spinks. There may have been another person with them. If there was another person with them, I do not know if he was a police officer. I did not see what kind of car they were driving.

"Someone (I don't know who) had told them what Edwards had done. They wanted to know what happened. I told them and they left.

"Perhaps a week later I was still working at the Shamrock. One day as I had just begun working at 2:00 p.m., the desk clerk named Diane, who I was

In addition, SEWARD provided the following information which was not put into the signed statement inasmuch as SEWARD had to go to work and there was insufficient time to incorporate this information into the signed statement.

SEWARD advised that she had withheld the information that she had told JAMES GOSS that EDWARDS had tried to kiss her because GOSS was married when SEWARD was dating him. SEWARD advised that she did not know that GOSS was married when she began dating him. SEWARD advised that GOSS was working out of Tallulah, Louisiana, at the time GOSS was dating SEWARD in 1964.

SEWARD advised that she did not know if the name of the Natchez Police Officer who came to her apartment after the EDWARDS' incident was (First Name Unknown) GLENIS.

SEWARD advised that a short time after SEWARD had informed GOSS of what EDWARDS had done, SEWARD asked GOSS if GOSS had reported it to the police. GOSS replied that he had not done so, but that SEWARD's failure to report it had caused EDWARDS to brag about it and that is how the police found out about it. SEWARD stated that SEWARD told GOSS that SEWARD did not want GCSS to make any trouble. GOSS replied that the line will be so long that GOSS would not be able to get a shot at EDWARDS. SEWARD continued to date GOSS after that. At no time did GOSS ever indicate that he had done anything to EDWARDS nor had anyone else done anything to EDWARDS.

She advised that she stopped going with GOSS when she found out that he was not single as he claimed.

SEWARD advised that she did not know that EDWARDS was still missing. SEWARD stated that EDWARDS had once indicated to her that he could do better financially in New Orleans and that EDWARDS was thinking about leaving the Shamrock.
