ADMINISTRATIVE:

All persons contacted during the course of this investigation were advised that the inquiry was being made at the specific request of JOHN DOAR, Assistant Attorney General, Civil Rights Division, U. S. Department of Justice.

The investigative period of the instant report overlaps the period of the referenced report in that some FD-302's were not available at the time of the preparation of referenced report.

Only one Agent conducted some of the interviews set forth inasmuch as another Agent was not immediately available and this investigation required expeditious handling.

The indices of the New Orleans Office contained no reference to JAMES B. GOSS, except a subject case file entitled "JAMES B. GOSS, Aka James Buford Goss, WA, 58127AB, AEA - E," Bureau File 116-346063, New Orleans File 116-14323. A review of that investigation shows no unfavorable information concerning GOSS.

The following investigation was conducted at Shreveport, Louisiana:

On September 21, 1967, Chief CLINTON L. WINGFIELD, Armed Forces Examining and Entrance Station, 702 Texas Avenue, advised SA THURMAN P. EDITH SNYDER, a school teacher who resides across the railroad tracks from Dixie Lanes, a bowling alley located on the Vidalia - Ferriday Highway, Star Route, Ferriday, Louisiana, advised as follows:

She did not observe a 1958 green and white Buick pulled over one night during July, 1964, by a vehicle with a flashing red light; however, she recalled seeing a Buick fitting that general description parked at the north side of the Vidalia - Ferriday Highway opposite the bowling alley about that period.

This car remained there for about two weeks. Later, she observed that the car had been moved to the side street next to the bowling alley where it remained a few days. She did not see anyone move the vehicle and did not know the reason for its presence in the area.

On one occasion, he had a woman with him, whom GOSS introduced as his wife. She was attractive, had dark hair--but not a brunette, and was about five feet six inches tall with a heavy build.

KEATHLEY did not know GOSS to be dating the crippled registration clerk at the Shamrock Motel nor PAULINE BROWN, a cleaning woman at the motel. GOSS was known to be friendly with Deputy Sheriff FRANK DE LAUGHTER and they used to go around to the various "joints" together.

With regard to Chief of Police BUD SPINKS, Vidalia, Louisiana, Police Department, KEATHLEY did not know of any close associates of SPINKS who did not have a good reputation. SPINKS was known to have used a camp owned by several men from Shreveport, Louisiana, at NOWLAND SIMPSON's Red River Camp.

This vehicle was leased to the town of Vidalia, Louisiana, for use as a police car. Delivery was effected about October 15, 1963, and this vehicle was traded during October, 1964, for a 1965 model Oldsmobile. The repair records for that vehicle are no longer available, but if a red emergency light was installed on top of that vehicle, the Town of Vidalia purchased the extra equipment and in all probability obtained the item from Penka Parts, Inc., Natchez.

EDWARD RAY WILSON, 804 Morgan Avenue, was contacted and advised of the identities of the interviewing Agents. He provided the following information:

WILSON stated that he has been employed as the night clerk at the Shamrock Motel, Vidalia, Louisiana, from October, 1957, to the present. His working hours are from 9:00 p.m. to 7:00 a.m. seven days a week.

WILSON stated that he did not recall a Negro porter named JOSEPH EDWARDS who was employed at the Shamrock in July, 1964. WILSON stated that he recalled that IONA PERRY worked at the Shamrock for a short time in 1964. WILSON stated he did not know if EDWARDS had ever insulted PERRY. WILSON could not recall any other information concerning PERRY.

WILSON stated that he had no knowledge concerning any prostitituion activities at the Shamrock. WILSON stated that he did not know RED GLOVER, HOMER BUCK HORTON, KENNETH NORMAN HEAD, or JAMES GOSS. WILSON stated that he did not know about any date that EDWARDS thought he was going to have with a white girl.

The following investigation was conducted by SA ERNEST A. SERENA in Natchez, Mississippi, on September 7, 1967:

Reverend HENRY RUSSELL, 907 North Pine Street advised that he was unfamiliar with either the names JOSEPH EDWARDS or (first name unknown) BLANTON. He said that he did not recall whether or not he had seen (FNU) BLANTON on the televised civil rights hearings from Jackson, Mississippi, in February of 1965 but that Mr. WEST, who operates West Funeral Home, Natchez, had testified at those hearings and he might be able to further identify (FNU) BLANTON.

GEORGE F. WEST, 411 North Pine Street, advised that he knew no one by the names of JOSEPH EDWARDS or (FNU) BLANTON. He said that he had testified at the civil rights hearings in Jackson in 1964 but he did not recall anyone who had been beaten and given castor oil, who had also testified. The only man who testified whose name resembled BLANTON was WILEY A. BRANTON, an attorney from Pine Bluff, Arkansas. WEST advised that he was certain that BRANTON had not been involved in any beatings that took place in Natchez.

ARCHIE CURTIS, 106 East Franklin Avenue, advised that he did not know anyone by the name of JOSEPH EDWARDS or (FNU) BLANTON who had been victims of Klan violence in 1964. He said that he vaguely recalls having been informed of the incident involving a boy from the Shamrock Motel but is not familiar with any of the details.

CURTIS advised that DAVID FLEMING, 17 Bishop Street, was a commercial painter who might be able to identify (FNU) BLANTON.

DAVID FLEMING, North Pine and Purnell Streets, advised that he was a painter by trade, specializing in remodeling antebellum homes in the Natchez area. He said that for this reason, he works with a small, steady crew and is not acquainted with many of the transient painters who come into the area. He said that he did not know a painter by the name of BLANTON.

He said that he did not have any specific knowledge concerning any painters who had been in trouble with the Klan but that about three months ago, he had heard some of the men he works with discussing the fact that a painter had gotten into trouble with the Klan and had to leave town. He said that he could not recall who had been discussing this incident but advised that he would "ask around" and notify the FBI if he discovered anything.

FLEMING advised that a former partner of his, FRANCIS RAWLINS, Nine' Railroad Alley, was also a painter. He said that RAWLINS ran a large crew of painters and specialized in production work. He said that any itinerant

painters who came into this area would almost certainly contact RAWLINS. FLEMING advised that he would contact RAWLINS and find out if he had ever employed a painter who had been a victim of Klan violence or if he was familiar with anyone named (FNU) BLANTON.

FLEMING advised that he had heard of the incident concerning a Negro man who worked at the Shamrock Motel but could add nothing specific. He said that he had never heard the name of the man mentioned and that the name JOSEPH EDWARDS was totally unfamiliar to him.

FLEMING advised that he knew of several families named BLANTON living on Old Woodville Road near the Cloverdale housing development. He said that to his knowledge, none of them were painters nor had they been involved with the Klan.

Deputy Sheriff, Adams County, would get her anything she wanted. She claimed that HERNANDEZ had bought for her a used car and gave her \$100 on several occasions.

WALKER stated that HERNANDEZ apparently set out to get WALKER's job for THAMES and he, accompanied by some unknown white males, would follow her after work. Other unknown white males in old cars would follow her from the Shamrock and call her vile names. She frequently attempted to lose them by going to the post office and other places before going home.

Deputy Sheriff HERNANDEZ drove an unmarked white Oldsmobile patrol car with the usual police-type radio antenna but without a red light on the top. He frequently visited THAMES at the motel and also dropped off other men who spent considerable time with THAMES.

EDDIE, whose last name is unknown, an elderly Negro, was employed at the Shamrock Motel as a porter. EDDIE advised her to keep the room next to the motel office until all the other rooms were filled. He explained that the room had a bad spot on the rug and was unsightly. She noticed that EDDIE was very solicitous of unescorted men and handled his duties with couples very quickly. +9095-2H-Mh :

About two days before she quit her position at the motel, she noted that the storage room adjacent to the registration office had removable shelves which permitted entrance into the first motel room which EDDIE had advised had the soiled rug.

WALKER advised that she was personally acquainted with NELLIE JACKSON, who operates a house of prostitution in Natchez, Mississippi. On a number of occasions, JACKSON and EDDIE were in telephonic contact. On one occasion while EDDIE was working, JACKSON was observed to drive through the service entrance of the motel and drop off two white girls. WALKER did not know either of these girls.

ROBERTA C. WALKER, Eleven Oak Lane, Post Office Box 42, Natchez, Mississippi, viewed a group of photographs exhibited to her. She stated as follows concerning the respective photographs.

JAMES FORD SEALE - EDWARD J. FOLEY, Realtor, with an office in the Fry Building, told her that JAMES SEALE is a friend of RAY HUDNALL. She said that SEALE was observed in the vicinity of her residence on several occasions.

THOR LEE TORGERSEN - She used to see him come into the Shamrock Motel. She does not know his associates. According to JOHN C. SMITH, a guard at International Paper Company, Natchez, currently residing with his mother at Smith's Convalescent Home, Pine Street, Natchez, TORGERSEN is "a no-good son of a b ---- who is killing people."

WALKER advised that SMITH invited himself to her house for coffee on one occasion. She became alarmed when he knocked on her front door and telephoned Sheriff ANDERS. ANDERS told her that SMITH was harmless. Later, SMITH received anonymous threats to stay away from WALKER.

MYRON WAYNE "JACK" SEALE - Mississippi Highway Safety Patrolman REX ARMISTEAD advised her that SEALE was no good. JOHN SMITH also talked in a derogatory fashion about SEALE.

JOE DANIEL HAWKINS - WALKER stated HAWKINS used to park in front of her home in an attempt to intimidate her. WALKER advised that her son, TONY, heard from his Negro playmates that HAWKINS is supposed to have fathered a child by a Negro woman.

His brother then passed a white man who was going to the same room who did not notice his brother. After his brother was proceeding back to the desk with that "something," the white man came out of the woman's room and stared at his brother. His brother proceeded to the desk and never returned with that "something" that the woman had requested and shortly thereafter, went off duty.

EDWARDS stated that at the time his brother disappeared, his brother was dating a Negro woman named LILLIAN LEE and that LEE supposedly saw his brother on or about the night his brother disappeared. EDWARDS stated that LEE presently lives in New Orleans, Louisiana, and that LEE's father is JIM LEE, who drives a school bus in Ferriday, Louisiana.

EDWARDS stated that a WILLIE (last name unknown), who presently lives across the railroad tracks from the Handy Stop on the road to Ferriday, Louisiana, inquired about his brother's whereabouts after his brother had disappeared. EDWARDS told WILLIE that his brother was still missing. During the course of their conversation, WILLIE (last name unknown) indicated that he and EDWARDS' brother had worked together at the bowling alley just before EDWARDS' brother disappeared.
