> Surviellence was instituted at 4:30 pm and maintained until 6:15 pm. First automobile arriving at about 4:51 pm was white Ford Sedan '64 modèl, license unknown with one male. He was joined by yound w/m about 30, 5'8-10"; 165 with light brown hair. He came from the rear of Primos and got in the automobile with unknown male and they drove away.

The second car that acted suspiciously was a cream and brown '55 Chevrolet, license H-16411. This same young man spoke to theoccupant of this car. He drove around the block and parked and stayed parked near the entrance of the Primo parking lot. He was joined by another male for part of the time he stayed there. This license registered to Mrs. J. A. SHEARER, 3823 Northview Drive, '55 Chev., Ser # 048,7487 552.

Efforts to locate these persons at Holiday Inn Highway 51 North resulted negatively.

Another automobile that acted somewhat suspiciously was a '65 model either Chev or Pontiac, Black in color with one male occupant. The license number was 39-115. A check of records determined this license was listed to D. J. SANDIFER, Jayers, Miss. This information was obtained from Mary Turner, State MV Comptrollers Office. The semial # of the car was 41839S281493.

Fund Raising Activities

A confidential source, who has provided reliable information in the past advised that on March 24, 1965, he traveled to Brookhaven, Mississippi, and attended a meeting of the Board of Directors of the White Christian Protective and Legal Defense Fund. The meeting was presided over by Elmore D. Greaves, the State Chairman, and in attendance were: Harvey H. Heredeen, Secretary-Treasurer; Reverend Delmar Dennis, Meridian, Mississippi; I. H. "Pete" Shumaker, Kosciusko, Mississippi, and a Mr. Everett.

This meeting was scheduled for March 25, 1965; however, it was changed for some unknown reason.

A review of the organization's fund raising efforts indicated that a total of \$2700 had been collected thus far. Expenses indicated outlays of \$1000 for stamps and \$500 for miscellaneous items such as printing and advertising. This left a total balance of \$1200 in the fund. However, the source advised that this is in no way a complete collection report.

It was decided at the meeting to contact the County Chairman of the White Christian Protective and Legal Defense Fund to recall all the containers previously distributed throughout the state and make a formal accounting of the monies collected. The source indicated that the containers would, after the accounting was completed, be redistributed.

The directors then empowered Heredeen and Greaves to proceed to the aid of any 'White Christian" who may be فلمتراري الديسان

A confidential source advised an Agent of the Federal Bureau of Investigation in March, 1965, that an unverified rumor emong some Klansmen at Jackson, Mississippi recently was that the Original Knights of the Ku Klux Klan of Mississippi was reported to have hired a killer in 1964 to kill Martin Luther King when he was to be in Jackson, Mississippi during that year. This killer was allegedly a man known as "Two Jumps" and was from the State of Oklahoma. He went to Jackson, Mississippi, dates unknown, to "case the layout" and while in Jackson stayed at the Tarrymore Motel. He was to use a high powered rifle in the killing. The deal fell through when the Klan was unable to raise the \$13,000.00 cash demanded by "Two Jumps" for the job.

"Two Jumps" is the same individual who killed a person whose last name was Dillon and who was at the time on the Ten Most Wanted List of Fugitives of the Federal Bureau of Investigation. Dillon was allegedly killed in the Flamingo Motel in Jackson, Mississippi and his body was transported to either Oklahoma or Kansas where it was dumped in an old well.

"Two Jumps" was also allegedly hired to kill a burglar from the State of Texas sometime ago. This killing was to occur in Jackson, Mississippi but did not come off. It was rumored that the lawyers of the unknown burglar "paid off" the killer.

A source advised that on February 15, 1964, approximately 200 members of the Original Knights of the Ku Klux Klan (OKKKK) from the State of Mississippi met at Brookhaven, Mississippi. Those present decided to defect from the OKKKK and to form their own klan group in Mississippi to be known as the White Knights of the Ku Klux Klan of Mississippi.

This source advised that the aims and purposes of the White Knights of the Ku Klux Klan of Mississippi are to preserve Christian civilization, protect and promote white supremacy and the segregation of the races, to fight communism and to extend the dignity, heritage and rights of the white race of America.

APPENDIX

ORIGINAL KNIGHTS OF THE KU KLUX KLAN (LOUISIANA) (OKKKK)

A source advised on October 25, 1963, that in December, 1960, a group was organized at Shreveport, Louisiana, known as the Original Knights of the Ku Klux Klan (OKKKK). The purpose of this organization was to promote Americanism, white supremacy, and the maintaining of segregation.

This source further advised on October 25, 1963, that the OKKKK continues to be active and that the aims and purposes continue to be the same.

Mississippi Klansman Voices Opposition To LBJ Probe Plan

NATCHEZ, Miss. (AP) — A Mississippi Klan leader joined other Klan officials Sunday in voicing opposition to President Lyndon Johnson's push to probe the clandestine organization.

E. L. McDaniel, grand dragon of the United Klan, realm of Mississippi, said the President should urge legislation to rid the United States of Communists rather than attacking the Ku Klux Klan.

McDaniel asked:

"Could it be that Mr. Johnson sees that the Klan is standing in this way of being a dictator?"

He said the President should get on national television and warn the Communists that they should get out of the party before it is too late.

Johnson told a national television audience that four Ku Klux Klansmen were arrested by the FBI in connection with the fatal. shooting of a Detroit housewife who was driving civil rights workers from Montgomery to Selma, Ala.

After announcing the arrests, the President vowed to wage war on the Klan and urged anyone affiliated with the organization to "get out before it is too late."

A source close to the United Klan in Mississippi placed the present membership at about 400., There has been no comment from the white knights of the Klan, which is believed to have a larger nemoersmp in the state.

On March 28, 1965, a confidential source who is a member of the White Knights of the Ku Klux Klan of Mississippi (WKKKKOM) advised that on March 27, 1965, Tommie Beddingfield, another member of the WKKKKOM from Meridian, Mississippi, had made the following comment:

Beddingfield said that he had a letter in his possession which letter he had received from Raymond Roberts, younger brother of Alton Wayne Roberts, who is a defendent in the Neshoba County Civil Rights slaying case. In this letter Raymond Roberts asked Beddingfield to try and get as many Klansmen as possible from the Meridian, Mississippi, area and go to Atlanta, Georgia, on April 25, 1965. Roberts also wrote that Lester Maddox from Atlanta was arranging for a big march of Klansmen in Atlanta on April 25, 1965, to protest the march of Negroes and Civil Rights workers at Selma, Alabama.

Johnson Asks For Legislation Against KKK

WASHINGTON, (UPI)-President Johnson has declared an all-out battle to banish the Ku Klux Klan from American society.

Friday, he ordered Atty. Gen.-Nicholas Katzenbach to draft legislation bringing the Klan "undereffective control of law" and urged a prompt congressional investigation of its activities.

The chief executive did so in announcing the arrest of four Alabama men in the slaying Thursday night of Mrs. Viola Gregg Liuzzo of Detroit, a white civil rights worker, on a federal highway between Selma and Montgomery, Ala. He said the arrested men were klansmen.

The response on Capitol Hill. was swift. Rep. Edwin E. Willis, D-La, announced that his House Committee on Un-American activities would meet early next 'week to consider a formal inguiry into the Kian and other 'extremist'' groups. Committee investigators already have gathcred information on the Kian in Alabama and Mississippi and have conferred with the FBI, it was stated.

Rep. Emanuel Celler, D-N. Y., said his House Judiciary Committee would consider "with, all possible dispatch" any new criminal legislation dealing with the Klan.

It was not clear what legislation-Katzanbach might propose. There were indications diat_the Juštiće Department had just degun its work on a measure under Johnson's orders.

The president, who conferred throughout the night with the attorney general and PBI Director J. Edgar Hoover about the latest Alabama slaying, said Mrs, Liuzzo had gene to Alabama to serve what he called "the struggle for justicé."

Four Men Arrested

Fast moving FBI agents, perhaps operating with inside information, quickly rounded up the four Alabama men Friday and charged them in the slaying of Mrs. Liuzzo, the first white woman to die in the civil rights movement.

The President went before a national television audience to announce the arrests and personally identify the suspects as Eugene Thomas. 43, Bessemer, Ala.: William Orville Eaton. 41, Bessemer: Gary Thomas Rowe, Jr., 31, Birmingham, and Collie Leroy Wilkin, Jr., 21, Fairfield, Ala.

The chief executive was flanked by Hoover and Katzenbach at the hurriedly-arranged news conference_at_the White Hease.

WASHINGTON (AP) — The House Committee on Un-American Activities voted unanimously today to conduct a searching investigation into the activities of the Klu Klux Klan.

Chairman Edwin E. Willis, D-La., said the committee's preliminary study indicated "that shocking crimes are carried out by highly secret action groups with-'in the klans."

These groups, Willis said, arc known as "knockoff squads" or "holy terrors."

Willis also announced that the committee had instructed him to go on with his preliminary inquiry into activities of the Black Muslims, the American Nazi Party and the Minute Men.

The committee said its decision to throw the full light of a congressional investigation of the klan was based on three factors:

--Its staff's preliminary study "clearly indicated the klan activities are such that investigation is called for."

-Statements by federal officials indicating that klan members have been involved "in a number of recent murders and other unconstitutional acts of violence and terrorism."

-President Johnson's appeal last Friday in which 'he indicated support for congressional investigation of the klans as ar aid to enactment of remedia legislation." Craig Says KKK Will Fight LBJ

MONTGOMERY, Ala. (AP) — A Ku Klux Klan leader said foday the robed order would fight a presidential attack after four Klansmen were arrested on charges of federal conspiracy in the highway killing of a white civil rights worker.

"We're going to put President Johnson back on the spot — he has jumped on the white people of the South," said Calvin F. Craig, grand dragon of the Klan in Georgia.

Craig, reached in Atlanta, said the Klan's attorney was defending the four men.

They were arrested by FBI agents in the assassination of pretty Mrs. Viola Gregg Liuzzo, 39, a Detroit mother of five, Mrs. Liuzzo was shot to death Thursday night near Lowndesboro afier taking part in the civil rights march to the state capital.

President Johnson announced the arrests and then declared war on the Klan. He called for controlling legislation and congressional probes.

Craig followed the lead of Robert M. Shelton Jr. of Tuscaloosa, Ala., the imperial wizard of the United Klans, in denouncing the President's stinging verbal attack.

"I regret very much that this white lily, Mrs. Liuzzo was killed," Craig said, "And I hope and believe — that our men were not responsible."

Gov. George C. Wallace deplored the crime and announced an

.

all cut state investigation after the arrests.

Alabama may seek first degree murder indictments against the four arrested.

If the evidence warrants, "I'm going to insist that we get a first degree murder indictment, State Atty. Gen. Richmond Flowers said Friday night.

Mrs. Viola Gregg Liuzzo, 39, white and mother of five, was shot to death near Lowndesboro, Ala., while assisting in a civil rights drive.

Flowers said, "from what I've heard thus far, it looks like premeditated murder."

Conviction for first degree murder in Alabama carries either a death sentence or life imprisonment at the discretion of the jury.

The President announced the arrests in Washington, 16½ hours after Mrs. Luzzo, who grew up in the South, slumped over in the driver's seat of her car, a bullet in the temple

Selma Negro, Leroy Moton, 19, was beside her in the car when another auto pulled alongside and two shots were fired. The two were returning to Montgomery after shuttling a group of civil rights workers to Selma, She was en route back to pick up another group.

The four men arrested were Eugene Thomas, 42, and William Orville Eaton, 41, both of Bessemer; Gary Tommy Rowe Jr., 34, of Birmingham; and Collie Leroy Wilkins Jr., 21, of Fairfield, Ala.

The four were taken into custody by FBI agents in the Birmingham area. A U.S. commissioner set bond at \$50,000 each. Thomas, Eaton and Rowe were released several hours later when their attorney posted bond.

Wilkins remained in jail. He was convicted in federal court last November on a charge of possessing an unregistered shotgun, given a one-year suspended senergy and placed on probation for two years. R. Macey Taylor, an assistant U.S. district attorney, "Salt une four were charged with violating a 90-year-old federal statute for conspiring to deprive another person of his constitutional rights. Maximum penalty is 10 years in prison, a \$5,000 fine or both.

There were these other developments on the racial scene:

1. Seven policemen were treated at a hospital in Waterbury, Conn., after a street fight broke out in a Negro neighborhood when officers tried to make an arrest. Police said

they were called "segregationists" and other names by a crowd of from 150 to 200. Bottles and bricks were thrown at the officers.

2. Counties seeking exemptions from the proposed voting rights act of 1955 were promised full Justice Department cooperation. Atty. Gen. Nicholas Katzenbach told delegates of the National Association of Counties, meeting in Washington. "we want to make the burden on the counties as small as we can."

3. A boycott at Negro Jackson High School in Jonesboro, La. ended its third week with no solution in sight. The pupils are protesting what they called substandard facilities and courses. 4. Nineteen Syracuse University students asked Katzenbach for federal protection while in Jonesboro, La., helping recon-struct two Negro churches destroyed by fire Jan. 19. They plan to spend their spring vacation in the Deep South community. And Gov. John J. McKeithen of Louisiana said he will go to Jonesboro to try personal diplomacy with Negro students boycotting a school.

5. The House Committee on Un-American Activities probably will meet next week to decide whether it should launch, a formal investigation <u>of the Ku</u> Klun-Klan The four men the FBI said belanced to the Klan had little to say when brought before U.S. Commissioner Louise O. Charlton except "Yes m'am," and "yes, your honor."

The commissioner is a spry 76 and has had her office in Birmingham for 41 years. She wore a pink suit with a turquoise blouse for the bond hearing. A pink rose was stuck in her near-white hair.

Once when opposing altorneys disagreed over an arraignment date she told them, "Now, let's don't put this off forever and ever please."

She handed them a calendar and after brief discussion set April 15 as the date.

Wilkins, who was dressed in a dark brown shirt and black trousers, and Rowe who was neatly garbed in a dark grey suit and white shirt, objected to photographers taking their pictures.

"Get those damn lights out of my face," Wilkins told one cameraman.

Rowe, who has red hair, lunged three times at photographers, once forcing are EAU

agent to pash him lato a hastily opened door for a moment.

Another time when Rowe was ducking a comeraman he appeared to make a threatening gesture and said, "I'm fixing to bust one of them in the mouth." An FBI agent said, "Take it easy."

Some hours after completion of the bond hearings in Birmingham, a blue and white Teamsters Union plane arrived in Detroit with the body of Mrs. Liuzzo, wife of a union official.

prenks and mystic initiations in 1866, one year after the Civil War ended, the Klan soon turned to a major role in the overthrow of carpetbag state governments in the South and the restoration of white supremacy.

By 1871, the estimated 550,-600 Klansmen disappeared as a formal organization. President Ulysses S. Grant, under the Ku Klux Klan Act of 1871, suspended the writ of habeas corpus in nine South Carolina counties, and thousands of Klansmen were arrested.

Another Klan did not appear until 1915, when the organization was resurrected on top of Stone Mountain, Ga., with the burning of a cross and an oath of allegiance to the "invisible empire of the Ku Klux Klan."

By 1924, it had become a national political power, with four million members dedicated to opposing not only Negroes, but Catholics, Jews, and anyone who was not a native-born, Anglo-Saxon Protestant.

But, by the beginning of the depression, the Klan's power and glory were gone in the North and West.

The third Ku Klux Klan revival was organized in Atlanta late in World War II by an Atlanta obstetrician, Dr. Samuel Green. It had a brief period of activity, but splintered after Green's death in 1949.

Informant advised that on 3/9/65, he went to visit W. R. MANGUM, at which time he asked MANGUM to obtain for him 15 machine guns. MANGUM stated he could obtain these machine guns for \$150 a piece. Informant advised MANGUM that the price was too high and the informant then inquired if MANGUM could obtain for him .44 caliber ammunition. MANGUM advised that he could not obtain any .44 caliber ammunition and suggested that the informant contact members of the National Guard who have previously been successful in purloining ammunition from the National Guard Armorys.

Informant advised that at a meeting of Province and State officers of the White Knights of the Ku Klux Klan of Mississippi (WKKKKOM) in Jackson, Miss., on 3/6/65, the Klansmen first met at the Westland Plaza and were then led to a man's house. At this house, there was a large number of children in the family who were present in the room when an attempt was made to hold a meeting so it was decided to move to a second man's house who appeared to be a bachelor and whose house was located approximately five miles west of Terry, Mississippi. At this meeting on 3/6/65, there were approximately 20 or 25 individuals present. There were two men from Vicksburg, Miss., whose identity was unknown. MARK SANDIFER from Lawrence County, Miss., who operates a store near the Ruth Community, was present, together with another individual from Lawrence County, whose identity was not determined. (FNU) GREAVES, the secretary or treasurer of the White Christian Protective Legal and Defense Fund (WCPLDF) was present. The man from Gulfport, Miss., who operates a cleaning establishment and who has previously been identified, was at the meeting.

There were two guards who had walki-talkies and one of these guards remained inside the house while the other waited outside. These two individuals alternated on their assignments. Of those present were SAM BOWERS, JULIUS HARPER, BILLY BUCKLES, ERNEST GILBERT, CLYDE SEALE, and J. K. GREER. Informant advised that at this meeting on 3/6/65, SAM BOWERS told a story about his .44 caliber automatic being stolen in Meridian, Mississippi, and that later when two Negroes, whom he described as Black Muslims, killed a filling station attendant in Laurel, Mississippi, and were later caught and searched, a gun was found which was used to kill the filling station attendant and also found in possession of the two Negroes was a .44 caliber automatic of SAM BOWERS which had previously been stolen in Meridian, Mississippi. BOWERS stated that his .44 caliber automatic had been "planted" by the FBI in the car of the two Negroes.

BOWERS brought out at the meeting on 3/6/65, that he had not been paid for the past three State Meetings and advised that he had out of his own personal money spent \$1500 on Klan business.

In accounting of Klan money, it was discussed at the meeting and it was brought out chat \$3200 had been collected and approximately \$1600 or \$1700 of this sum had been spent for advertising.

It was also discussed that the bank has refused to handle any more of the money collected by the WCPLDF in that the bank has disassociated itself in every way from this fund. It was pointed out that money would continue to be collected at the post office box which had previously been furnished as the mailing address for the WCPLDF.

Informant advised that GREAVES, who is the treasurer or secretary for the WCPLDF, is keeping a record of all contributions and disbursements and that he reports directly to SAM BOWERS.

Informant advised that ERNEST GILBERT suggested that in view of the fact there had been a poor response to the letters sent to various businessmen in the State of Mississippi requesting contributions to the WCPLDF, that letters should be directed to the "plain country folks" asking for money and that these letters, after they were printed, should be purchased by various local units of the Klan which would then be responsible for addressing and mailing out these letters. Informant advised that

there was a discussion of the various units purchasing and selling stamps similar to Easter Seals which would have some designation on the stamp indicating that they had contributed to the WCPLDF. These stamps are to be sold to the various klaverns, who in turn will be responsible for the selling of these stamps to either Klansmen or individuals outside of the Klan.

BILLY BUCKLES, JULIUS HARPER and SAM BOWERS in a discussion brought out the fact that the Klan treasury presently has sufficient money to pay all Klan obligations but that after these obligations are paid, the Klan will have no money.

Informant pointed out that information has been received from numerous units that they are not contributing any more money to the State Headquarters as they feel SAM BOWERS is not giving a proper accounting for the money which has been collected.

ERNEST GILBERT inquired at the meeting if Klan money was to be given to help the individuals who had been arrested in connection with the murder of the three civil rights workers near Philadelphia, Mississippi. SAM BOWERS replied that it was not necessary for the Klan to furnish money to these individuals as the attorneys representing them had made the statement they would defend the defendants in this case regardless of whether or not they received payment for their services. BOWERS then stated the purpose of the WCPLDF was for propaganda purposes so that word could be put out by the Klan that the Klan presently has one million dollars to defend anyone in the State of Mississippi who is accused of a violent act.

JULIUS HARPER then advised the meeting that attempts were being to get the WCPLDF set up as a nonprofit organization in order to avoid paying Federal income taxes.

The informant advised that in a closed meeting the four State Officers, BILLY BUCKLES, JULIUS HARPER, ERNEST GILBERT and SAM BOWERS, discussed a proposed plan by SAM BOWERS to reorganize the White Knights of the Ku Klux Klan of Mississippi (WKKKKOM). The proposal of SAM BOWERS pointed out that the Communist Party is set up so that one communist does not know the identity of any other communists. BOWERS then proposed that Exalted Cyclops for each klavern be designated by him and that the Exalted Cyclops would then in turn choose four officers for his klavern. The four officers would not know the identity of any other officers other than the Exalted Cyclops. Each officer would then select three or four men to assist him but the officer who was in charge of the guards would not disclose the identity of the guards he had selected and in turn the guards would not know the identity of those individuals selected to assist the treasurer and so forth. Each member would then be allowed to choose four additional members who would not know the identity of any other members. Meetings would be held at which everyone attended in robes and was masked so that no one would know the identity of the other individuals. ERNEST GILBERT then pointed out to BOWERS that his plan was "ridiculous" in view of the fact there would be no control over the various individuals as the identity of the Klansmen in the unit would not be known and that anyone could commit any act of violence he desired and blame it on the Klan.

Informant advised that he had received information that ERNEST GILBERT, JULIUS HARPER and BILLY BUCKLES are presently investigating SAM BOWERS to obtain documentary proof with dates, facts and figures which will be presented at the next State Meeting in order to remove SAM BOWERS as Imperial Wizard of the WKKKKOM.

Informant advised that it had come to his attention that the individual who had put out the word about SAM BOWERS having pictures of MUSSOLINI. HITLER, KRUSCHEW and FIDEL CASTRO in his home was a Karate teacher who was

supposed to have been an informant of the Laurel Police Department. The Klan subsequently banished this individual from Klan membership when it was determined that he was an informant for the Laurel Police Department.

Informant went to the State Meeting at Jackson on 3/6/65, with BILLY BUCKLES and CLYDE SEALE. During the ride the informant asked about the Negro who was killed in Ferriday, Louisiana, at which time BUCKLES and SEALE mentioned the fact that the Negro who was killed in Ferriday operated a shoe shop which they named, but both of them only laughed and made no further comments about the burning of this Negro.

Informant advised that J. M. FOSTER has telephonically contacted him and the informant is of the opinion that FOSTER wants to arrange a trip between himself and the informant to go to Bogalusa, La., to repay the visit made by the Klansman from the 6th Congressional District of Louisiana.

Informant advised that in his contact with klansman he has come to the conclusion that the trouble in Selma, Alabama, and the speech made by President JOHNSON recently in connection with the Selma, Alabama, incidents, will drive people back into the Klan. Informant pointed out that some Klansman who have become inactive have told him that if necessary they would prefer to have martial law in Mississippi rather than subject themselves to the incidents which have occurred in Selma, Alabama.

Informant advised that the next State Meeting of Province Officers and State Officers will take place on Saturday, 3/20/65, in Jackson, Mississippi. The first meeting place will be in Westland Plaza, after which they will go to a designated place.

Informant advised that an individual who formerly was employed by the Lomax Printing Company in Laurel, which

has done printing for the Klan, went to work for a newspaper in Meadville, Mississippi. This man, name unknown, telephonically contacted SAM BOWERS and asked who he should contact in the Meadville area regarding participation in Klan activities. BOWERS told BILLY BUCKLES about this man and pointed out that he may be an FBI Agent but that if BUCKLES checked him out to be satisfactory, that BUCKLES could contact the individual and possibly use him.

The following bulletin was circulated in the residential section of Hattiesburg, Mississippi, by unidentified persons on March 21, 1965:

"ANOTHER WHITE KNIGHTS BULLETIN"

"The NAACP, The Communits, The COFO and other Jew backed subversive organizations now have a perfect stystem of infiltrators in your homes. Yes, at this very minute in the majority of South Mississippi homes is a trained agent of the anti-white, anti-American revolutionary conspiracy. Whitout apparently realizing the grave dangers involved, many white citizens take the nigger maids into their homes, to care for their innocent children and run their households while they work or engage in their social activities. "Only a few days ago, a family came home to a meal prepared by one of these nigger infiltrators, and were hospitalized due to some <u>substance</u> placed in their food by this nigger saboteur. Naturally, the nigger never showed up for work again and it was later learned, that the night before, she had attended an NAACP rally, where a Jewish speaker had worked the nigger audience into a frenzy of savage emotion with his anti-white propaganda. On March 27, 1965 a memographed leaflet consisting of two pages stapled together and rolled tightly together and secured by a rubber band, was distributed thoughout certain sections of residential areas of Hattiesburg, Mississippi by unidentified individuals. The leaflet was prepared on legal size paper. The first page was plain white paper, and the second page was of a color, other than white. The following information was typewritten on the two pages:

"Who are these people?

What people are you talking about?

157-63-884

"We are talking about the people that the <u>Jews</u> and their Communist dupes are trying to force the <u>white</u> people to intergrate into our schools, churches, swimming pools, parks, restaurants, homes and ever our <u>beds</u>. These are the people that will vote you <u>into</u> slavery and the Jew into mastery of the world.

"Now these people were originally known only in the darkest jungles of Africa. But then the jew saw a great opportunity for vast profits in rounding up' these helpless half-humans and selling them into slavery; especially in America. If tens of thousands of them died on route, it didn't matter to the jew, it only added to his overhead. Anyway there were millions more free for the catching. Sad? Well not to the Jew; be has dealt in human misery for centuries. Witness the brutal "prize" fights, organized gambling and prostitutuion, dops peddling, vulgar, obscene magazines and picture shows and the thousands of other sordid enterprises owned or operated by Jews.

"Now back to these people that the Jews and their brainwashed, bleeding-heart <u>helpers</u> want to cram down the white people's throats. Lets look at some of thir actions.

Her stomach had been cut open and the unborn child pulled out and beheaded.

They must control your chinking in order to control you. Think.

"To got the truth you must go out and find it. It will never be banded to you by the energy. Threa: are bundreds of books and phesphlets written by smart and patriotic people to expose the plans and activities of your energy. Hest of these are kept out of your public libraries. Who would do a thing like this? The Jewish-Communist conspiracy. Most of the books and writings mustlened above can be found in the Patriotic Book Store and information centors springing up all over the country. not he disseminated outside the Bureau, inasmuch as is still in a very sensitive and vulnerable position and has excellent potential as a criminal informant of this Division.

Informant was asked if he knew an individual named DONALD SPARKS or GENE SPARKS, to which he promptly replied, "Who, Two Jumps?" He was then shown a photograph of DONALD EUGENE SPARKS, Tulsa, Oklahoma Police Department number 38224, dated 9/7/63. Informant promptly identified this photograph of DONALD EUGENE SPARKS as being identical with the person he has known for many years as "Two Jumps." Informant then went on to relate that SPARKS got the nickname "Two Jumps" from his ability as a cowboy. According to informant, SPARKS was an excellent "broncho buster" and could ride almost any horse going. Informant considered SPARKS to be an extremely hard and tough individual who would not hesitate to kill anyone.

The informant then went on to state that "Two Jumps," together with a second individual, whom he knew as BOB JENKINS, MARTIN EDWARDS, LEROY MC MINNAN, and another individual known only as BUTCH, were all present in Jackson, Miss., during November, 1963 at which time they murdered top ten fugitive JOHN GIBSON DILLON, in a motel in Jackson, Miss., and then transported DILLON 's body to Oklahoma, where they dumped it in a well. According to informant, "Two Jumps" was present at the time of the murder, but did not actually do the killing. Informant was asked how DILLON was killed, to which he replied, "They blew his brains out."

Informant then rummaged through a pile of old papers and produced a Southern Bell Telephone Company "list of calls" for long-distance telephone calls billed to his telephone number at Jackson, Miss. Informant stated that the call made on 11/18/63, to Chickasha, Oklahoma,

number 405-CA4-6245, was to the home phone of DONALD EUGENE SPARKS, aka "Two Jumps." Informant then added on second thought the four phone calls made on 11/18/63 were pertinent. These phone calls were as follows:

11/18/63, New Orleans, Louisiana, 504-523-4471 11/18/63, Chickasha, Okla., 405-CA 4-6245 11/18/63, Moffett, Okla., 918-TR 3-9073 11/18/63, Moffett, Okla., """ 12/2/63, Vicksburg, Miss., 636-4551.

Informant advised that all of the phone calls made on 11/18/63, were made by the man he knew as BOB JENKINS, and were made to locate individuals to meet with him at Jackson, Miss. The calls to Chickasha, Okla., and Moffett, Okla., were made to "Two Jumps."

Informant was exhibited a photograph of RUBIE CHARLES JENKINS, which informant advised appeared to be identical with the person known to him as BOB JENKINS, except that BOB JENKINS now has grey hair and wears it crew-cut style.

The informant gave the following rundown of the individuals he believes were involved in the killing of DILLON:

The individual known as "BUTCH" is a resident of Tulaa, Okla., and is believed to operate a pool hall at Tulsa, Okla. He is not certain if "BUTCH" is identical with BOB JENKINS. "BUTCH" allegedly was the individual who actually murdered DILLON.

DONALD EUGENE SPARKS, aka "Two Jumps" is presently believed to be in the penitentiary in Oklahoma.

MARTIN EDWARDS, a former notorious bootlegger in Oklahoma, is presently serving a sentence at the State Penitentiary in McAllister, Okla. JN 157-63

LEROY MC MINNAN is presently serving a nine-year sentence for his connection with an automobile theft ring, as well as one year for harboring JOHN GIBSON DILLON at Levonworth Penitentiary. MC MINNAN was formerly of Wichita, Kansas.

According to the informant, the reason DILLON was killed was that he had told his attorney in Tulsa, Oklahoma, that he intended to "blow the whistle" on approximately 40 or 50 thieves, burglars, and holdup men to help get himself "off the hook." This information was purportedly relayed to another Tulsa, Okla., attorney who has the nickname of "CLARENCE DARROW." This second attorney in turn notified JENKINS or SPARKS, who then called the meeting in Mississippi, resulting in DILLON's murder.

During the interview, informant advised on several occasions that he considered "Two Jumps" to be an extremely hardened criminal who would resort to any tactics if the monetary gain was worth the risk. Informant considers SPARKS to be a pure and simple killer.

The possibility that "Two Jumps" SPARKS was propositioned to assassinate MARTIN LUTHER KING was not proposed to the informant; however, based upon the informant's assessment of SPARKS, it is felt that SPARKS is entirely capable and would be a logical person, by those who know him, to hire as a killer.

It is again pointed out that this information should not be divulged outside the Bureau unless it is appropriately paraphrased in order to protect the informant.

It is requested that all offices receiving copies of this communication advise Jackson immediately if any information is developed which would confirm the fact that DONALD EUGENE SPARKS is known to other individuals as "Two Jumps."

Re Jackson airtel to Oklahoma City, 3/23/65; Oklahoma City airtel to Jackson, 3/29/65; and Jackson airtel to Bureau, 4/2/65.

Jackson airtel to Oklahoma City requested investigation in Oklahoma to identify "TWO JUMPS." Results background contained in former case JOHN GIBSON DILLON (DECEASED) TOP TEN FUGITIVE, was furnished to Jackson in detail by referenced Oklahoma City airtel of 3/29/65.

For information of Bureau and Jackson complete background contained in case involving BILLON does not substantiate the allegation that DILLON was killed in Mississippi. It is highly doubtful that this is true. It is not known where DILLON was killed but suspected either in Southern Kansas or Northern Oklahoma due to the time elapse when he was located alive and later found with heavy iron weights tied to the corpse, which weights were stolen in the near vicinity where the body was found approximately two days after he was last known to be alive in Kansas.

Efforts continuing to attempt to identify "TWO JUMPS."

In March, 1871, Adam Kennard came to Meridian as a deputy sheriff to arrest some Negroes who had broken 1 a b o r contracts. He had neither credentials nor legal right in the case. But he persisted.

At night a disguised band, led by Daniel Price, white scalawag who had fled Livingston, Ala., waited on Kennard. They stripped him of clothes and money, whipped him, and shot and wounded him as he ran.

ASSAILANTS IDENTIFIED

"The law" stepped in. Kennard identified scalawag Price, white, as the mob leader. He also had some Negro members arrested. All were tried under the state anti-Ku-Klux Klan law.

Price had a record of trouble making - a convict pardoned serving a grand larcency sentence in the penitentiary, said to be a Confederate soldier who had deserted the Union Army, become a white living among the Negroes. He became circuit clerk of the county. Aside from his preaching agitation among the Negroes he "took up with a yellow girl" and "stayed with her like a wife." Feeling ran threateningly high and Price shook the dust of Livingston from his feet and settled in Meridian to become a member of the Radical political party in Lauderdale county After arrest Price gave bond for \$200 and skipped out of Meridian « Kenned's white frame

Alabama rode into Meridian Undisguised they caught the three Negroes Kennard would arrest and sent them back to Livingston. The white men then stacked their shotguns in the street and went to the hotels where they ate breakfast. After eating they gladly told the hotel keepers: "Charge it to the city." They were called Alabama Ku-Kluxers.

NEGROES STIRRED After that event, the trial of Price's Negro Klansmen was continued. Negroes stirred over the events called a mass meet-

ing. They were inflamed over Price's untimely desertion and over the high-handedness of the "Alabama white Ku-Klux" invading Meridian for three of their colored men.

In their rage, the Negroes decided to burn Meridian. After much hesitation over where to start, they fired a large building but the flames were confined to it.

Out of this fire came the arraignment of three Negro, leaders charged with arson and, disorderly conduct. One of the men was Warren Tyler who conducted his own defense. Tyler got in a fight with a white with ness who brandished a hickory cane. Tyler fied the courtroom but trees at the door and fired his piscol wildly. Judge Bramlette toppled on the beach and fell dead from one of Tyler's bullets.

BATTLE IN COURT

A courtroom battle broke. One of the three firebrand Negroes was wounded and when found not dead was heaved from the second floor balcony. Still he didn't die. But' he was carried back in the courthouse where his throat was fatally cut to finish him.

Tyler, who had killed the Judge, was caught and killed. The third arsonist got away and was chased by a posse train for 50 miles in Alabama.

Eventually this late "Ku Klux" outrage brought about the hooding of six whites under

As per your frequent requests, I am placing this mail in your hands for investigation in order that I may assist you in discovering the nature of what it is behind the Ku Klux Klan.

Mc Rae, our local postmaster requesting him to abstain from delivering all such mail to me and rather, place it directly in your hands. I feel that in this way I can best serve the interest of my country and that of myself in demonstrating that there is absolutely no foundation in fact to the malicious and ridiculous rumors which link myself with the Ku Klux Klan.

You may rest assured that I will continue to cooperate in every way possible with the qualified Christian American Patriots of the FBI in all matters pertaining to the well-being of our Republic. As a citizen, I sincerely appreciate the work which your organization has done in the past in tracking down the deadly communists who are destroying our country.

OPEN LETTER

March 29, 1965

TO: Senator James O Eastland, Chairman Senate Judiciary Committee Hon. Emanuel Celler, Chairman, House Judiciary Committee

Lyndon B. Johnson - Murderer!

As an extension of prior reports concerning the insanity of Lyndon B. Johnson, usurping president of the United States, I now indict him for the murder of Mrs. Vila Luizzo, in Alabama, with Rev. Martin Luther King, Jr., as accessory before and after the fact.

It was Johnson who, in conspiracy with King, master-minded the "march" on Montgomery; who set up the false slogans of "right to vote - one man one vote", to incite to internal rebellion, knowing that, through his own seditious actions, the right to vote has become a tragic delusion for all U.S. voters; who incited the rabble-rousing press to create the irrational hysteria which underlay the "march", which has continued since; who deluded the marchers into believing that solutions could be found in Montgomery, when law ful, constitutional action could under no circumstances be found there, but represented fun damental constitutional and economic changes; who created a situation of grave peril to the marchers, to all Negroes, to all Whites, to the State of Alabama and to the entire Unit ϵ States, through his irrational, deranged "March" programming disaster; who, when he finally realized the enormous dangers let loose by his acts in bringing into conflict two angry armed groups, attempted to throw the onus on the shoulders of Governor Wallace for protect ing the State of Alabama, the marchers, and the total citizenry of the state, by attempting to force him to mobilize the National Guard of Alabama in a tacit declaration of war agains: his own people, and against the people of the United States generally; who, when Governo Wallace refused to assume the illegal, irresponsible, impossible burden, himself mobilize the National Guard of Alabama and invaded the Sta te with US troops; who knew that should violences occur, a chain reaction of racial violence would follow throughout the United States on issues having nothing to do with the right to vote; who knew that one sharp-shoo er could shoot Martin Luther King from a distance of 1000 yards and thus light the fuse whic Johnson himself had laid, for a blood bath for the entire United States; who - a congenital coward - having set the stage for disaster, flew nonchalently off to his Texas ranch, shunning his own responsibilities, hiding from the explosion which he must have expected.

Murder was implicit in the situation, and became the obvious outcome. It was a miracle that only <u>one</u> individual was killed (one, incidentally, who should have known enough to keep away from Martin Luther King's battlefield of a seditious "war against the United States"). Thousands <u>might</u> have been slaughtered on both sides. This fact stands as a monument to the restraint of the marchers, the guards, and the people of Alabama.

Now this criminal Johnson, having set the stage and incited the murder by creating an explosive situation of violence which has been triggered by the acts of four men, declares war on them publicly for a crime committed in the White House, to create national hostility against them to prevent a fair trial (on the precedent of Lee Oswald, assassinated by the press of the United States for a crime committed by another), to murer them as he has already murdered Mrs. Liuzzo - the men not a <u>cause</u> of the murder, but an <u>effect</u> of the lawlessness of Lyndon B. Johnson; who now incites murder against the long-suffering people of Selma, victims of the Johnson - King conspiracy, selected as "whipping boy" to distract attention from Johnson's crime; who declares war against the Ku Klux Klan, an organization reduced to clandestine operations because, under Lyndon B. Johnson, law and order have disappeared in the United States; by creating a situation again leading to violences. This lent solutions based on LAW, will next order the use of so-called "non-lethal" gases against the people of Alabama as he has against the people of Viet Nam. His purpose? To defeat Governor Wallace as a candidate in the 1968 presidential elections NOW! the dirty, grievious, futile, murderous "March" launched as a political "gimmick" []]

The issue goes deeper. As I have warned, the incitement of Negroes to civil disobedience is part of a long range strategy of international forces of Wall Street - the Vatican - the Kremlin, to create national disunity, to give an excuse for overthrowing the Con-Stitution of the United States and establishing some form of dictatorship, or to weaken us for invasion. The logic of this premise is beyond dispute.

Racial problems have never been primarily an issue of color, but of economics, today as at the time of the Civil War. The irrational emotionalism of Uncle Tom's Cabin, of William Lloyd Garrison's abolitionism, of John Brown's attack on Harper's Ferry, is on a par with the foolish, purposeless, lawless hysteria of Martin Luther King and his equally foolish, irrational following among priests, preachers and rabbis in Alabama, which never touched the vital issues involved.

The greatest Negro "march" in History started at Fort Sumter in 1861, and ended at Appamatox in 1865 - four long, bitter years of mud, blood, murder, wasted resources, hatred, disunity - all ending in futility and defeat for both participants; the basic causees carried over one hundred years, still unsolved; still no recognition of <u>causes</u> to point the way to solutions; a tragic historic failure which must cause Lincolh's heart to bleed, wherever he may be.

Decision: Treason and murder in high places, under cover of fraudulent public power, must be, and shall be rooted out, not by executing four men in Alabama, victims of a vio-1041 bealed lent society incited from the White House, or by striking at the relatively insignificant blood numbers of the Ku Klux Klan, but by reaching out for the invisible and visible "prime movers nationally and internationally.

I demand the assured arraignment of Lyndon B, Johnson and Rev. Martin Luther King abode for the crimes of Treason and Murder, which they incited in Alabama, consummated in n i 🦿 their punishment by confinement in a penitentiary, or commitment to a mental institution.

This era of disobedience to LAW in high and low places shall end; justice under LAW shall be restored; a "new birth of freedom" shall take place; positive solutions which I have advanced for over 30 years, sabotaged by the rabble-rousing, seditious press, shall emerge under the aegis of the Constitutional Provisional Government of the United States. "It IsWritten!"...... unless catastrophe incited by madman Lyndon B. Johnson and his equally mad cohorts, nationally and internationally, moves too fast to be contained by programs of moderation under Constitutional Law.

In launching my own program of constitutinal "rights" for Negroes and all other citizens, I have designated as my staff representative for Negro affairs, Mr. Ali Timbel, an enlightened, spiritually oriented, inspired Negro of a kind not now found among the so-called Negro "leaders" who lead to disaster. Mr. Timbel is dedicated to law and order under the Constitution, recognizes the underlying causes of racial conflict, and will be my right hand in promoting the "Holdridge Plan For Everyone", as the solution for Negro<u>rights</u> and responsibilities. Thepeople of the United States will find this young man a refreshing change to positivity from the dismal negatives to which they have been subjected by non-Negro as well as Negro leaders in the dangerous racial controversy. He will be given ample opportunity to speak for himself.

ORIGINAL KNIGHTS OF THE KU KLUX KLAN (LOUISIANA) (OKKKK)

A source advised on October 25, 1963, that in December, 1960, a group was organized at Shreveport, Louisiana, known as the Original Knights of the Ku Klux Klan (OKKKK). The purpose of this organization was to promote Americanism, white supremacy, and the maintaining of segregation.

This source further advised on October 25, 1963, that the OKKKK continues to be active and that the aims and purposes continue to be the same.



APPENDIX

WHITE KNIGHTS OF THE KU KLUX KLAN OF MISSISSIPPI

A source advised that on February 15, 1964, approximately 200 members of the Original Knights of the Ku Klux Klan (OKKKK) from the State of Mississippi met at Brookhaven, Mississippi. Those present decided to defect from the OKKKK and to form their own klan group in Mississippi to be known as the White Knights of the Ku Klux Klan of Mississippi.

This source advised that the aims and purposes of the White Knights of the Ku Klux Klan of Mississippi are to preserve Christian civilization, protect and promote white supremacy and the segregation of the races, to fight communism and to extend the dignity, heritage and rights of the white race of America.

On 3/23/65, informant advised that he went to Franklin County and visited with CLYDE SEALE, during which visit he invited SEALE to a fish fry being held by the Klan in Lincoln County the night of 3/27/65. Informant advised that in conversation with CLYDE SEALE and other Klansmen, he has gained the impression that the feeling among Klansmen is "beginning to run high" due to the Civil Rights activity in Alabama and the fear there will be stepped up activity by Civil Rights agitators in Mississippi during the coming summer.

Informant advised that on 3/25/65, he met with GARLAND WHITE of Brookhaven, Mississippi, and that together they went to Crystal Springs for the purpose of inviting JULIUS HARPER to the fish fry in Lincoln County on 3/27/65.

Informant advised that he gained the impression in talking to HARPER that HARPER had changed and seemed "strange". Informant stated he is of the opinion HARPER is now working for Governor PAUL JOHNSON as an investigator. Informant stated HARPER is getting ready to run for a political office and it is possible he may run for Representative in the State Legislature from Crystal Springs.

Informant stated that in his conversations with GARLAND WHITE, he gained the impression that WHITE is not now interested in the Klan or Klan activity.

Informant advised that on 3/26/65, he went to Prentiss and Laurel, Mississippi, and while in Prentiss he visited with FELTER POLK, the former EC of the Prentiss Klavern. Informant stated that POLK advised him that things were not going well in the Prentiss Klavern as no control was being maintained over any of the members in the Prentiss Klavern.

Informant advised that on March 26, 1965, he went to Laurel, Miss., where he visited with **B**. F. HINTON and that HINTON advised him that SAM BOWERS had told him, HINTON, that Agent ROBERT E. LEE of the FBI has been to BOWERS twice and told him that the Klan was going to kill BOWERS. HINTON stated that he believes that the story about SAM BOWERS and the pictures of CASTRO, KHRUSHCHEV, HITLER and MUSSOLINI in the home of SAM BOWERS is a plot by the FBI to get BOWERS killed. HINTON stated that he believes the FBI started the story through informants in the White Knights of the Ku Klux Klan of Mississippi (WKKKKOM) and through informants in the United Klans of America (UKA). HINTON advised the informant that he would keep an eye on SAM BOWERS and indicated that he had other individuals assisting him in this project.

HINTON advised the informant that he now believes that SAM BOWERS is a "religious fanatic".

HINTON advised the informant that he has been to a meeting at Hattiesburg with SAM BOWERS and (FNU) AINSWORTH and a third individual whom the informant could not recall by name. HINTON stated that at the meeting a man held all of the Kluckers at gun point and demanded that ten dollars be returned to him since AINSWORTH had sworn in this man's son as a Klansman and collected ten dollars which had never been turned into the Klan by AINSWORTH. HINTON stated that AINSWORTH finally gave the man ten dollars to put up his gun and leave the meeting.

Informant stated that HINTON advised him that Agent ROBERT E. LEE had offered to go to Hattiesburg with HINTON and SAM BOWERS to "help them". Informant pointed out that this was the story as told by HINTON and he could not vouch for the veracity of this statement by HINTON.

Informant advised that on 3/27/65, there was a fish fry in Lincoln County, Mississippi. He stated the fish

fry was held on the farm of a Klansman whose name he could not recall. Informant described the location of the meeting as follows: The fish fry was held three miles from Caseyville. In going from Brookhaven to Fayette one turns right at Caseyville and goes approximately three miles to the second white house on the left which is a big house with large trees in the front house. To reach the meeting place, go just past this big house and turn left through a cattle gap. After crossing a pasture one enters the woods where the meeting was held.

Informant pointed out that a Province Meeting is scheduled for April 10, 1965, and is to be held at the same location as the fish fry which is described above.

Informant advised that at the fish fry on March 27, 1965, the following were present:

A. C. HERRINGTON CLYDE SEALE BILLY BUCKLES ERNEST GILBERT ARCHIE PRATHER (FNU) CRISWELL CHARLES FALVEY Approximately 50 to 75 other Klansmen.

Informant advised that CLYDE SEALE had a good representation at the fish fry from his Klavern in Franklin County.

Informant advised that at the fish fry CLYDE SEALE made a short talk in which he stated that his "boss, BILLY BUCKLES" had told him to get his group back together and to get the men working again.

BUCKLES made a talk in which he stated he had to go to Greenville to pay a Mr. THOMAS \$500 but it was not brought out why the \$500 was to be paid by BUCKLES to Mr. THOMAS. Informant advised that on the night of March 30, 1965, he went to Crystal Springs, Miss., where he visited with Mr. HURDEEN (PH), who is Secretary-Treasurer of the White Christians Protective Legal and Defense Fund (WCPLDF). Informant pointed out that HURDEEN has been the Secretary-Treasurer of the WCPLDF for the entire time and that previous reports referring to GREAVES as the Secretary-Treasurer were in error. Informant pointed out that HURDEEN is keeping all of the money collected for the WCPLDF and is the individual who is mailing out the letters to businessmen and individuals in an attempt to collect money.

Informant stated that HURDEEN advised him that the FBI was at the Westland Plaza in Jackson, Miss., on Sunday afternoon to cover the meet of Klansmen in connection with the WCPLDF but that the meeting had actually been held the Saturday before. HURDEEN then stated that there would be no more meetings of the Klan regarding the WCPLDF and that the jugs which had been put out for collection of money would be called in. HURDEEN stated that he and SAM BOWERS will decide what to do with the money which has been collected.

Informant advised that at this meeting with HURDEEN and JULIUS HARPER on 3/30/65, that after HURDEEN left that HARPER made the statement that BOWERS had been to Crystal Springs attempting to get Jackson to hold the next State Meeting at the Jackson Farm. Informant stated he gained the impression that a final decision was not reached and that he suggested that the next State Meeting be held in Lincoln County at the location of the fish fry which was held on March 27, 1965.

Informant advised that HARPER told him that EDDIE MC DANIEL, the Grand Dragon of the United Klans of American, Inc., Realm of Mississippi, had recruited three WKKKKOM in Meridian, Miss., recently. Informant stated the three

Klansmen who had been recruited by MC DANIEL were not identified by HARPER.

Informant stated that he did get a commitment from HARPER that HARPER would attempt to keep SAM BOWERS from going to the next State Meeting and that HARPER agreed that he would not go to the State Meeting himself. Informant stated that he impressed on HARPER that if HARPER and BOWERS would stay away from the next State Meeting, that he, the informant, would attempt to keep the Klan from causing any trouble by acts of violence. Informant stated that he felt he had convinced HARPER that the best way to handle the Negro situation in Mississippi was to allow the Negroes to create so many disturbances that public opinion would be against the Negroes and that the Klan should make a concerted effort to avoid any incidents which would materially assist the cause of the Negroes.

Informant advised that he had heard no discussion of any new group being formed in the State of Mississippi which has as its purpose the combating of the Negro Civil Rights activity in Mississippi.

Informant advised he had received no information regarding the molotov cocktails thrown at the residence of SILAS MC GHEE, Greenwood, Miss., 3/5/65.

Informant advised that CHARLES WRIGHT, formerly was employed by Homco and resided on the Gulf Coast. CHARLES WRIGHT subsequently moved to either Houston, Texas, or Lafayette, La. The (FNU) WRIGHT, who is allegedly the brother of CHARLES WRIGHT, was at a meeting of Klansmen north of Gulfport, Miss., near Sauciar, at which time ANTHONY DE SALVO was also present at this meeting. It was at this meeting that (FNU) WRIGHT made the statement to the informant that he was the brother of CHARLES WRIGHT, who is employed by Homco. Informant

advised that he had no information as to where (FNU) WRIGHT, who said he was the brother of CHARLES WRIGHT, resides or works. Informant pointed out that he knew for a fact that CHARLES WRIGHT was a Klansman who was possibly at one time the Exalted Cyclops of a klavern on the Gulf Coast but that he recalls definitely that CHARLES WRIGHT was a leader in one of the klaverns on the Gulf Coast before he moved to either Houston, Texas, or Lafayette, Louisiana. Informant stated he had no way of knowing if (FNU) WRIGHT was in reality a brother of CHARLES WRIGHT or if he was making this statement for the benefit of the other Klansmen who were present.

Informant advised that he is unable to place JAMES RUSSELL STUART, SR., and that the mailing address P.O. Box 2505, West Jackson Station, Jackson, Mississippi, had no significance to him. Informant pointed out that there are several STUART's in the Klan within the State of Mississippi but that he is unable to place a JAMES RUSSELL STUART, SR., or any STUART in the Jackson area.

• Informant advised that A. C. HERRINGTON, who resides in the Ruth Community of Lincoln County, Miss., gave him the name "DAVE CARRAWAY" as a Kleagle at Large, who should be contacted by the informant for information in the Amite County area. Informant advised that he had at no time ever contacted DAVE CARRAWAY and that he feels if investigation has failed to locate a DAVE CARRAWAY in the Amite County area, that there must be some confusion as to the name DAVE as given by HERRINGTON. The informant advised that he will attempt to check with HERRINGTON in an effort to identify the CARRAWAY referred to as a Kleagle at Large.

Informant advised that in connection with the Copiah County Rod and Gun Club, that GERALD WHITEHEAD was the contact man between Philadelphia, Miss., and State Headquarters. Informant advised that the mother of GERALD WHITEHEAD resides in the Philadelphia, Miss., area which

given him an excuse to visit Philadelphia. Informant pointed out that GERALD WHITEHEAD has previously been reported as being the Province Giant of Province 9 and that he asked to be removed. He was replaced by CLYDE SEALE, who was elected Province Giant of Province 9.

Informant advised that he could not say that the building formerly occupied by the Copiah County Rod and Gun Club is being used as a Klan Headquarters and that he actually feels that the building is not being used by the Klansmen but that they are probably meeting at the various homes of the Klansmen in Copiah County.

Informant advised that he has no personal knowledge of any Klansman residing or frequenting the Natchez, Miss., area who would be described as a large man driving a 1958 red and white Ford or a 1956 to 1958 model, dark colored, Buick.

Informant advised that as of 4/1/65, the following are officers of the Klan and reside in the towns indicated:

SAM BOWERS is the Imperial Wizard and resides Laurel, Mississippi;

JULIUS HARPER is the Grand Dragon and resides Crystal Springs, Miss.;

BILLY BUCKLES is the Grand Giant and resides near Oldenberg, Mississippi, on a rural route out of Roxie, Miss.;

ERNEST S. GILBERT is the State Investigator and resides at Brookhaven, Mississippi;

A. C. HERRINGTON is the State Kleagle at Large and covers all of Mississippi south of U. S. Highway 80;

GORDON LACKEY is the State Kleagle at Large and covers all of Mississippi north of U. S. Highway 80;

JOHN MC GREGOR was the Propaganda Chief and was fired for misappropriation of Klan funds. Informant advised that he has no information indicating that BOWERS has appointed another Propaganda Chief;

Informant advised he cannot recall the name of the new State Chaplain who was elected at the last election but he pointed out that he had previously furnished this information and that there has been no change in the chaplain.

Informant advised that the headquarters of the Klan is generally considered to be at the home of SAM BOWERS which is located at 816 South 4th Avenue, Laurel, Mississippi, and at the business of SAM BOWERS which is located at 820 South 4th Avenue, Laurel, Mississippi.

Informant advised that the Klan operates by a constitution which has had numerous amendments since the original constitution was written and that there is presently no printed constitution containing all of the amendments. Informant stated he does not believe anyone but BILLY BUCKLES would know all of the amendments as it is the responsibility of BILLY BUCKLES to record all of the amendments and have them added to the constitution.

Informant advised that there has been no changes made to the original Kloran as published by the Klan.

Informant advised that the WKKKKOM is not affiliated with any outside Klan group, either within the State of Mississippi or outside the State of Mississippi.

Informant advised that the Province Giants have changed but that to his knowledge, the last list provided by him after the last election is the most recent list of Province Giants and there have been no changes to this list to the informant's knowledge.

Informant stated that the last report he had on the Klan finances was that when all outstanding bills are paid, the Klan will again be broke.

Informant advised he had no information whatsoever regarding a Klan Meeting near Greenwood, Mississippi, the night of 3/26/65. He pointed out this was possibly a Province Meeting and he had not received an invitation to this meeting.

Informant advised that he had no information regarding CHARLES SALVEY moving around or traveling in the State of Mississippi and Alabama. Informant pointed out that he is in quite frequent contact with SALVEY and that he has had no reason to believe that SALVEY is moving around extensively. Informant also pointed out that SALVEY does not have an automobile, that he normally drives an old pickup truck and during the course of business drives a butane gas truck.

Informant advised that in connection with the ZOLLIE CASE shooting in Lincoln County, that he has received information from CHARLES SALVEY that this shooting was a family political feud. SALVEY stated that Mrs. CASE was actually shot by one of her sons. Informant pointed out that he has also received this same information from several other individuals in Lincoln County. Informant stated that he had heard the story that when someone, whose identity he did not know, told Mrs. CASE that it was her son who had shot her, she called the sheriff and the FBI and told them who had made this statement.

Informant stated that MELSON CASE is a County Supervisor in Lincoln County and that MELSON CASE is a relative of ZOLLIE CASE and that there seems to be a political feud between members of the CASE family.

WHITE KNIGHTS OF THE KU KLUX KLAN OF MISSISSIPPI FUND RAISING ACTIVITIES

A confidential source, who has provided reliable information in the past, advised that on March 24, 1965, a meeting of the White Christian Protective and Legal Defense Fund (WCPLDF) was held at Whitworth College, in Brookhaven, Mississippi. The following members were present:

> Mr. Elmore B. Greaves, President, Reverend Delmar Dennis, Reverend A. C. Everett, Mr. I. H. Shumaker Mr. H. H. Heredeen, Secretary-Treasurer

The meeting was called to order by Mr. Greaves and opened with a prayer by the Reverend Dennis.

On a motion by Reverend Dennis and seconded by Mr. Shumaker, the board voted to call in all collection jars, previously distributed throughout the state by the WCPLDF, due to the deplorable condition of some of the placards, and turn in the money contained in these jars as per existing instructions with one exception. This exception being that all monies and correspondence be directed to the Funa's Post Office Box 426, Jackson, Mississippi. The County Chairmen are to have the jars cleaned and held for new placards that will be issued in about a month's time. These new placards will be colored and eye-catching, and the wording changed considerably.

On a motion by the Reverend Dennis and seconded by Reverend Everett, the board voted to authorize the President and the Secretary to investigate cases called to 9 - Bureau 157-63-906

On a motion by Mr. Shumaker and seconded by Reverend Everett, the board authorized the Treasurer to mail a check in the amount of \$100.00 to Mrs. Charles R. Buckley, widow of a Jackson police officer who was shotgunned by a Jackson Negro. Mr. Greaves will also write a personal letter to Mrs. Buckley, copies to be placed in the hands of some of the Jackson police.

The Treasurer gave the board a financial report. As of the 24th of March the Fund had receipts of \$2,785.22 and disbursements of \$1,558.19. The reason the disbursements are so high is due to the fact that the Jackson Hinds Bank advised the Fund that they had never given anyone permission to use their box number and name on anything connected with this Fund. The Fund then stated that they had received from the printer 10,000 return envelopes and 10,000 drafts which had to be burned. The Fund mailed out over 15,000 donation letters but the response from these letters was not too good. It has been decided that the Fund would discontinue these letter for the time being.

The meeting then was adjourned with an inspiring prayer by the Reverend Everett.

ReBulet to JN, 3/9/65 and JNlet to Bureau, 1/21/65, captioned "SAMUEL HOLLOWAY BONERS" and "WHITE KNIGHTS OF THE KU KLUX KLAN OF MISSISSIPPI".

Considerable thought has been given to other techniques along the lines of those set out in reJNlet by which to expose SAMUEL HOLLOWAY BOWERS, Imperial Wizard, WKKKKOM. However, nothing of preponderance has been conceived. It is noted that at present BOWERS is being interviewed by Agents with a view toward making him an informant. In the light of his development, this technique is being held in abeyance pending further developments in this regard.

It is noted that the HCUA is very much interested in calling BOWERS to testify at the proposed hearings and every opportunity vill be made to exploit this situation to expose BOWERS publicly as the Imperial Vizard of the WKKKKOM.

Indices of the New Orleans Office negative on "Two Jumps" and "Two Shoes."

A review of file entitled "JOHN GIBSON DILLON, aka - Fugitive, BAIL JUMPER" New Orleans file 26-26550, contains no additional information to that furnished by the Oklahoma City Office concerning "Two Jumps" and "Two Shoes."

The file reflects that on 11/21/63 a beige Cadillac bearing 1963 Oklahoma license ZV3587, registered to G. W. EDWARDS, father of <u>TOMMY MARTIN EDWARDS</u>, was observed at the residence of JOE <u>BUCHANAN</u> at Jackson, Mississippi, and observation on 11/23/65 revealed this automobile was no longer there. Previous to this time, TOMMY MARTIN EDWARDS had possession of the registration for the abovedescribed Cadillac.

Based on information that there would be a meeting of the Dillon gang with the Marshall-DeFord gang of Las Vegas, in the area of Biloxi, Mississipi, spot checks of motels and residence of Dillon associate <u>DEAN DE FOREST LIAKIS</u> were made for automobiles in possession of EDWARDS, <u>RUBY CHARLES</u> <u>JENKINS and DONALD EUGENE SPARKS</u>, and nothing was developed concerning the presence of these automobiles in the Biloxi area. Confidential Informants and sources were unable to identify these individuals as being in the Biloxi area.

Investigation regarding LIAKIS developed that he was reportedly employed as a truck drivery by D. J. VENUS but actually was a strong-arm man and body guard with JIM BLACKWELL for VENUS, according to rumors, inasmuch as VENUS was anticipating another shoot-out with RICHARD HEAD.

The file reflects that the proposed meeting between the <u>Marshall-DeFord</u> gang and the <u>Dillon/gang</u> at Biloxi did not materialize, and the Las Vegas Office advised on 12/2/63 that DE FORD, ET AL were back in Las Vegas, and instructed that leads in this instance be discontinued.

It is noted that information furnished by Dillon associate LEROY BASIL MC MANAMAN to the Kansas City Office, (KC airtel to OC 10/29/63) pertains to associates of DILLON and lists DEAN LIKUS, Gulf Coast, CHARLES HORN of Jackson, Mississippi (CHARLES HENRY HORNE, Jackson PD #8945); JIM BLACKWELL, associate of DILLON and FUQUA from Tulsa (probably JIM BLACKWELL of Laurel, Mississippi and Mississippi Gulf Coast, known associate of <u>GEORGE FUQUA</u>).

Information concerning JIM BLACKWELL was provided to the Jackson Office by New Orleans airtel dated 2/16/65 entitled Klan Activity in Rankin County, Mississippi, RM (NO file 157-1999, Jackson file 157-45).

He constantly referred to DILLON as "JACK" while insofar as is known to las Vegas, people who really know and associated with DILLON referred to him as "JOHN". During one contact with CIARK he was shown photos of members of the DILLON Gang, including photos of DONALD HUGENE SPARKS and RUBY CHARLES JENKINS. He recognized neither of these people, although SA MC VAY knows from personal experience that the photo of JENKINS was an excellent current likeness.

The Agents gained the impression that CIARK had received his knowledge of the members of the DILLON Gang from other members of the MARSHALL-DE FORD Gang, possibly the late JAMES LYMAN DE FORD, CHARLES "CHUCK" CORNET, REX STIDHAM WINDOM, Jr. MARION CARTER "CURLY" BOMMAN or possibly ROBERT EDMARD REYNOLDS, aka, Bobby Jack Reynolds. It is also known that members of the MARSHALL-DE FORD Gang had great respect for JACK RAINEY, well known to Phoenix, and were in frequent contact with RAINEY. All members of the gang located in Las Vegas were questioned at one time or another concerning DILLON.

DE FORD claimed to have known DILLON but never furnished any specific information about him. Extent of DE FORD'S connection, if any, with the DILLON Gang is unknown. DE FORD at one time was closely associated with EDDIE LEON CROUCH and BILL PAT KELLEY, burglars. CROUCH professed to have known DILLON and claimed to aspire to emulate DILLON'S stature in the underworld. KELLEY was reported to have been an associate of DILLON and it was claimed that DILLON once planned to free KELLEY from a county jail in Illinois.

CHUCK CORNET was born in Lawton, Oklahoma, but apparently grew up in West Virginia. He is known to have had some connection with DILLON'S bondsman, PETE KING, Tulsa, Oklahoma, but again the extent of this connection is unknown to Las Vegas. It might be of interest to note that in December, 1963, CORNET was in possession of a Phillips Petroleum Company credit card of FRANK VAN LERHERG, which had been stolen in the heist of a poker game attended by several prominent people near Hansa's City in November, 1963, such robberies apparently being a trademark of the members of the DILLON Gang. CORNET has denied any knowledge of or connection with members of the DILLON Gang but it should be noted he is notoriously uncommunicative about his illegal activities.

WINDOM has nover furnished Ias Vegas Agents any information.

It would appear at this time that any direct contact with RICHARD GERALD CLARK would reveal to him that CLEVELAND was cooperating with the Las Vegas Office during his series of contacts with CLARK in November and December, 1963.

ine scenda consisted of a "pep talk" by Sam Bowers, Imperial Wizard of the WKKKKOM, and Julius Harper, Grand Dragon of the WKKKKOM. The "pep talk" re-affirmed the aims and problems of the Klan and the importance of its reason to preserve the white race.

Billy Buckles and J.K. Greer, Klansmen and both plane pilots, proposed dropping leaflets containing Klan propagands on the civil rights marchers in Selma, Alabama; however, after much discussion, no plans were formulated. However, (first name unknown) Dunn did mention that some "fellows" were on their way to Selma with Klan literature which they will distribute along the marchers' route.

Confidential source also advised that during this meeting, Billy Buckles advised he has a secret source in the Delta area of Mississippi (a geographic area of the state) from which he can borrow money for Klan matters without paying interest. The confidential source was unable to learn of the identity of this secret source.

Those present decided to defect from the OKKKK and to form their own Klan group in Mississippi to be known as the White Knights of the Ku Klux Klan of Mississippi.

This source advised that the aims and purposes of the White Knights of the Ku Klux Klan of Mississippi are to preserve Christian civilization, protect and promote white supremacy and the segregation of the races, to fight communism and to extend the dignity, heritage and rights of the white race of America.

A second source advised on February 4, 1965, that the present membership of the White Knights of the Ku Klux Klan of Mississippi (WKKKKOM) is between 1,000 and 1,500 members and the organization has continued to operate in the State of Mississippi as an independent Klan organization with the same aims and purposes as when it was created in February, 1964.
